Amendment to the Icelandic authorisation of the Union authorised biocidal product family, Contec IPA Product Family

Regulation (EU) No 528/2012 concerning the making available on the market and use of biocidal products and Commission Implementing Regulation (EU) No 354/2013 (on changes), are implemented into Icelandic legislation through the Icelandic Regulation No 878/2014 on biocidal products.

Contec IPA Product Family is authorised in Iceland with an implementing decision in EEA countries and Switzerland (EE-APP), with reference to the Union Authorisation – EU-0020460-0000.

The Environment Agency of Iceland (Umhverfisstofnun) received your application for amendment of the implemented decision on 29 November 2022, Case No. BC-YC071762-33. The amendment concerns removal and addition of trade names for the Icelandic market as referred to in Section 1 of Title 1 of the Annex to Commission Implementing Regulation (EU) No 354/2013 (on changes).

The application for administrative change of the Icelandic authorisation of the Union authorised biocidal product family is accepted in exercise of the powers conferred by Articles 50(2) of Regulation (EU) No 528/2012 (BPR).

The amendment concerns

 - o **Removal of the trade names;** Contec 70% IPA FBC570I, Contec Sterile 70% IPA SBT170IW, Contec Sterile 70% IPA SBT0570IW and Contec 70% IPA FBT170I.
 - o **Addition of the trade names;** Contec IPA and Contec Sterile IPA.

- **Addition of the trade names;** PROSAT EasyReach, PROSAT Sterile EasyReach, PROSAT Wipes, PROSAT Sterile Wipes, SATWipes Wipes, SATWipes Sterile Wipes and Cleanroom wipes, presaturated Spec-Wipe.

Accordingly, the Environment Agency of Iceland has made the relevant changes to the Summary of Product Characteristics (SPC) under asset number IS-0021979-0000. The relevant criteria for the biocidal product authorisation apply as described therein.
