1. In vivo mammalian alkaline comet assay also requested below (triggered by Annex VII, Section 8.4., column 2)

Information required from all the Registrants subject to Annex VIII of REACH

2. In vivo mammalian alkaline comet assay (triggered by Annex VIII, Section 8.4., column 2; test method: OECD TG 489) in rats, or if justified, other rodent species, oral route, on the following tissues: liver, glandular stomach and duodenum.

The reasons for the decision(s) are explained in Appendix 1.

Information required depends on your tonnage band

You must provide the information listed above for all REACH Annexes applicable to you in accordance with Articles 10(a) and 12(1) of REACH. The addressees of the decision and their corresponding information requirements based on registered tonnage band are listed in Appendix 3.

In the requests above, the same study has been requested under different Annexes. This is because some information requirements may be triggered at lower tonnage band(s). In such cases, only the reasons why the information requirement is triggered are provided for the lower tonnage band(s). For the highest tonnage band, the reasons why the standard information requirement is not met and the specification of the study design are provided. Only one study is to be conducted; all registrants concerned must make every effort to reach an agreement as to who is to carry out the study on behalf of the others under Article 53 of REACH.

You are only required to share the costs of information that you must submit to fulfil your

information requirements.

How to comply with your information requirements

To comply with your information requirements, you must submit the information requested by this decision in an updated registration dossier by the deadline indicated above. You must also **update the chemical safety report**, where relevant, including any changes to classification and labelling, based on the newly generated information.

You must follow the general requirements for testing and reporting new tests under REACH, see Appendix 4.

Appeal

This decision, when adopted under Article 51 of REACH, may be appealed to the Board of Appeal of ECHA within three months of its notification to you. Please refer to <http://echa.europa.eu/regulations/appeals> for further information.

Failure to comply

If you do not comply with the information required by this decision by the deadline indicated above, ECHA will notify the enforcement authorities of your Member State.

Reasons for the decision(s) related to the information under Annex VII of REACH

1. In vivo mammalian alkaline comet assay

- 1 Further mutagenicity studies must be considered under Annex VII to REACH in case of a positive result (Section 8.4., Column 2).
- 2 Your dossier contains positive results for the in vitro gene mutation study in bacteria (OECD TG 471, 2007) which raise the concern for gene mutations.
- 3 ECHA considers that an in vivo follow-up study is necessary to address the identified concern.
- 4 For the assessment of the testing proposal, see Section 2.

Reasons for the decision(s) related to the information under Annex VIII of REACH

2. In vivo mammalian alkaline comet assay

5 Appropriate in vivo mutagenicity studies must be considered under Annex VIII to REACH (Section 8.4., Column 2) in case of a positive result in any of the in vitro genotoxicity studies under Annex VII or VIII to REACH.

6 Your dossier contains positive results for the in vitro gene mutation study in bacteria (OECD TG 471, 2007) which raise the concern for gene mutations.

7 Moreover, your dossier contains an in vivo micronucleus test (OECD TG 474, 2007); however, this study does not investigate gene mutations.

2.1. Information provided to fulfil the information requirement

8 You have submitted a testing proposal for an In vivo mammalian alkaline comet assay to be performed with the Substance.

9 ECHA requested your considerations for alternative methods to fulfil the information requirement for Genetic toxicity in vivo. You provided your considerations concluding that there were no alternative methods which could be used to adapt the information requirement(s) for which testing is proposed. ECHA has taken these considerations into account.

10 ECHA agrees that an appropriate in vivo follow up genotoxicity study is necessary to address the concern identified in vitro.

2.2. Test selection

11 According to the Guidance on IRs & CSA, Section R.7.7.6.3., the in vivo mammalian alkaline comet assay ("comet assay", OECD TG 489) is suitable to follow-up a positive in vitro result on gene mutations.

2.3. Specification of the study design

12 You proposed testing in the rat. According to the test method OECD TG 489, rats are the preferred species. Other rodent species can be used if scientifically justified (OECD TG 489, para. 23).

13 Additionally, you proposed to perform the test in males only, "*as no significant toxicological differences were observed between males and females.*" Based on the data in your dossier, such as the repeated dose toxicity (28-day) study and the reproduction / developmental toxicity screening test, no relevant differences between males and females were noted; therefore, the comet assay study could be performed in either sex (see OECD TG 489, para. 31).

14 You proposed testing by the oral route. Having considered the anticipated routes of human exposure and adequate exposure of the target tissue(s) performance of the test by the oral route is appropriate.

15 You proposed to analyse blood and liver cells. However, ECHA notes that in line with the test method OECD TG 489, the test must be performed by analysing tissues from liver as primary site of xenobiotic metabolism, glandular stomach and duodenum as sites of contact.

There are several expected or possible variables between the glandular stomach and the duodenum (different tissue structure and function, different pH conditions, variable physico-chemical properties and fate of the Substance, and probable different local absorption rates of the Substance and its possible breakdown product(s)). In light of these expected or possible variables, it is necessary to analyse both tissues to ensure a sufficient evaluation of the potential for genotoxicity at the site of contact in the gastro-intestinal tract. It is at your discretion to perform additional analysis in the blood.

2.3.1. Germ cells

- 16 You may consider collecting the male gonadal cells from the seminiferous tubules in addition to the other tissues in the comet assay, as it would optimise the use of animals. You can prepare the slides for male gonadal cells and store them for up to 2 months, at room temperature, in dry conditions and protected from light. Following the generation and analysis of data on somatic cells in the comet assay, you should consider analysing the slides prepared with gonadal cells. This type of evidence may be relevant for the overall assessment of possible germ cell mutagenicity including classification and labelling according to the CLP Regulation.

2.4. Outcome

- 17 Under Article 40(3)(b) your testing proposal is accepted under modified conditions, and you are requested to conduct the test with the Substance, as specified above.

Appendix 2: Procedure

ECHA started the testing proposal evaluation in accordance with Article 40(1) on 10 March 2022.

ECHA held a third party consultation for the testing proposal(s) from 10 May 2022 until 27 June 2022. ECHA did not receive information from third parties.

ECHA followed the procedure detailed in Articles 50 and 51 of REACH.

The deadline of the decision is set based on standard practice for carrying out OECD TG tests. It has been exceptionally extended by 12 months from the standard deadline granted by ECHA to take into account currently longer lead times in contract research organisations.

ECHA notified you of the draft decision and invited you to provide comments.

ECHA did not receive any comments within the commenting period.

ECHA notified the draft decision to the competent authorities of the Member States for proposals for amendment.

As no amendments were proposed, ECHA adopted the decision under Article 51(3) of REACH.

Appendix 4: Conducting and reporting new tests for REACH purposes

1. Requirements when conducting and reporting new tests for REACH purposes

1.1. Test methods, GLP requirements and reporting

- (1) Under Article 13(3) of REACH, all new data generated as a result of this decision must be conducted according to the test methods laid down in a European Commission Regulation or to international test methods recognised by the Commission or ECHA as being appropriate.
- (2) Under Article 13(4) of REACH, ecotoxicological and toxicological tests and analyses must be carried out according to the GLP principles (Directive 2004/10/EC) or other international standards recognised by the Commission or ECHA.
- (3) Under Article 10(a)(vi) and (vii) of REACH, all new data generated as a result of this decision must be reported as study summaries, or as robust study summaries, if required under Annex I of REACH. See ECHA Practical Guide on How to report robust study summaries².
- (4) Under the introductory part of Annexes VII/VIII/IX/X to REACH, where a test method offers flexibility in the study design, for example in relation to the choice of dose levels or concentrations, the chosen study design must ensure that the data generated are adequate for hazard identification and risk assessment.

1.2. Test material

Before generating new data, you must agree within the joint submission on the chemical composition of the material to be tested (Test Material) which must be relevant for all the registrants of the Substance.

- (1) Selection of the Test material(s)
The Test Material used to generate the new data must be selected taking into account the following:
 - the variation in compositions reported by all members of the joint submission,
 - the boundary composition(s) of the Substance,
 - the impact of each constituent/ impurity on the test results for the endpoint to be assessed. For example, if a constituent/ impurity of the Substance is known to have an impact on (eco)toxicity, the selected Test Material must contain that constituent/ impurity.
- (2) Information on the Test Material needed in the updated dossier
 - You must report the composition of the Test Material selected for each study, under the "Test material information" section, for each respective endpoint study record in IUCLID.
 - The reported composition must include the careful identification and description of the characteristics of the Tests Materials in accordance with OECD GLP (ENV/MC/CHEM(98)16) and EU Test Methods Regulation (EU) 440/2008 (Note, Annex), namely all the constituents must be identified as far as possible as well as their concentration. Also any constituents that have harmonised classification and labelling according to the CLP Regulation must be identified and quantified using the appropriate analytical methods.

This information is needed to assess whether the Test Material is relevant for the Substance and whether it is suitable for use by all members of the joint submission.
