## 1. Introduction

## 1.1. Objective

The purpose of this manual is to assist in the preparation of REACH registration and PPORD (product and process-oriented research and development) dossiers using IUCLID. The manual provides you with detailed and practical instructions on how to generate a substance dataset and outlines the IUCLID sections to be filled in, in order to prepare a valid dossier that can be submitted to ECHA through REACH-IT.

This manual assumes that IUCLID has been installed, that you are using the web user interface and that you have a valid ECHA account. Please note that the classic user interface (IUCLID client) is being phased-out.

More information about each field, the different functionalities in IUCLID and how to use those functionalities can be found in the help system of IUCLID (see chapter <u>Functionalities of IUCLID</u>).

The manual also assumes that you have decided on your registration approach and have all relevant information available. Please consult the Guidance documents for support on the information requirements for registration: <a href="https://echa.europa.eu/support/guidance">https://echa.europa.eu/support/guidance</a>.

For instructions on how to prepare REACH registration dossiers covering nanoforms, see the corresponding manual at <u>Manuals - ECHA (europa.eu)</u>.

## 1.2. Overview of the preparation and the submission of a dossier

A IUCLID dossier is non-editable snapshot file of a substance dataset, containing the information to be submitted to ECHA. To generate a dossier and submit it you have to proceed through the following steps:

- **Step 1.** Sign-up in REACH-IT and create the Legal entity (<a href="https://reach-it.echa.europa.eu">https://reach-it.echa.europa.eu</a>).
- **Step 2.** Create the reference substances in IUCLID related to your substance (see chapter *Reference substance*).
- **Step 3.** Create the substance dataset in IUCLID (see chapter <u>How to create a substance</u> dataset).
- **Step 4.** Enter information in the substance dataset in IUCLID (see the relevant sections of chapter <u>How to create a substance dataset</u>).
- **Step 5.** Include the chemical safety report (CSR) for all substances manufactured or imported above 10 tonnes unless exempted by REACH article 14(2)1.

A *Report generator* is available in IUCLID to support you generating your CSR. It compiles the information from your IUCLID dataset and generates a formatted document covering the CSR chapters 1 to 8. You may also use Chesar to perform your CSA. In this case, the full CSR can be generated from Chesar. To generate a report click on the three dots button at the top of

the substance dataset page and then select Generate report (See chapter The Dataset page). information Chesar available the Chesar More on is on website: https://chesar.echa.europa.eu/.

- **Step 6.** Create a dossier in IUCLID (see chapter How to create a Dossier).
- **Step 7.** Export a dossier from IUCLID (see chapter <u>How to export a Dossier</u>).
- **Step 8.** Submit a dossier to ECHA via REACH-IT (see chapter *Submit a Dossier*).

Upon receipt of your dossier, ECHA will undertake a set of administrative and technical checks of your submission (see chapter <u>Checks performed by ECHA on the submitted dossiers</u>).

ECHA will also disseminate on its website information from the registration dossier. For more information on what is disseminated and possibilities to claim some information confidential, see chapter Confidentiality requests and publication of information.

## 1.3. IUCLID dossier templates

Before creating a dossier from a substance dataset you have to select the appropriate template for the type of dossier that you need to submit from the types indicated below<sup>2</sup>:

```
REACH Registration 1 - 10 tonnes, physicochemical requirements;
REACH Registration 1 - 10 tonnes, standard requirements;
REACH Registration 10 - 100 tonnes;
```

REACH Registration 100 – 1000 tonnes;

REACH Registration above 1000 tonnes;

REACH Registration member of a joint submission – general case;

REACH Registration member of a joint submission - intermediates;

REACH Registration on-site isolated intermediates above 1 tonne;

REACH Registration transported isolated intermediates 1 – 1000 tonnes;

REACH Registration transported isolated intermediates above 1000 tonnes;

REACH PPORD.

The information requirements for a registration dossier depend on the registered tonnage band and the type of registration dossier prepared (Article 10 vs 17/18; joint submission member vs lead). This means that the information in the IUCLID dossier that will be checked for completeness varies depending on the type of submission. This manual gives a sectionby-section overview of the information required for registration and PPORD dossiers. In addition, a summary of the completeness check rules applied can be found in the Annex 2, Overview of the completeness check performed by ECHA on the submitted dossiers.

#### Registration or PPORD notification dossier?

The most common type of dossier is the registration dossier. However, where your substance is subject to product and process-oriented research and development (PPORD) in quantities of one tonne or more per year, you can submit a PPORD dossier in order to be exempted from the obligation to register for a period of five years.

#### Individual registration or joint submission?

The REACH Regulation requires parties manufacturing/importing a substance to submit one registration for this substance (the so-called "One substance - one registration", or OSOR principle). Registrants of a substance are put in contact with other (potential) registrants after they submit to ECHA an inquiry. The registrants of the same substance have the collective responsibility to identify the substance, generate/collect relevant information according to the Annexes VI-X of REACH, and ultimately submit it in IUCLID format in fulfilment of the obligations.

This manual assumes that joint submission obligations have been determined by the submitting party and that all relevant information has been generated/collected and is available.

#### On-site isolated intermediate or transported isolated intermediate?

If you are a manufacturer or importer of an isolated intermediate in quantities of one tonne or more per year, you may benefit from reduced registration requirements. Note that the requirements for registration vary depending on whether the isolated intermediate is an on-site or a transported intermediate.

#### Notification made under Directive 67/548/EEC (NONS)?

According to Article 24 of the REACH Regulation all notifications made under Directive 67/548/EEC (NONS) are considered registrations under the REACH Regulation at the relevant tonnage band. These registrations need to be updated if at least one of the cases described in Article 22 or Article 24(2) of the REACH Regulation applies.

You can find detailed information on how to update your registration that was previously a notification under Directive 67/548/EEC (NONS) in the Annex 4 <u>Minimum information required</u> <u>for updating a registration under previous Directive 67/548/EEC</u> of this manual as well as the document <u>Questions and answers for the registrants of previously notified substances</u> available at:

## 1.4. Information requested for registration and PPORD notification

Registrants of the same substance have to share data and submit information jointly to ECHA. A distinction is made between information to be submitted by the **lead registrant** and that to be submitted by the other **members of the joint submission**.

Each registrant (manufacturer, importer or only representative) has the obligation to submit his own **dossier** as a part of the joint registration. If you are preparing a dossier as the only registrant for that substance, and no joint submission exists, you need to provide all the information in your own dossier.

The table below shows the information that is submitted by the lead registrant on behalf of all members of the joint submission (joint information<sup>3</sup>) and the information that is submitted by each registrant in his own dossier (individual information).

## 1.5. Checks performed by ECHA on the submitted dossiers

All dossiers submitted to ECHA undergo initial technical and administrative checks in order to ensure that they can be handled properly and that the subsequent required regulatory processes can be successfully carried out. Such checks are called business rules (BR).

A dossier can be accepted for processing only if all of the relevant business rules, such as format verification and availability of administrative information are satisfied.

For more information on the business rules check refer to the Annex 1: <u>Overview of the business rules checks performed by ECHA on the submitted dossiers</u>.

After successfully passing the business rules step, registration and PPORD dossiers undergo the completeness check required by Article 20 of the REACH Regulation to ensure that the required information is provided.

For more information on the completeness check refer to the Annex 2: <u>Overview of the completeness check performed by ECHA on the submitted dossiers</u>.

In addition, as part of the completeness check, certain data in the dossier will be checked manually to ensure that the required elements are present.

#### 1.5.1. The Validation assistant

The *Validation assistant* (VA) has been developed to enable you to perform some checks on the dossier before you submit it to ECHA via REACH-IT.

Therefore, before the submission, we strongly advise you to use the *Validation assistant* in two steps:

- i. To check your substance dataset (before the IUCLID dossier is created) to be able to correct any failures reported at this level.
- ii. To check the final IUCLID dossier and address any issues identified in this step.

Using the *Validation assistant* in both steps is vital for you to minimise any unnecessary failures and potential rejection of your submission.

For instructions on how to run the Validation assistant, refer to the help system of IUCLID.

Please note that as of 21 June 2016 the technical completeness check includes additional verifications of the registration dossier by ECHA staff. These checks cannot be replicated using the Validation Assistant; the related completeness issues cannot be displayed by the tool. #### 1.6. The main features of the IUCLID web user interface


In this chapter an overview of the IUCLID web user interface's main new features is presented.

Please note that the features introduced here below are not an exhaustive representation of the IUCLID web user interface. Only the most used features of the web interface for preparing dossiers for submissions to ECHA are covered. For an overview of all the features included in the IUCLID web user interface please refer to the help system of IUCLID that can be accessed from anywhere in the application by clicking the round question mark icon displayed in the top-left corner of the screen (see chapter *The functionalities of IUCLID*).

#### 1.6.1. The Dashboard

The Dashboard is the page shown upon starting IUCLID with the web interface.

Figure 1: The Dashboard and its icons




The squared question mark icon allows you to easily access to a list of supporting material for IUCLID such as manuals, Q&As and video tutorials.

The round question mark icon next to the search bar opens the help system of IUCLID, a user manual presenting in detail the functionalities of IUCLID in the web interface.

The three dashes icon is the link to the Main menu, which contains direct links to list of entities and to functionalities that do not necessarily need the context provided by the data window.

Figure 2: View of the main menu



The widgets for Substance, Mixtures and Articles lead to lists of existing substances, mixtures and articles and the option to create new ones. The windows for Substances, Mixture and Articles that open by clicking on the widgets can each display either datasets or dossiers based on these entities.

#### 1.6.2. The Substances list page

Datasets Dossiers This button displayed in the Substances, Mixtures and Articles list pages allows switching between the display of datasets and dossiers.

Export CSV This button allows you to export the full list of results in the substances list page as a CSV file.

In the *Substances* and *Mixtures* and *Articles* list pages, the orange icon with a bottle indicates datasets. The datasets represent the editable data related to a particular substance, mixture or article from which a dossier can be created.

The purple icon with a lock instead indicates dossiers. Dossiers represent the data related to a particular substance, mixture or article at a snapshot in time. Dossiers cannot be edited and are the format in which the data is submitted to ECHA.


The button labelled with three dots allows sharing, deleting and cloning an entity (substance, mixture or article) from the list. Please note that another button labelled with three dots is also displayed in the top of each *Dataset page*. For the functionalities included in the three dotted button of the *Dataset page* please see the following subchapter.

by selecting the checkbox next to the datasets you will be able to export or delete the selected dataset. More than one dataset can be selected in one instance.

From the *Substances*, *Mixtures* and *Articles* list you can access both datasets and dossiers. To open a dataset click on the selected substance among those displayed in the list. The page that opens up is the Substance dataset page (see Figure below).

Figure 4: The Dataset page of a Substance dataset with the working context (submission type) "REACH Registration above 1000 tonnes"




Depending on the *working context* (submission type) selected, IUCLID automatically displays the table of contents containing all sections that are relevant. The table of content is displayed as a navigation panel on the left hand side of the screen (1).

The content of the dataset can be modified by filling the data of the fields of the various sections (2). The tabs at the top of the dataset page help to navigate through the dataset page taking you to directly to the section indicated on the tab (3).

The fields to be filled in are either free-text fields or picklist fields.

Some picklist fields - when the option 'other' is selected - the possibility to add a remark (See figure below).

Figure 5: Add a remark to a Justification for deviation field




In certain free-text fields it is possible to insert a template containing suggestions on the information required for the field. To open the free-text template, click on the icon that shows the letter A with an arrow at the bottom right, displayed above the selected field A Insert existing templates


Repeatable blocks such Other IT system identifiers in figure 6 can be filled in:

- 1. By clicking the + New item button, clicking on the generated row and manually fields in the pop up window.
- 2. By downloading the CSV template for that specific repeatable block, filling in the excel file with your data and importing the excel file in the repeatable block. This option is recommended for those cases in which many rows need to be created.

The Validation assistant on a dataset is run by clicking on the button labelled *Validate* (4), which is shown at the upper right of the substance dataset page. The validation assistant can be run also on a dossier by clicking the Validate button on the dossier page.



With the button labelled with three dots (6) at the right top of the Dataset page the

following functions can be accessed: Export to i6z, Create document PDF/RTF, Create component PDF/RTF, Generate report, Compare, Clone and Copy data from and Bulk Deleting.

#### 1.6.4. The Dossier header

The page opening when clicking the *Create dossier* button is the *Dossier header*.

From the *Dossier header* page you can either use default settings and create your dossier by clicking on *Create dossier* at the foot of the page or access the *Advanced settings* for dossier creation by clicking on the related button displayed next to *Create dossier*. The *Advanced settings* allow for example to include or exclude the *Legal entity* that is attached to the *Substance, Mixture* or *Articles,* or to select the documents to be included in the dossier outside of the default based on the submission type.

## 1.6.5. Confidentiality flags

A flag icon to the left of the name of a field or section indicates whether a flag can be set, whether it has been set, and whether it involves confidentiality or is a regulatory programme flag for filtering information. The icons are described here below.



No flag is set;



A regulatory programme flag is set which does not involve confidentiality;



A flag is set that involves confidentiality.

## 1.7. Confidentiality requests and publication of information

Certain IUCLID data can be flagged as confidential. If you wish to flag a document field, a section of a document, or an entire document as confidential, you must use the IUCLID *confidentiality request* flag for each request. Such requests are flagged by setting the confidentiality flags ( $^{\sim}$ ) on the field, section, or document that you wish to request as confidential and providing a justification for the request, explaining in detail why the publication of such information would be harmful to your business. You are strongly advised to use the justification template which appears after clicking the icon  $^{\leftarrow}$  Insert existing templates.

Any confidentiality requests on information falling under **REACH Article 119(1)** are disregarded, as such information is always published.

If a flag refers to information covered by **REACH Article 119(2)** a fee is incurred. Such requests must be accompanied by a full justification. If a flag refers to information not covered by REACH Article 119(2), no fee is incurred.

To calculate the costs of confidentiality requests, you can use the Fee calculator. The *Fee calculator* is run from the application bar located at the top of the record for a Dossier. Click on the button labelled with three dots, and then select *Calculate Fee*. For more information on the Fee calculator, refer to the help\_system of IUCLID.

#### 1.7.1. The Dissemination preview

The *Dissemination preview* has been developed to offer you a possibility to check which information from your dossier will be made publicly available on the ECHA website. It is strongly recommended to use the *Dissemination preview* before submitting your dossier to simulate which information will be published.


The *Dissemination preview* is run from the application bar located at the top of the record for a Dossier. Click on the button labelled with three dots, and then select *Dissemination preview*. For more instructions on the *Dissemination preview* refer to the help system of IUCLID.

#### 1.8. The functionalities of IUCLID

The functionalities of IUCLID are described in detail in the help document *Functionalities of IUCLID in the web interface*. To access the *Functionalities of IUCLID* document, click the icon displayed on the top right corner of any page inside the interface and you will be able to open the IUCLID user manual. From there it is possible to navigate to the specific help required.

For specific support on how fields should be filled in within IUCLID, click on the question mark icons next to the field headers. Please note that the question mark icon will appear only after hovering with the cursor over the selected field, as shown here below.

## 2. Legal entity

Submissions to ECHA are done by *Legal entities* which have to be defined including contact details prior to submission. The contact details of the company are stored as a *Legal Entity Object (LEO)*. You can create a LEO both in IUCLID and in the *ECHA accounts* available at <a href="http://idp.echa.europa.eu/ui/">http://idp.echa.europa.eu/ui/</a>

Note that ECHA will use only the contact details of the legal entity that you have registered in the ECHA accounts or in REACH-IT.

You have already created one legal entity when you installed IUCLID. You can add more legal entities either:

- 1. By clicking on Legal entities from the main Menu.
- 2. From the point where the *Legal entity* is referred to in a dataset.

However, ECHA will not enforce the consistency between the IUCLID legal entity and the ECHA accounts legal entity.

Please note that by the default settings the legal entity is not included in the dossier. If you wish to include the legal entity in your dossier, you can change the default settings during the dossier creation (see chapter <u>How to create a Dossier</u>).

If you include a legal entity in the dossier which will be submitted to ECHA it may be beneficial to check if the legal entities in IUCLID and REACH-IT are the same. For further information on how to create a Legal Entity Object (LEO) and how to synchronise it between IUCLID and REACH-IT, refer to the next chapter.

## 2.1. How to update and synchronise the LEO information

To register your legal entity, you should sign-up into the *ECHA accounts* where you can enter and administer your legal entity information.

When you create a LEO, a numeric identifier called Universal Unique Identifier (UUID) is generated. Example of a legal entity UUID: *IUC5-a620a92d-32c6-426a-b6ee-fc338cde0932*.

The UUID is different for each LEO, even within the same company in case the company has several LEOs.

You can synchronise the legal entity between IUCLID and REACH-IT by exporting your LEO from ECHA accounts or REACH-IT. You can then import the file into IUCLID. It may be beneficial that the UUID is identical between all the applications where the company identity appears (IUCLID, REACH-IT, any web forms submitted to ECHA). Alternatively, if you have not yet created your ECHA account, you may export the LEO from IUCLID and import the file to ECHA accounts when you create an account. Note that a LEO can be imported to ECHA accounts only while you create an account, and not to an existing ECHA account.

To compare the UUIDs between the applications, you can find them inside each application by following the below paths:

- IUCLID: Main Dashboard menu > Legal entity > find your legal entity.
- ECHA Accounts: Legal Entity tab > General information > Legal Entity UUID

REACH-IT: Menu > Company information > General information > UUID

## 3. Legal entity sites (Sites)


A Legal entity site (Site) is an entity where you can indicate the site where manufacture or own use of your substance takes place. This information includes the name of the site, the address and other contact details of the site, and the possibility to include the identifiers of the site under *Other IT system identifiers*. The *Legal entity site* belongs to only one *Legal entity owner*.

Note that it is not possible to create a Legal entity site without linking it to a legal entity, but it is possible to modify the link between a *Site* and its legal entity owner by selecting another legal entity from your inventory. More than one Site can be associated with the same legal entity.

The creation and editing of a site is done either:

- 1. from the list page of Sites which can be accessed from the main menu;
- 2. from the point where the *Site* is referred to in a dataset. To create a new site from the point where the *Site* is referred to in a dataset click on *Select* in the *Site* field as shown below. The link will take you to the *Site* inventory.

Figure 8: Link to Sites inventory from within the dataset




## 3.1. Creating a Legal entity site

To create a new site:

- **Step 1.** In the pop-up window click on *New site / Create*.
- **Step 2.** Complete as many fields as possible under General information and Contact address. The minimum data required is the Country where the site is located.
- Step 3. Click Save.

## 4. Contact


In the *Contact* inventory you can insert the contact details of the relevant competent persons, such as person responsible for the safety data sheet (SDS), toxicologist, etc, which can be attached to the IUCLID dossier. This person may be contacted to provide assistance or ask about the information submitted.

Information on the contact person responsible for your submission must be specified and managed in REACH-IT.

A Contact can be either edited or created either from:

- 1. from the list page of Contacts which can be accessed from the main Menu;
- 2. from the place where the *Contact* is referred to in a dataset. Typically, a link can be made to more than one *Contact* from the same place. To create a new contact from the place where the *Contact* is referred to in a dataset, click on *Select* within the link as shown below. The link will take you to the *Contacts* inventory.

Figure 10: Link to Contact inventory from within the dataset




## 4.1. Creating a contact

To create a new contact:

- **Step 1.** Click on New contact / Create.
- **Step 2.** Provide the 'Last name' and the 'Organisation' (Fields marked with the red asterisk are mandatory) and complete as many fields as possible under General Information.
- Step 3. Click Save.

#### 5. Reference substance

A Reference substance enables you to store identification information on a given substance or a given constituent of a substance, such as chemical names (EC name, CAS name, IUPAC name, synonyms, etc.), identity codes (EC number, CAS number), molecular and structural information.

The *Reference substance* inventory gives the possibility to use the same information for the same chemical identity avoiding to re-type it and to ensure that the data is centrally managed and updated. The *Reference substance* inventory is directly maintained by you, in your IUCLID web user interface. Each *reference substance* can be linked to an unlimited number of *substance* or *mixture* datasets. For updating the information in a *reference substance*, you can open the *Reference substance inventory*, search for the relevant *reference substance* and update it. The modifications will impact every single dataset linked to that *reference substance*.

To extend the number of entries in your inventory, you can search, download and import available reference substances from the IUCLID website under the section <a href="Support -> Get IUCLID">Support -> Get IUCLID</a> data -> Reference substances to your IUCLID web user interface. These pre-defined reference substances have been prepared to improve data quality and minimise data entry.

## 5.1. Creating a reference substance

If you do not find a reference substance in the *Reference substance* inventory, you can create a new reference substance.

There are two types of information that can be reported in a reference substance:


- 1. Information **specific** to the reference substance: such information exactly corresponds to the substance/constituent(s) covered by that reference substance;
- Information related to the reference substance: this information does not accurately correspond to the substance/constituent(s) covered by that reference substance for any of the following reasons:
- The information is generic as it also covers other substances/constituents;
- The information only covers some of the constituents of a reference substance for a substance or a group of constituents;
- The information refers to a similar constituent/substance;
- The information is not the latest available information to identify the substance/constituent(s)

Related information should be reported under the *Identifiers of related substances* as it may create an ambiguity on the identity of substance or constituent(s) which a reference substance corresponds to.

The creation and editing of a *Reference substance* can be done from the point where the *Reference substance* is referred to in a dataset, or from the list page of *Reference substances*. Here below you find instructions on how to create a *Reference substance* from the inventory list page.

To open the list page for *Reference substances* click on the menu button in the top left corner of the *Dashboard*, and then click on *Reference substance* in the main menu as shown below.


Figure 12: Open the list page for Reference substances



To create a new Reference substance:

**Step 1.** Click on *New reference substance*.

- **Step 2.** Enter a name for your new *Reference substance* and click *Create*. Once you receive the message that your Reference substance has been created click *Open*.
- **Step 3.** If the **reference substance is listed in the EC inventory** you can assign that entry by filling the *Inventory number* field.

- **Step 4.** If your **reference substance is not listed in the EC inventory**, select a justification from the picklist proposed under the *No inventory information available Justification*.
- **Step 5.** Complete as far as possible the remaining fields of the reference substance.

The following information, if available and/or applicable, should be submitted for the substance and any of the constituents, impurities and additives required to be reported:

- EC Inventory number,
- CAS number and CAS name,
- *IUPAC name* (Note that, if a name following the IUPAC nomenclature cannot be derived, you should still provide a name defining the chemical nature of the substance or the constituents/impurities/ which the reference substance describes),
- Description (Specify any additional information relevant for the description of the reference substance in this field. This is important especially when the reference substance does not correspond to a well-defined chemical substance. Attached files can be added if necessary.),
- Synonyms,
- Identifiers of related substances,
- Molecular formula (if a molecular formula cannot be derived from the reference substance, a justification should be indicated in the Remarks field at the bottom of the section);
- Molecular weight range,
- *SMILES notation* (the text must be limited to the SMILES notation itself. Do not include any other text in this field. Further information on the nomenclature is available at e.g. <a href="https://www.daylight.com/dayhtml/doc/theory/theory.smiles.html">https://www.daylight.com/dayhtml/doc/theory/theory.smiles.html</a>. SMILES translators are available from different websites such as <a href="https://cactus.nci.nih.gov/translate/">https://cactus.nci.nih.gov/translate/</a> and <a href="https://pubchem.ncbi.nlm.nih.gov/edit3/index.html">https://pubchem.ncbi.nlm.nih.gov/edit3/index.html</a>)
- *InChI* (the text must be limited to the InChI itself. Do not include any other text in this field. Further information on the nomenclature and a software to generate InChI are available at <a href="https://iupac.org/who-we-are/divisions/division-details/inchi/">https://iupac.org/who-we-are/divisions/division-details/inchi/</a>).
- Upload an image file with the Structural formula.

**Step 6.** To save the *Reference substance* click on *Save*.

#### 6. Literature reference

In *Literature references* inventory you can insert and store different types of the bibliographic references, such as publications and the study reports which serve as the literature basis for the endpoint study records. Each literature reference stored in your inventory can be linked to the endpoint study records of sections 4 to 10 in IUCLID.

The creation and editing of a *Literature reference* is done either:

- 1. from the list page of *Literature reference* which can be accessed from the main Menu;
- 2. from the point where the *Literature reference* is referred to in a dataset.

## 6.1. Creating a literature reference

To create a new literature reference from the point where the *Literature reference* is referred to in a dataset (like an endpoint study record), click on *Select* in the *Reference* field under *Data source* (1). The link will take you to the Literature reference inventory. In the pop-up window click on *Create /New Literature reference* (2). Fill in the fields in the pop-up window (3) and click *Save* (4).

Figure 14: Create a new Literature reference (1)




Figure 15: Create a new Literature reference (2)





Figure 16: Create a new Literature reference (3)



## 7. Test material

In the *Test material* record you can insert information on the identity of the material(s) used in the study(ies) reported in your dossier. *Test material* records stored in the inventory can be reused in each record where the same test material was used. A link can be made to a *Test material* entity from within an endpoint study record. In this way, the test material information can be centrally prepared and managed, and linked to the relevant endpoint study records.

Each *Test material* entry consists of a *Composition* to report the different constituents of the test material, similar to the information used to define a *Substance*. In addition, under *Other characteristics* the form of the test material can be provided as well as additional details on the test material.

The creation and editing of a test material is done either:

- 1. from the list page of *Test material* which can be accessed from the main Menu;
- 2. from the point where the Test material is referred to in a dataset. The link will take you

to the Test material inventory.

## 7.1. Creating a test material

To create a new test material from the place where the *Test material* is referred to in a dataset:

- **Step 1.** Click Select in the Test material information field. Then click Create / New test material.
- **Step 2.** Enter the same *Name* which is given in the study record where the test on the material has been performed.
- **Step 3.** Use the table under the *Composition* to report the *constituents*, *impurities*, *additives* of the test material. Identify the reported components by selecting the type of component (*Constituent*, *impurity* or *additive*) linking the corresponding *Reference substance* and insert their *Concentration*. To insert a new entry under the *Composition* click on *New item*. Alternatively you can import a CSV file.
- **Step 4.** If the details on the purity of the composition are not known, you can provide a qualitative statement by selecting the appropriate value from the *Composition / purity:* other information picklist.
- **Step 5.** When the *Test material* is used to identify the chemical structure used in a (Q)SAR prediction, information on the concentration is not relevant. Instead, the value *not applicable for in silico study* should be selected under *Composition / purity: other information* in addition to the specified *Composition*.
- **Step 6.** Under the *Other characteristics* you should insert information about the form of the test material and more details as appropriate.
- **Step 7.** To save the test material click on *Save*.

Figure 17: Create a new test material (1)




Figure 18: Create a new test material (2)





Figure 19: Create a new test material (3)




## 8. How to create a substance dataset

This chapter outlines which information you have to provide in different sections of IUCLID, which depends on the type of submission that you wish to do via a IUCLID dossier.

When entering your data you can use the help system of IUCLID that can be opened by clicking on the round question mark icon on the top-right corner of the screen.

For further support and to read specific help text that explains how each field should be used, click on a question mark icon displayed next to the field heading. Please note that the question mark icon will appear only after hovering with the cursor over the selected field.

To create a IUCLID **dossier**, you first need to create a substance **dataset**. A substance dataset is a repository of administrative and scientific data for a substance. The information in the dataset can be modified: you can add, remove or change information in the dataset. **The dataset is used as basis for the dossier.** The dossier is a snapshot of the dataset at a certain moment; the information in the dossier cannot be modified.

#### To create a dataset:

- **Step 1.** Click on the button entitled *Substances* in the IUCLID Dashboard and then click *New substance* in the top right-hand corner of the screen.
- **Step 2.** Fill in the field *Name* for your new substance. Especially if your IUCLID contains several datasets, ensure to enter a name that you can easily use to distinguish the substance. Then click *Create*.

- **Step 3.** Once you receive the message that the substance has been successfully created, click *Open*.
- **Step 4.** You are now presented with a view of your substance dataset with the *Complete table of contents* displayed as a navigation tree on the left-hand side of the screen.

Please note that all the *datasets* that you have created (or imported) can be accessed from the Substances page. To open a substance dataset, click on the selected substance among those displayed in the list. In case you have several datasets, you can search the substance you wish to view by typing into the query box either the substance name, the CAS or EC number of the substance, or its IUPAC name. Alternatively, the *Advanced search* can be used.

Figure 21: Substances page - list of substances






Figure 22: View of substance dataset with complete table of content (TOC)



- **Step 5.** To view the table of contents that is relevant for the type of dossier that you are preparing, click on the *Working context* query box and then click on *New working context*.
- **Step 6.** A picklist of different submission types appears. Select the specific type of submission from the list and click *Apply*.

Step 7. The sections relevant for the *working context* (submission type) are now displayed. Sections including mandatory information to complete are marked with the asterisk. Note that if you are creating a dataset but do not yet know the exact REACH dossier type that will be prepared, you can select the option REACH Complete. This will display the table of contents containing all sections that are relevant under the REACH Regulation.

For information on how to fill the data in the *Dossier header*, please see the dedicated section under the chapter '*How to create a Dossier*'.

Once you have created a dataset for your substance, you can enter data on the substance in this dataset. The following chapters describe what data should be entered into each section of IUCLID for the specific type of submission that this manual refers to. The sections are shown with their name and the numbering used with the relevant IUCLID table of contents view.

When filling in the different parts of a dataset it is important, that:

- when you create many rows in a table, you must fill in the relevant information in each row,
- when other is selected in a picklist the text field below marked with 'Other' must be completed,
- when a field is associated with a unit, this must be filled in.

# 8.1. Templates

A Template allows data from multiple sections to be copied or linked to a Substance dataset all at once without having to manually recreate all sections and to retype the data. Its structure is very similar to that of a substance dataset. Templates can be accessed from the Main menu.

A template can be used in two different ways:

**Inherit:** in this case a link is established between a substance and a template. The data managed in the template can only be edited in the template itself but is visible in the substance dataset together with the other data. When modifications are made in the template, they are immediately reflected in the substance dataset to which the template is linked. The same template can be linked to different substances which then share a common set of data.

**Copy:** in this case the documents part of the template are copied to the substance dataset. There is no link between the documents in the template and the documents copied in the substance. After the copy, the documents in the template and in the substance dataset are not synchronised anymore. A document copied in this way can be modified in the substance to which it was copied. Even if the template is completely deleted the data in the substance dataset are not affected.

For more information on *Templates* refer to the help system of IUCLID.

# 8.2. Categories

For the substances whose physicochemical and toxicological properties are similar or follow a regular pattern as a result of structural similarity, a *Category* can be created in IUCLID and included in the dossier. These structural similarities may create a predictable pattern in any or all of the following parameters: physicochemical properties, environmental fate and environmental effects and human health effects.

Grouping the chemicals in terms of their similarity could be based on the following:

- common functional group (e.g. aldehyde, epoxide, ester, metal ion, etc.);
- common precursors or breakdown products (e.g. the "metabolic pathway approach" of examining related chemicals such as acid/ester/salt);
- incremental and constant change across the category (e.g. a chain-length category);
- · common constituents or chemical class.

A chemical category is defined by a list of chemicals (the category members) and by a set of properties and/or effects for which experimental and or estimated data are available or can be generated (the category endpoints). For each category member, a separate substance dataset

in IUCLID has to be created, in which all relevant data are entered.

Data gaps in a chemical category can be filled by using various approaches, including simple read-across, trend analysis (interpolation and extrapolation) and computational methods based on SARs, QSARs or QAARs.

More information on how to use these methods to fill data gaps is available on the ECHA website: <a href="https://echa.europa.eu/practical-guides">https://echa.europa.eu/support/grouping-of-substances-and-read-across</a> and <a href="https://echa.europa.eu/support/oecd-gsar-toolbox">https://echa.europa.eu/support/oecd-gsar-toolbox</a>.

For all information needed on how to create a dossier based on category refer to the help system built-in IUCLID.

The following chapters provide you with information on the different sections of IUCLID relevant for a registration dossier.

# 8.3. Section 1 General information

In section 1, *General information*, enter information on substance identity and the submitting party in the different sections as explained below.

#### 8.3.1. Section 1.1 Identification

Section 1.1 contains the identification of the substance, role in the supply chain and the type of (reference) substance. To complete this section, follow the steps:

- **Step 1.** In the *Substance name* field type a name for the substance which you are preparing the dossier for.
- **Step 2.** If you have any confidentiality concerns about the substance name, you need to fill in the *Public name* field. In this field you have to indicate a generic name suitable for publication, which appropriately describes the substance.

For more information on how to derive a *public name* for a substance for use under the REACH Regulation, refer to the manual *Dissemination and confidentiality under the REACH Regulation* available at <a href="https://echa.europa.eu/manuals">https://echa.europa.eu/manuals</a>.

**Step 3.** Assign a *Legal entity* to your substance dataset.

The legal entity that has subscribed to the web interface has automatically been attached in the IUCLID web interface.

**Step 4.** For REACH registration, Inquiry and PPORD dossiers you can indicate a *Third party* representative.

Information on the *Third party* representative for your submission must be specified and managed in REACH-IT prior to the submission. For more information on *Third party* representatives, please refer to the *Guidance on data sharing* available at: <a href="https://echa.europa.eu/guidance-documents/guidance-on-reach">https://echa.europa.eu/guidance-documents/guidance-on-reach</a>

#### Identification of substance:

- **Step 5.** Click in the *Reference substance* field under *Identification of substance* and then click *Select* to identify your reference substance.
- **Step 6.** Search for your reference substance and click on it.

If you cannot find your reference substance because it has not been created yet, click *Create* and create it (see chapter *Reference substance*).

The information to be reported in your reference substance depends on the substance type:

#### • Mono-constituent substances:

A **mono-constituent substance** is a **well-defined substance** for which one constituent is present at a concentration of at least 80 % (w/w). This constituent is the main constituent of the substance. The substance is named according to the chemical name of that main constituent.

If your substance is a **mono-constituent** substance, assign the *reference substance*<sup>4</sup> corresponding to the main constituent in section 1.1.

#### Multi-constituent substances:

A **multi-constituent substance** is a **well-defined substance** for which more than one constituent is present at a concentration between 10 % and 80 % (w/w). These constituents are the main constituents of the substance. A multi-constituent substance is normally named as a *reaction mass* of the main constituents.<sup>5</sup>

If your substance is a **multi-constituent** substance, assign the *reference substance*<sup>6</sup> corresponding to the reaction mass of the main constituents of your substance in section 1.1.

#### UVCB substances:

**UVCB substances** (i.e. substances of Unknown or Variable composition, Complex reaction products or Biological materials) are substances that cannot be sufficiently identified by their chemical composition.

If your substance is a **UVCB** substance, assign a *reference substance*<sup>7</sup> corresponding to the UVCB substance in section 1.1.

<sup>3</sup> Certain multi-constituent substances corresponding to reaction masses of isomers may sometimes be more conveniently named using a chemical name where the isomeric form is not specified rather than as a "reaction mass".

A Note that for the reference substance: Molecular formula, Molecular weight range and Structural formula must be provided. In addition, the SMILES notation should also be provided if available.

Note that the chemical name of the multi-constituent substance must be reported in the IUPAC name field of the reference substance. This applies even if the naming convention "reaction mass of" does not follow the IUPAC nomenclature. Note also that the *Molecular formula*, *Molecular weight range* and *Structural formula* of the reference substance must be provided or a justification for not providing this information must be given in the *Remarks* field. In addition, the *SMILES notation* should also be provided if available.

Note that the chemical name of the UVCB substance must be reported in the IUPAC name field of the reference substance. This applies even if the naming conventions for UVCB substances do not follow the IUPAC nomenclature. Note also that the *Molecular formula*, *Molecular weight range* and *Structural formula* of the reference substance must be provided or a justification for not providing this information must be given in the *Remarks* field. In addition, the *SMILES notation* should also be provided if available.

#### Type of substance:

**Step 7.** Select the appropriate *Type of substance* from the picklist. For submissions of registrations under REACH, you can only select between mono-constituent substance, multi-constituent substance and UVCB (the options *polymer* and *other:* are not relevant).

We also recommend you to read the *Guidance for identification and naming of substances under REACH and CLP* available at <a href="https://echa.europa.eu/guidance-documents/guidance-on-reach">https://echa.europa.eu/guidance-documents/guidance-on-reach</a>.

- **Step 8.** Select the *Origin*, e.g. organic or inorganic, from the picklist.
- **Step 9.** If relevant, you can include additional identifiers for your substance under *Other substance identifiers*. Such identifiers may include trade names of the substance, identifiers by which the substance was previously known but have later been replaced/refined, or identifiers which are used to identify the substance under other regulatory schemes. Chemical (scientific) synonyms should not be listed here, but should be indicated in the reference substance information.
- **Step 10.** You can add information of the contact person(s) for this substance from the previously defined contacts (see chapter <u>Contact</u>). A new contact can also be created by clicking <u>Select</u> on the <u>Person</u> field and then <u>Create</u>. An example of a contact to be added here is the competent person responsible for the Safety Data Sheet (SDS) of the registered substance.

# Role in the supply chain:

- **Step 11.** Select at least one checkbox in this section according to your role in the supply chain with regards to this substance.
- **Step 12.** To save the information click *Save*.

# 8.3.2. Section 1.2 Composition

In this section, you will report the identity and concentration of the constituents of the composition, including any impurities and additives. The state and form of your composition(s) is reported in this section.

Additionally, in this section you can indicate if your registration dossier cover nanoforms and fill in information on their characterisation parameters. For more information, please refer to the manual *How to prepare registration dossiers covering nanoforms* at <a href="https://echa.europa.eu/manuals">https://echa.europa.eu/manuals</a>.

You should ensure that the information included in IUCLID section 1.1 and section 1.2 is sufficient to clearly report your substance identity and is consistent between both sections. The information reported may not be so generic that it would describe more than one substance.

Each substance dataset must contain at least one composition record which refers to the composition manufactured, imported or used by the registrant/notifier/applicant. Depending on the type of substance and dossier to be prepared, it may be necessary to report more than one composition. This is in the specific case where compositional differences affect the hazard profile and classification of the substance.

Each composition is reported as a record in IUCLID. To create a new record:

- **Step 1.** Click on the + button displayed in the navigation tree next to 1.2 Composition.
- **Step 2.** Fill in the composition as described below.

#### **General information:**

**Step 1.** Provide a descriptive *Name* for the composition. This is especially relevant if you report multiple compositions.

For more information on how to name the substance, please refer to the *Guidance for identification and naming substances under REACH and CLP* available at: https://echa.europa.eu/guidance-documents/guidance-on-reach

- **Step 2.** The default selection in the *Type of composition* field is *legal entity composition of the substance*. This refers to a composition manufactured, imported or used by the registrant/notifier/applicant. Each dataset should contain at least one composition of this type. Only modify this value where you intend to report a composition with a different purpose. For more information on what composition types that can be reported for that submission please refer to the specific instructions for the submission type that you are preparing, you can find more explanations below.
- **Step 3.** You must indicate the physical *State/form* of the composition by selecting the appropriate value in the picklist. Where the substance covers different physical states or forms, a separate composition should be created for each of them. If case your composition covers nanoforms, you must select the value 'solid: nanoform' in order to be able to insert their characterisation below (For more information please refer to the manual *How to prepare registration dossiers covering nanoforms* at <a href="https://echa.europa.eu/manuals.">https://echa.europa.eu/manuals.</a>)
- **Step 4.** You can give more detailed information on the composition under the *Description* field. This is particularly important when several compositions are reported in order to clarify the differences between them. Providing further considerations on how the composition has been defined is also advisable when the composition covers wide concentration ranges or polymorphs or isomers. For substances that cannot be described with well-defined and quantified constituents (e.g. UVCB substances), further information to identify the composition is provided in this field, including the identity of the starting materials and a description of the production process used to manufacture the substance (see Table 2).

Table 2: Example of the manufacturing process of a UVCB substance that should be reported in the 'Description' field

Description	
Identity and ratio of starting materials	Soybean oil (EC#232-274-4) and methanol (EC# 200-659-6, purity 99%) are used in a molar ratio of 1:4 respectively.
Description of the relevant manufacturing steps in the order they occur (including information on the reaction steps/mechanisms)	Step 1: loading of the reactants in the batch reaction vessel Step 2: loading of the catalyst in the batch reaction vessel Step 3: transesterification reaction Step 4: extraction with water Step 5: distillation of the organic phase Step 6: collection of the residue from the distillation process.  Please see the attached process workflow.

The relevant operating parameters applied to control the composition (e.g. temperature, pressure, solvent, catalysis type)	Step 1: no relevant parameter  Step 2: the catalyst used is sodium hydroxide (EC# 215-185-5)  Step 3: the reaction is carried out at 50oC and is monitored every 5 hours by gas chromatography (GC-FID). The reaction is stopped when the concentration in the methyl esters formed during the reaction represents at least 75% (w/w) of the reaction medium.  Step 4: the extraction is carried out until the glycerol is removed in full. It involves a drying step of the organic phase. The drying method does not contaminate the organic fraction. - **Step 5.** In the *Justification for deviations* field, provide where relevant, the justification for deviating from the rules for reporting the composition of substances as specified in the legal text and indicated in the *Guidance for identification and naming of substances under REACH and CLP* available at <a href="https://www.echa.europa.eu/web/guest/guidance-documents/guidance-on-reach">https://www.echa.europa.eu/web/guest/guidance-documents/guidance-on-reach</a>.
- **Step 6.** You can provide supporting attachments under the *Attached description/ Justification*. Note that under *Attached description/ Justification* you can attach information that complements the description of the manufacturing process for a UVCB substance, for example reaction schemes and process workflows. Additionally, you can attach information that complements justifications for deviating from standard requirements for reporting your substance. However, in this case please be aware that the rationale must be provided in the *Justification for deviations* field.

# Types of composition

In IUCLID 6, the composition record contains the field *Type of composition*. This field allows users to indicate more precisely the nature of the composition they are providing. The field will be automatically populated with the value *legal entity composition of the substance* during migration or when creating a new record. This type of composition is expected to reflect the composition of the registered substance as manufactured/imported by the registrant and is an information requirement subject to completeness check. The first legal entity composition record will be used by REACH-IT to determine the substance identity of the registration.

Other composition types available are *boundary composition of the substance* (see below for more information), and *composition of the substance generated upon use*.

A composition generated upon use is a composition/form of the registered substance generated in the supply chain by processes other than manufacture such as purification or generation of nanoform from bulk form by mechanical process. This composition generated upon use should only be reported when it refers to the same substance. Identifying such compositions/forms enables transparent reporting of the properties of the various compositions (classification and labelling, fate and hazard assessment) when those are different. You may use assessment entities for that (see chapter <u>Assessment approach</u>). It also enables clear identification of the uses relevant for each composition. See also paragraph on connecting the compositions to the hazard information below.

## Boundary composition of the substance for lead registrants

IUCLID 6 enables registrants in a joint submission to report the substance identity information that should be common to the legal entity compositions for which they are jointly submitting the Annex VII-X information and the related classification and assessments. This information is reported in the format of a so-called *boundary composition of substance*. This type of composition is also known as the Substance identification profile (SIP, as published by Cefic<sup>8</sup>). The number of boundary compositions provided in one dossier will depend on the variability of the compositions registered by the different joint submission participants and the fate and hazard profiles of these compositions. If one information profile (physicochemical, fate and hazard information) covers all the compositions reported in **section 1.2 by all the participants of the joint submission**, it is sufficient that one *boundary composition* is defined in the lead registrant dossier, covering all the legal entity compositions in the joint submission.

Boundary compositions should be reported in the lead registrant dossier. Information provided in boundary composition records is extracted to the REACH-IT Joint submission page and displayed to participants of the joint submission. Boundary compositions are subject to certain business rule checks and completeness checks which verify that the minimum information is present and consistent with the substance type. The business rule checks and completeness checks are listed in Annexes 1 and 2 of this manual.

Registration dossiers for joint submission member registrants, or dossiers for a substance with no joint submission, are not expected to contain boundary compositions.

# **Related composition:**

**Step 7.** Provide related compositions whenever relevant.

This *Related composition* functionality enables you to define the logic links existing between the compositions reported in a registration:

- If you are the **lead registrant**, for each legal entity composition you report, select the relevant boundary composition in the *Related composition* field by clicking the *Select* button.
- If you are a **member registrant**, for each legal entity composition you report, include the Name of the relevant boundary composition submitted by the lead registrant in the *Reference to related composition(s)* field.

The *Name* of a boundary composition submitted by the lead registrant is extracted to the REACH-IT Joint submission page and displayed to participants of the joint submission.

Please refer to the help system of IUCLID for more information on this section.


#### Degree of purity:

**Step 8.** Provide the *degree of purity* of the composition, together with the unit of measurement. For instance, a substance with a purity of between 95-98% (w/w) will be given as shown below.

Note: The degree of purity should correspond to the overall concentration of the (main) constituents in the composition.

Figure 24: Degree of purity




#### **Constituents:**

- **Step 9.** Include the *constituents* for the composition. Each composition must have, as a minimum, one constituent. The number of constituents to be reported will depend on the type of substance. To add more constituents, click on *New item*, and then on the new rows will appear.
- **Step 10.** Assign a *reference substance* to the newly created constituent. Search for the appropriate reference substance by clicking *Select*. Once you have found the appropriate reference substance click on it to select it; alternatively, create a new reference substance to specify the constituent (see chapter *Reference substance*). Ensure that the reference substance contains a chemical name in the *IUPAC name* field, and the appropriate EC and CAS identifiers, as available. To create a new reference substance click *Create*.
- **Step 11.** Indicate the *Typical concentration* and the *Concentration range* (minimum and maximum values, and unit of measurement) for every constituent.

Alternatively, you can add constituents by uploading a CSV file.

## **Impurities and additives:**

- **Step 12.** To complete the information regarding *Impurities* and *Additives* follow the same procedure.
- **Step 13.** Where the impurity or additive is considered relevant for classification and labelling of the substance, the relevant checkbox must be selected.
- **Step 14.** The function of each *additive* has to be provided by making a selection in the picklist *Function*. Only selections beginning with the word *stabiliser* are applicable under REACH and CLP.

To report **unknown impurities**, create a generic reference substance (see chapter <u>Reference substance</u>) and insert in the <u>IUPAC name</u> field the phrase <u>unknown impurities</u>. In the <u>Remarks</u> field of the impurity block, specify the nature, number and relative amounts of the impurities as far as possible. Also provide the <u>Typical concentration</u> (with unit of measurement) and <u>Concentration range</u> (with unit of measurement) for the <u>unknown impurities</u>.

Similarly to Constituents, you can fill in the Impurities and Additives by importing a CSV file.

Figure 26: Reporting unknown impurities





Figure 27: Reporting additive



When reporting information on the composition, where there is any deviation from the rules for identifying a mono-constituent, multi-constituent or UVCB substance, you will need to provide explanations for the deviations in the field *Justification for deviations*. Such deviations include, for example, reporting a mono-constituent composition that includes a main constituent with a concentration of less than 80 %.

The composition to be reported depends on the substance type:

# Mono-constituent substances:

**For mono-constituent** substances, you have to provide the following information:

- Report only the main constituent under the *Constituents* in section 1.2. Assign the same reference substance for this constituent as in section 1.1;
- Report individually any impurities under the Impurities in section 1.2;
- Report any additive necessary to stabilise your composition under the Additives in section 1.2. Specify the stabilising function of the additive from the picklist *Function*;
- Report the concentration range (both minimum and maximum values) and the typical concentration for the main constituent, any impurity and any additive;
   Note: The typical concentration and concentration range values reported for the main constituent of a mono-constituent substance should normally not be less than 80%

 $(w/w)^9$ ;

• Report a *degree of purity* for your composition corresponding to the *concentration range* of the main constituent.

# **Multi-constituent substances:**

For **multi-constituent** substances, you have to provide the following information:

- Report the main constituents under the Constituents in section 1.2.
   Note: The main constituents should be the same for all compositions reported;
- Report any other constituent below 10% under Impurities in section 1.2;
- Report any additive necessary to stabilise your composition under *Additives* in section 1.2. Specify the stabilising function of the additive from the picklist *Function*;
- Report the concentration range (both minimum and maximum values) and the typical concentration for the main constituents, any impurity and any additive. Note: The typical concentration and concentration range values of each main constituent should normally be ≥ 10 and < 80%<sup>10</sup>;
- Report a *degree of purity* for the composition corresponding to the overall concentration range of the main constituents.

#### Registration of individual constituents of a multi-constituent substance:

Under specific circumstances (see the <u>Guidance for identification and naming of substances under REACH and CLP</u>), you may register the individual constituents of multi-constituent substances instead of the multi-constituent substance itself.

In this case, select mono-constituent in the field *Type of substance*, and proceed as follows:

- Assign a reference substance corresponding to the constituent you are registering in section 1.1;
- For technical reasons, report the composition of the corresponding mono-constituent substance as the first composition with the composition type *legal entity composition* in section 1.2;
- If you also manufacture or import such a mono-constituent substance, you should report the composition of that substance as the first composition;
- If you do not manufacture or import such a mono-constituent substance, you still need to report a composition corresponding to the mono-constituent substance as the first composition in section 1.2. In this case we recommend you report a theoretical composition where the main constituent is reported at a typical concentration of 100%(w/w). Select legal entity composition of the substance as the type of composition. Insert in the field Description the considerations for using the approach to register the multi-constituent substance through its individual constituents, as well

- as the following statement: "This composition is neither manufactured nor imported. It is only reported for technical reasons because the registration of the multi-constituent substances through their individual constituents is applied";
- Report all the multi-constituent compositions that you manufacture/import where the constituent, to which the registration dossier refers, is present. Include the following statement in the field *Justification for deviations*: "Composition of a multi-constituent substance covered by the registration of its individual constituents".

#### **UVCB** substances:

For **UVCB** substances, you have to provide the following information:

- Report the description of the manufacturing process, as well as other information relevant for the substance identification, in the field *Description*; Note: To facilitate the reporting of the manufacturing process, suggestions as to what to enter are provided in free text templates for the field *Description*. To open the free text templates, click on the icon that shows the letter A with an arrow at the bottom right, A Insert existing templates. A pop-up window appears. Click *Option 2*: Composition of a UVCB substance or Option 6: Composition of a petroleum UVCB substance depending on the type of your UVCB substance. The text should then be edited so that it contains only the relevant data;
- Report the appropriate individual constituents or groups of constituents under Constituents. To provide compositional information, you must not reuse, in section 1.2, the reference substance already assigned for your substance in section 1.1, but instead report individual constituents or groups of generic constituents based on their chemical nature.
- Do not report any constituent under the *Impurities* of the composition (impurities are not considered relevant for UVCBs);
- Report any additive necessary to stabilise your composition under *Additives*. Specify the stabilising function of the additive;
- Report the concentration values of the individual constituents, groups of constituents and any additive as a concentration range (both minimum and maximum values) and typical concentration.
- Report the appropriate *degree of purity* for your UVCB substance (the degree of purity should normally be 100% for UVCBs which do not include any additive, as the concept of *impurity* is not considered relevant for these substances).

#### Reporting the characterisation of nanoforms:

This sub-section is filled in when 'solid: nanoform' has been selected in the State/form picklist for that composition. It includes fields to report key characteristics of compositions that are nanoforms. For more information on how to fill in this section please to the manual *How to prepare registration dossiers covering nanoforms* at <a href="https://echa.europa.eu/manuals">https://echa.europa.eu/manuals</a>.

#### Reporting the characterisation of polymers:

This sub-section should not be filled under REACH regulation at present.

# Connecting the composition(s) to the hazard information when several fate/hazard profiles are covered by the registration.

When more than one composition is reported in section 1.2, it is important to clarify whether they correspond to one or more fate/hazard profiles (properties of the substance reported in sections 2 and 4 to 7 of the IUCLID dossier).

If the registration covers more than one fate/hazard profile, in order to transparently report the properties for the various compositions, it is strongly recommended to define assessment entities (see chapter <u>Assessment approach – assessment entities</u>). In addition, in such case, it is important that you create the relevant links between the various IUCLID records to make clear which fate/hazard data are relevant for which compositions. For that you should link the following records to the composition:

- A Classification and Labelling record in section 2.1;
- A PBT summary in section 2.3 (if a CSR is required);
- One or more assessment entity records in section 1.10.

For joint submissions several boundary compositions should be defined in the lead dossier, each covering those legal entity compositions sharing the same fate/hazard profile. The links mentioned above have to be made to the boundary compositions.

For individual submissions, those links have to be made to the legal entity compositions.

If a composition generated upon use is part of a substance dataset those links have to be made to it as for the cases above.

#### 8.3.3. Section 1.3 Identifiers

In this section you can insert identifiers for regulatory programmes. In particular, this section should be used to report the following identifiers when available: REACH registration number, REACH pre-registration number, REACH inquiry number, notification number (NCD), CLP notification number.

To enter your data:

- **Step 1.** Click the *New item* button under Regulatory *programme identifiers and* then click on the generated row.
- **Step 2.** Depending on the type of submission, select the appropriate identifier from the *Regulatory programme* picklist.
- **Step 3.** Enter the relevant number in the *ID* field.
- **Step 4.** If you need to provide more than one programme identifier, create a new item by repeating the previous steps. Alternatively, you can import a CSV file.
- **Step 5.** To save the information click *Save*.

# 8.3.4. Section 1.4 Analytical information

Section 1.4 is for the inclusion of analytical information such as spectra or chromatograms to enable the identity of your substance to be verified, including the compositions specified in the dossier. It is also the place to include the descriptions of the methods used to generate this information.

In this section you can create several records to include analytical information you consider sufficient to verify the identity of your substance. To create a new record:

**Step 1.** In the navigation panel click on + next to 1.4 Analytical information.

To complete this section, follow the steps:

# Methods and results of analysis:

- **Step 2.** Use the table *Analytical determination* to provide analytical information used to verify the identity of the substance.
- **Step 3.** Fill in the information on the analytical methods and results of the analysis.

You can populate the repeatable block content by clicking on limport file and uploading a csv file. Alternatively, you can manually create a *New item* for each analytical determination and then click on the generated row: enter the *purpose* for which the analysis was carried out, select the *Analysis type* (e.g. spectral, chromatographic), *Type of information provided*, and any *Remark* you consider relevant. For each method, you should attach the file containing the method and the result of the analysis. If you cannot provide results for the indicated analysis type, select the reason from the picklist *Rationale for no results* and fill in the explanation in the *Justification* field. Note that several analysis types can be reported for one determination.


You can choose to enter *identification* or *quantification* as purpose of an analysis. Both identification and quantification analyses are expected to be submitted to verify the composition of a substance.

*Identification* refers to any analysis carried out to establish the identity of the constituents, including their chemical functionalities, present in the composition of a substance. Examples of analyses used for identification are spectroscopic analyses such as UV, IR, NMR, MS or XRD.

Quantification refers to any analysis carried out to establish the concentration of the constituents in the composition. Examples of analyses used for quantification are chromatographic analyses, elemental analyses, titration.

Some analyses may be carried out both for identification and quantification purposes.

- **Step 4.** Indicate whether your substance is optically active by selecting the appropriate value from the picklist under *Optical activity*.
- **Step 5.** Provide information on the optical activity, whenever applicable in the *Remarks* field.

# Related composition(s):

**Step 6.** You can link the reported analytical information to the relevant *Composition* from section 1.4. This is especially relevant when you have reported several compositions in section 1.2. To link reported analytical information to the relevant *Composition* from section 1.4 click *Select* in the *Related composition(s)* field. In the pop-up window select the composition among those displayed in the list.

In addition, in this section you can provide analytical data for nanoforms under the heading *Analytical determination for nanoforms*, for more information refer to the manual *How to prepare registration dossiers covering nanoforms* at <a href="https://echa.europa.eu/manuals">https://echa.europa.eu/manuals</a>.

## 8.3.5. Section 1.5 Joint submission

In this section you (regardless of if you are the lead or a member of a joint submission) may wish to indicate, for your own administrative purposes, the name and some further details of the joint submission that this substance refers to in the corresponding fields. To enter your data, you must first create a new record.

#### 8.3.6. Section 1.7 Suppliers

If the checkbox *Only representative* is selected in section 1.1 *Identification*, then you are advised to attach clear documentation of your appointment as the only representative (e.g. a copy of the appointment letter which was sent to importers) in the field *Assignment from non-EU manufacturer*. In this case, you are also advised to indicate the list of the importers' names covered by your registration in the field *Other importers*. To enter your data, you must create a new record.

# 8.3.7. Section 1.8 Recipients

This section only needs to be provided for **PPORD notification dossiers**. You can indicate the identity of all the customers in the PPORD activity, including their names and addresses. To enter

your data, you must create a new record.

#### 8.3.8. Section 1.9 PPORD

This section only needs to be provided for **PPORD notifications dossiers**. When you are creating a dataset for PPORD notification you must create a new record and fill in the following information:

- **Step 1.** Enter the *Name* for the PPORD activities for which the notification is prepared.
- **Step 2.** Report the *Estimated quantity* of the substance to be manufactured, imported or used in the production of an article for the purpose of PPORD for the calendar year of the notification.
- **Step 3.** This estimation can be provided as an exact or approximate tonnage, or as a tonnage range. However, it is important to provide as specific tonnage information as possible.
- **Step 4.** In the *Remarks* field you can provide additional information you consider relevant for the PPORD notification dossier, such as the Research and Development programme or other relevant information (as information related to requirements under Article 9.4 provided because of a request decision or spontaneously provided).
- **Step 5.** You can provide an attachment for any other information you consider relevant for the PPORD notification dossier. For example, you can attach a document justifying the request for extension of a PPORD.

# 8.3.9. Section 1.10 Assessment approach (assessment entities)

To prepare your registration dossier you need to have an understanding on the properties and the life cycle of your substances in order to determine your assessment approach. This is particularly relevant if you are registering a substance above 10 tonnes per year, and therefore have to perform a Chemical Safety Assessment. In a standard safety assessment, the fate and effect properties of a substance are characterised by one set of values. However, there are cases where more than one set of values for the fate and effect properties may be needed (for more details see the <u>Guidance on Chemical Safety Assessment</u> part D, chapter D.2). If several sets of properties are needed to assess your substance, then to transparently report the information in your registration dossier you are advised to create assessment entities (see <u>Annex 5:</u> <u>Assessment entities in IUCLID 6</u> for more information). For that:

- **Step 1.** Open section 1.10 Assessment approach (assessment entities).
- **Step 2.** Provide information on the assessment approach to fate/hazard followed, describing the overall reasoning used for the definition of the assessment entities.
- **Step 3.** Select the relevant type(s) of assessment entity and create a new record. Provide all necessary information and links to better understand your substance.

In any case, you are advised to provide information in the field *Approach to fate/hazard assessment* in section 1.10 even if no assessment entities need to be created. Such information will be reported in section 1 of the CSR.

# 8.4. Section 2 C&L and PBT assessment

There is one section in IUCLID for entering information relating to classification and labelling: 2.1 GHS. In addition, the section 2.3 PBT assessment will allow you to store the outcome of the PBT assessment performed under the REACH Regulation.

**GHS** is the abbreviation for the United Nations Globally Harmonised System.

**The CLP Regulation** is the Regulation (EC) No 1272/2008 on the classification, labelling and packaging of substances and mixtures (CLP Regulation), which implements the GHS in the EU. Further information on CLP is available on our website at <a href="Understanding CLP - ECHA">Understanding CLP - ECHA</a> (europa.eu).

Once you have included the classification and labelling information in your registration dossier, or accepted the information included in the lead registrant's dossier, you do not need to submit a separate C&L notification (Article 40 of CLP).

#### 8.4.1. Section 2.1 GHS

Use this section to specify the Classification and Labelling (C&L) information of your substance resulting from the application of the criteria of the CLP Regulation (1272/2008).

It is necessary to consult Annex I of the CLP Regulation for the classification criteria and the following guidance documents for more detailed instructions on its application. The Guidance documents are available at <a href="http://echa.europa.eu/web/guest/guidance-documents/guidance-on-clp.">http://echa.europa.eu/web/guest/guidance-documents/guidance-on-clp.</a>

In this section you can create several records to indicate more than one C&L for different compositions and forms of a substance. Note that when a new record is created you must fill in the data in all requested fields.

To create a new record:

- **Step 1.** In the navigation tree on the left-hand side of the screen click on the + button next to 2.1 *GHS*.
- **Step 2.** A new record to report the classification and labelling information is created.

Harmonised classification has to be respected and you should not modify any of those harmonised hazard classes/differentiations. Exception is made when there is a "minimum classification" in Annex VI, marked with an asterisk. In this case, if there is data on which a stricter classification (hazard classes and/or differentiations) could apply, you should use that. If there is data available for a stricter classification, but the one in Annex VI to CLP is not such a "minimum classification", you should report it to your relevant Member State competent authority. Please see further information in point **Re-assessment of the harmonised classification** at <a href="https://echa.europa.eu/regulations/clp/harmonised-classification-and-labelling">https://echa.europa.eu/regulations/clp/harmonised-classification-and-labelling</a>.

Note that all other hazard classes not listed in an Annex VI entry must also be assessed, and if the data shows that additional hazard classes apply, you should report them in the same record with the harmonised classification. Please also remember that your substance may be covered by one or more group entry in Annex VI that may not come up in a search for the name and identity numbers of the substance.

To complete this section, follow the steps:

#### **General information:**

- **Step 1.** Enter a descriptive *Name* for the GHS record. This is particularly relevant in the case that multiple GHS records are created, to easily distinguish the different records.
- **Step 2.** If you submit a dossier for a substance which is not classified, you should select the checkbox *Not classified.* In this case, you should not enter any *Hazard category* or *Hazard statement* in the GHS record.
- **Step 3.** Specify the *Implementation* by selecting from the picklist.
- **Step 4.** In the field *Type of classification*, indicate whether the reported classification corresponds to a harmonised classification as per Annex VI of the CLP regulation, or to a self-classification.
- **Step 5.** Enter any additional information in the *Remarks* field.
- **Step 6.** Select a composition(s) in the *Related composition* field for which the GHS record is relevant by clicking the *Select* button.

If you have several compositions (several records in section 1.2) and several GHS records (i.e. several classification and labelling pairs), then it is mandatory that you link each GHS record to the related composition(s) by using the *Related composition* field.

Several compositions can be linked to the same C&L record if they have the same classification.

#### Classification:

Under this header you must select a *Hazard category* and *Hazard statement* for each hazard class or differentiation. Otherwise, you must fill in the *Reason for no classification*.

Note that when reporting hazards, the fields have a default selection in the field *Reasons for no classification* as *Data lacking*. The fields to report hazard categories are only available for editing when the option *Not classified* is unticked, and when the field *Reason for no classification* is cleared of a selection.

The Reason for no classification should be selected according to the following principles:

- data lacking should be selected if you do not have relevant data or other adequate and reliable information that can be compared with the classification criteria;
- data inconclusive should be selected if you have data or other information which is not reliable (e.g. data of poor quality) or if you have several equivocal study results or information. In these cases, the available data/information cannot be regarded as a firm basis for classification;
- data conclusive but not sufficient for classification should be selected in cases where a

substance has been tested with the appropriate high quality or where other high-quality information is available, and based on that, it is concluded that the classification criteria are not fulfilled.

- hazard class not applicable should be selected in cases where a substance has a physical state which is not compatible with the physical hazard class under evaluation (e.g. Flammable Solid when the substance is placed on the market as a liquid).
- *hazard class not assessed* should be selected if the hazard class has not been assessed and the justification cannot be covered by any of the other options.

For each of the classifications, or the reasons for no classifications, reported in this section, a justification should be provided in the field *Justification for (no) classification*. This field is available in the endpoint summary for some specific endpoints:

- 4.13 Flammable
- 4.14 Explosives
- 4.15 Oxidising properties
- 6 Ecotoxicological information
- 7.2 Acute Toxicity
- 7.3 Irritation / corrosion
- 7.4 Sensitisation
- 7.5 Repeated dose toxicity
- 7.6 Genetic toxicity
- 7.7 Carcinogenicity
- 7.8 Toxicity to reproduction
- 7.9.1 Neurotoxicity
- 7.9.2 Immunotoxicity.

# The CLP regulation foresees certain waivers:

If a substance is classified for certain physical hazards, it does not need to be classified for certain others. For example: explosives, organic peroxides, self-reactive substances, and mixtures as well as pyrophoric or oxidising solids should not be considered for classification as flammable solids since flammability is an intrinsic hazard in these classes.

In case the above classification waivers apply, you should select conclusive, but not sufficient for classification as a reason for no classification.

#### and interconnections:

If a substance is classified for Skin corrosion Cat.1, the risk of severe damage to eyes is considered implicit (but not *vice versa*). In this case, the substance should be classified also for serious eye damage 1.

## **Classification - Physical hazards:**

**Step 7.** Specify the *Hazard category* (e.g. Expl. Div. 1.1) and *Hazard statement* (e.g. H201: Explosive; mass explosion hazard) for the *Physical hazards* by selecting the appropriate values from the picklists.

The CLP Regulation implements the Globally Harmonized System of Classification and Labelling of Chemicals (GHS). However, not all the hazard categories and corresponding hazard statements from the GHS have been implemented in the CLP Regulation. Therefore, please note when populating IUCLID section 2.1 - GHS that not all the available entries are relevant for CLP (e.g. Flammable liquids/Flammable liquid 4/H227: Combustible liquid).

#### **Classification - Health hazards:**

**Step 8.** Specify *Hazard category* (e.g. Acute Tox. 1) and *Hazard statement* (e.g. H300: Fatal if swallowed) for the *Health hazards* by selecting the appropriate values from the picklists.

The nature of *Reproductive toxicity* effects (i.e. damage to fertility and/or the unborn child), should be indicated in the field *Specific effect* by including the appropriate additional *Hazard statement* code(s).

The following additional codes are specified in Annex VI, 1.1.2.1.2: to the CLP Regulation:

- H360F May damage fertility.
- H360D May damage the unborn child.
- H360FD May damage fertility. May damage the unborn child.
- H360Fd May damage fertility. Suspected of damaging the unborn child.
- H360Df May damage the unborn child. Suspected of damaging fertility.
- H361f Suspected of damaging fertility.
- H361d Suspected of damaging the unborn child.
- H361fd Suspected of damaging fertility. Suspected of damaging the unborn child.

For more instructions on the selection of these codes, please consult the Guidance on the application of the CLP criteria available at <a href="http://echa.europa.eu/web/guest/guidance-documents/guidance-on-clp">http://echa.europa.eu/web/guest/guidance-on-clp</a>.

The route of exposure for Reproductive toxicity should only be specified if it is conclusively proven that no other routes of exposure cause the hazard. Supporting evidence should be attached in section 13 (unless it is already specified in Annex VI to the CLP Regulation).


Figure 29: Specify the nature and the route of exposure for reproductive toxicity



In case you have conclusive data which enables you to explicitly specify the hazard of *Carcinogenicity* via inhalation (or it is specified in Annex VI to the CLP Regulation) you should include the corresponding additional hazard statement code (H350) in the free text field *Remark*.

The route of exposure for Carcinogenicity should only be specified if it is conclusively proven that no other route of exposure causes the hazard. Supporting evidence should be attached in section 13 (unless it is already specified in Annex VI to the CLP Regulation).

**Step 9.** For the following hazard class or differentiation: Specific target organ toxicity - single exposure (STOT SE) and Specific target organ toxicity - repeated exposure (STOT RE) you should fill in Hazard category, Hazard statement and Affected organs. Otherwise, the field Reason for no classification should be filled in.


For practical reasons, it is not recommended to include more than three primary target organs. If more target organs are affected, it is recommended that the overall systemic damage should be reflected by the phrase *damage to organs*.

If the affected organ is unknown, indicate *unknown* in the field *Affected organs*. For these and other classes/differentiations, you are also advised to indicate the *Route of exposure*, where applicable.

You can specify more than one STOT SE /STOT RE by adding additional entries. To add additional entries, click *New item*.

The route of exposure should only be specified if it is conclusively proven that no other route of exposure causes the hazard. Supporting evidence should be attached in section 13 (unless it is already specified in Annex VI to the CLP Regulation).

\* Please note that for the purposes of classification, the CLP Regulation requires the hazard categories Muta. 1, Carc. 1 and Repr. 1 to be further distinguished on the basis of whether the evidence for classification is primarily from human data (Category 1A) or from animal data (Category 1B).

# Classification - Specific concentration limits:

**Step 10.** If your substance has harmonised *Specific concentration limits*, you need to specify them by filling in at least one of the two range fields in the *Concentration range* (%). In addition, you also need to indicate the relevant *Hazard categories*.


You can specify more than one concentration limit by adding additional entries. To add additional entries, click *New item*.

If you propose to set specific concentration limit(s) under the strict condition of Article 10 of the CLP Regulation, you have to provide a scientific justification in section 13.

For each specific concentration limit (SCL), you should specify:

- a concentration range (at least one of the two range fields);
- at least one hazard statement related to the SCL.

The CLP Regulation implements the Globally Harmonized System of Classification and Labelling of Chemicals (GHS). However, not all the hazard categories and corresponding hazard statements from the GHS have been implemented into the CLP regulation. Therefore, please note when populating IUCLID section 2.1 - GHS that the following hazard categories under the specific concentration limits are not relevant for CLP.

#### **Classification - Environmental hazards:**

**Step 11.** Specify *Hazard category* (e.g. Aquatic Acute 1) and *Hazard statement* (e.g. H400: Very toxic to aquatic life) for the *Environmental hazards* by selecting the appropriate values from the picklists.

The CLP Regulation implements the Globally Harmonized System of Classification and Labelling of Chemicals (GHS). However, not all the hazard categories and corresponding hazard statements from the GHS have been implemented into the CLP regulation. Therefore, please note when populating IUCLID section 2.1 - GHS that the following entries under the environmental hazards have not been transposed to CLP.

Hazardous to the aquatic environment	Aquatic Acute 2	H401


If a substance meets the criteria for classification to the aquatic environment as both, Aquatic Acute 1 and Aquatic Chronic 1 (or other category):

- select from the picklist in the field *Hazardous to the aquatic environment (acute / short-term)*, the category *Aquatic Acute 1* and the hazard statement *H400*;
- select from the picklist in the field *Hazardous to the aquatic environment (long-term)*, the category *Aquatic Chronic 1* (or relevant category) and the hazard statement *H410* (or relevant hazard statement).

When a substance is classified as *Aquatic Acute 1* and/or *Aquatic Chronic 1*, multiplying factor(s) (M-factor) must be assigned. Where appropriate, *M-factors* shall be set for acute and long-term hazards separately. This means that there can be two different *M-factors* for one substance.

If you propose to set such M-factors you have to provide a scientific justification in section 13.

# **Classification – Ozone layer:**

**Step 12.** Select *Hazardous to the ozone layer 1* in the field *Hazard category* and the *Hazard statement H420* if the substance is classified as such.

You can specify Additional hazard classes in the free text fields Additional hazard classes and


Additional hazard statements.

# Labelling:

- **Step 13.** Specify the *Signal word* by selecting the appropriate value from the picklist. If no signal word applies to your substance, then you need to select *No signal word* from the picklist.
- **Step 14.** If applicable, please select a *Hazard pictogram* from the picklist. You can select more than one pictogram by adding a *New item*.
- **Step 15.** You should select at least one *Hazard statement* from the picklist and provide *Additional text* where applicable. If no hazard statement applies to your substance, then you need to select *No hazard statement*.

You can always specify more than one hazard statement for the labelling by adding a New item.

The principles of precedence for the hazard pictograms are stated in Art. 26 of CLP Regulation. For example, if the hazard pictogram 'GHS06' applies, the hazard pictogram 'GHS07' should not appear on the label. Please consult CLP Regulation and the Guidance on the application of the CLP criteria to ensure consistency between the classification and labelling sections.

According to Art. 27 of CLP Regulation, some hazard statements are not required in the label as they would be redundant. A few examples are listed below. For additional information please consult the Guidance on the application of the CLP criteria.

However, not all the hazard categories and corresponding hazard statements from the GHS have been implemented into the CLP regulation. Therefore, please note when populating IUCLID section 2.1 GHS that the following hazard statements for labelling are not relevant for CLP.

Hazard statement (in Labelling section):
H227: Combustible liquid
H303: May be harmful if swallowed
H305: May be harmful if swallowed and enters airways
H313: May be harmful in contact with skin
H316: Causes mild skin irritation
H320: Causes eye irritation
H401: Toxic to aquatic life
H402: Harmful to aquatic life
H303+H313: May be harmful if swallowed or in contact with skin
H303+H333: May be harmful if swallowed or if inhaled
H313+H333: May be harmful in contact with skin or if inhaled
H303+H313+H333: May be harmful if swallowed, in contact with skin or inhaled
H315+H320: Causes skin and eye irritation
H313+H333: May be harmful in contact with skin or if inhaled H303+H313+H333: May be harmful if swallowed, in contact with skin or inhaled

- **Step 16.** If applicable, please select a *Precautionary statements* from the picklist.
- **Step 17.** If applicable, please specify the *Additional labelling requirements*. These include supplemental CLP hazard statements and additional labelling elements resulting from the application of CLP Article 25. Please consult the CLP Regulation and Guidance for further information on the additional labelling requirements.

#### Notes:

**Step 18.** If applicable, you can select *note(s)* from the picklist. These *notes* are mandatory for harmonised classifications listed in Annex VI to CLP. If your substance has a harmonised classification, and the entry has any of them, you need to include them in your dossier

# 8.4.1.1. C&L within a joint submission

The dossiers of the lead and the members of a joint submission have to be clear and transparent as to which classification belongs to which composition.

The lead registrant dossier contains the information on the collectively registered substance,

namely information on the intrinsic properties of the substance, and the resulting classification and labelling agreed among the members. The lead dossier also contains the boundary composition(s) of the substance, outlining the compositions and forms of the substance covered by the joint registration. It is therefore expected, that in the lead dossier, the C&L information is related to the boundary composition(s).

When multiple C&L records exist in section 2.1, and multiple compositions (of any type) exist in section 1.2, then the relations between these must be made explicit by linking them.

Joint submission member dossiers, where the forms and compositions registered by the member fall within the boundary compositions of the lead dossier, and therefore are covered by the agreed classification provided by the Lead, are not expected to contain C&L information.

There may be situations where joint submission participants (member or lead) wish to provide C&L information that is not in line with that agreed by the members and provided in the lead dossier for the collectively registered substance. In this case, the party wishing to provide the differing C&L should provide it in his own dossier as opted-out information (see chapter <u>Opt-out information for REACH registration</u>), and link each of the C&L records to the particular composition(s) it relates to. Such a composition would be of the type <u>legal entity composition of the substance</u>, if it is a particular composition manufactured or imported by that registrant, but not covered by the <u>boundary composition</u> of the substance. In specific cases, it could also be a <u>composition of the substance generated upon use</u>, if the composition is not manufactured/imported, but subsequently produced by e.g. purification or physical processing of the substance.

# 8.4.2. Section 2.3 PBT assessment

In this section, all registrants who need to conduct a chemical safety assessment (CSA) and report the relevant scientific data in the chemical safety report (CSR) should provide an assessment on whether the substance is persistent, bioaccumulative and toxic (PBT) and very persistent and very bioaccumulative (vPvB) (see chapter <u>Assessment reports</u>).

The PBT endpoint study record ( ) is the place where to report the assessment of the PBT properties of the substance itself, or of one or a group of constituents or a transformation product if relevant. To report a PBT assessment for any of the above a new record has to be created:

- **Step 1.** In the navigation panel click on the next to 2.3 PBT assessment.
- **Step 2.** Select PBT assessment EU. A new record to report a new PBT assessment is created.

You have to repeat the operation if you need to create several records for several (group of) constituents/impurities/additives or transformation products.

When filling in the endpoint study record please ensure that the conclusions reported for each individual property (P,B and T) are consistent with the conclusion reported for the substance (or (group of) constituents or transformation product) assessed in the record. If the conclusion is that the substance is not PBT then ensure that there is at least the justification that one of the criteria is not met (e.g. the substance is not persistent).

In case PBT assessment does not apply for that substance (e.g. inorganic substances), there is no need to create an endpoint study record but to report this in an endpoint summary (see below).

The final conclusion on the PBT assessment is to be reported and summarised in the endpoint summary (0).

- **Step 3.** In the navigation panel click on the next to 2.3 PBT assessment.
- **Step 4.** Select <sup>10</sup> PBT assessment. A new record to report a new PBT summary is created.

In the endpoint summary, you must select the appropriate option from the *PBT status* picklist. If you select option *PBT assessment does not apply*, then you must provide the relevant information in the *Justification* field.

In case you select the option 'the substance is PBT/vPvB' or 'the substance is handled as if it were a PBT/vPvB substance', it is important to remember that the next step of the PBT assessment is to characterise the emissions and demonstrate minimisation of releases in your CSR. In addition, the likely routes of exposure by which humans and environment are exposed to the substances should be summarised in the field *Likely routes of exposure*.

Ensure that the final conclusion reported in the endpoint summary takes into account, and is consistent with, the conclusions for the substance itself, for all the constituents or transformation products when relevant, reported in the endpoint study record(s).

When different compositions have different PBT status, several PBT summaries can be created. A link from the PBT summary to the composition record is then to be made to clearly identify the PBT status of the various compositions (see also the section 8.3.2 on composition).

The objective of the PBT Section 2.3 in IUCLID is not to repeat information already provided in other IUCLID sections and therefore a reference to other sections can be made in the justification fields for the various criteria.

In case of a joint submission, the PBT assessment (records and summary) should be submitted by the lead registrant on behalf of the members, unless the Chemical safety report is not submitted by the lead on behalf of (some of the) members of the joint submission. In that case, each member should submit their own PBT assessment. When submitted in the lead dossier, the PBT information is to be related to the boundary composition(s).

More information on the different fields of this section is available in the help system of IUCLID.

# 8.5. Section 3 Manufacture, use and exposure

This chapter contains information on how to report the manufacture and uses of the substance as well as information on conditions of use in a IUCLID dossier as specified under section 3 of Annex VI of REACH Regulation. Each section of IUCLID is explained in a separate subchapter including practical instructions.

When preparing a **PPORD notification dossier** you can use this section to indicate the *Sites* where the PPORD activity of the notifier takes place.

# 8.5.1. Section 3.2 Estimated quantities

Use this section to report the information of the tonnage manufactured, imported and used as such or in articles that is a subject to registration per calendar year.

To enter your data, you must create a new record per each calendar year that you want to report.

You can refer to the help system of IUCLID for more explanation on what each tonnage field means.

Where you are a part of a **joint submission** for the substance, you cannot submit a dossier for a higher tonnage band than the maximum tonnage band of the joint submission (defined by the template of the lead dossier) unless you opt-out from the tonnage band of the joint submission. To increase the tonnage band of the joint submission, the lead has to update the lead dossier.

The estimated quantities reported in this section 3.2 should be consistent with the tonnages reported for each use in section 3.5 and the tonnages in the dossier header (tonnage bands) for both the tonnage requiring a full registration (Article 10) and the tonnage registered under article 17/18. More information on reporting tonnages is available in *Annex 6 Overview of tonnage fields in IUCLID*.

# 8.5.1.1. Special considerations for intermediate use(s)

Please note that uses of intermediates for which strictly controlled conditions in the meaning of REACH Articles 17 and 18 cannot be demonstrated, should be reported as any other use in a full registration (REACH Article 10) in both IUCLID sections 3.2 *Estimated quantities* and 3.5 *Use and exposure information* and should also be accounted for in the exposure assessment and risk characterisation in the Chemical Safety Report. Hence, the fields *Tonnage used as intermediate under strictly controlled conditions (transported)* and *Tonnage used as intermediate under strictly controlled conditions (on-site)* in IUCLID section 3.2 should only be filled with the tonnage of the intermediate used under the conditions as set out in Articles 17 and 18.

If you have decided to cover in the same dossier both uses requiring a full registration (Article 10) and uses of intermediates under strictly controlled conditions (Articles 17 and 18) it is very important that the different uses are clearly identified in the field *Registration/Notification status for this use*. You are also expected to report a tonnage for use as intermediate in IUCLID section 3.2 and, additionally, exclude the intermediate tonnage under strictly controlled conditions from the exposure assessment. More aspects to consider when submitting one dossier covering intermediate and non-intermediate uses, are explained in the chapter 9 *How to create a dossier*.

# 8.5.1.2. Special considerations for PPORD use

If part of the tonnage is used for the purpose of **PPORD** and covered by **PPORD notification dossier** it should not be included here. If it is not covered by a PPORD notification, it should be reported as part of the total tonnage manufactured or imported and included in the tonnage used for the determination of the information requirements.

#### 8.5.2. Section 3.3 Sites

In this section you can specify the information on your substance manufacture and use sites.


To report the data, click on the button in the navigation panel next to 3.3 Sites and create an endpoint. You can change the name of the endpoint on the top of the endpoint page. You can create several records and each of them must have one of the existing Legal entity owner linked to it.

List all the sites where your legal entity manufactures or uses the registered substance. If the legal entity site is not yet available in the inventory, create a new legal entity site by clicking *Select* in the *Site* field and then *Create* in the pop-up window.

The uses taking place at the site can be specified by linking them using the *Select* button under Manufacture / own use(s). Uses previously created in section 3.5 are displayed and can be selected.

If you indicated in section 1.1 that your *Role in the supply chain* is *Manufacturer*, then you must provide at least one production site in this section. To this end, you must create a record and link it using the field *Related manufacture/own use* to at least one manufacture use in section 3.5.1. For manufacturing sites, the country of the site is normally expected to be the same as the country of the submitting legal entity.

Figure 35: Linking the manufacture use to the manufacturing site



Note that in IUCLID sites are connected to legal entities. If you change the legal entity in section 1.1 Identification of the substance dataset, any site(s) linked in section 3.3 that belonged to that legal entity will be removed from the substance dataset. After changing the legal entity in section 1.1, you need to go to section 3.3 and manually link the appropriate sites of the new legal entity.

#### 8.5.3. Section 3.4 Information on mixtures

This section can be used to report information on mixtures including the substance, which is subject to the registration. To enter your data, you must create a new record for each mixture you wish to report. You can then indicate the information on the mixture such as trade name or the typical concentration of the substance in the mixture.

# 8.5.4. Section 3.5 Use and exposure information relevant for all uses

According to Annex VI section 3.5 of the REACH Regulation, registrants have to provide a brief general description of their identified use(s). This information on manufacture and use of the substance is to be reported in this section.

For substances > 10 t/a and which are meeting the criteria to be classified as hazardous or being considered a PBT/vPvB, an exposure assessment is required to be submitted to ECHA as part of the CSR document (see chapter <u>Assessment reports</u>). You can also report information on the exposure assessment of each of the identified uses here in this section. This option will be

particularly useful if you intend to demonstrate that the uses and the conditions of use of your substance do not give rise to any concern and thus no action by authorities would be needed.

Use and exposure information (including tonnage) is used by Authorities to assess the need for further regulatory actions for a given substance under REACH and to support corresponding priority setting. Having use and exposure information correctly reflected in the registration dossier ensures that decisions can be made on well-founded basis. ECHA advises you to ensure in particular that:

- the uses reported reflect your current supply chain (e.g. ceased uses should not be reported, product categories to reflect the current market);
- each use is correctly assigned to the appropriate life cycle stage;
- tonnage information, if available, is provided (in particular tonnage per use);
- uses having specific regulatory status (e.g. intermediate), uses taking place in a limited number of sites and uses taking place in rigorously contained conditions are reported as explained below.

Note that if Chesar is used for carrying out the CSA, the IUCLID fields for use and exposure information can be directly populated via export from Chesar.


# 8.5.4.1. Overview (section 3.5.0)

In this section you can report use and exposure information that is relevant across all uses.

In the rare case where no uses are reported, select a justification in the field *Justification for no uses reported*. This could be the case if the substance is directly exported or if the registered substance is a monomer in an imported polymer as uses of the polymer do not need to be described unless you are waiving information requirements on the basis of exposure based adaptations (Annex XI).

If no exposure assessment has been performed for any of the uses reported, select the justification in the field *Justification for no exposure assessment*.

Figure 36: Options for justification for no exposure assessment



Note that if you are exempted from performing a CSA by REACH Article 14(2), you should indicate here that no assessment has been performed and you still need to provide information in section 13 of IUCLID (see chapter <u>Assessment reports</u>).

In this section you can also report the cumulative tonnages of the substance in each of the following Life cycle stages: *Uses at industrial site*, *Widespread uses by professional workers*, *Consumer uses* or *Service life*. The overall tonnage per Life cycle stage may be of particular relevance if you want to demonstrate that the amounts ending up in widespread uses and/or articles are very low. Cumulative tonnages can be reported here as ranges in tonnes/year. If the cumulative tonnage represents the EU tonnage for the substance (and not just your own supply chain tonnage), you should select the checkbox *Cumulative EU tonnage* where relevant. Details such as the source of the values reported or the methods used to estimate the volumes can be indicated in the fields *Details on cumulative tonnage*.

Where information on the tonnage for each individual use is available, we advise you to report it in the dedicated fields available in section 3.5, rather than reporting the cumulative tonnage in this section only.

More information on the fields to report tonnage information is available in *Annex 6* Overview of *tonnage fields in IUCLID*.

# 8.5.4.2. Report uses and select regulatory status of each use (sections 3.5.1 to 3.5.6)

You need to describe the identified uses in section 3.5.1. to 3.5.6. For each use, you have to create a record under the corresponding life cycle stage:

- 3.5.1 Manufacture:
- 3.5.2 Formulation or re-packing;
- 3.5.3 Uses at industrial site;
- 3.5.4 Widespread uses by professional workers;
- 3.5.5 Consumer uses;
- 3.5.6 Service life.

Depending on the life cycle stage under which you have created a record, a set of fields will be displayed for describing the use. This set includes general fields (relevant for all life cycle stages) and fields that are specific to the selected life cycle stage.

The current IUCLID manual is meant to provide an overview of the information in this section, for more detailed explanation consult the help system of IUCLID, which provides an explanation of which type of information is expected for each field. To access the field specific help text, click on the question mark icons next to the field headers. Please note that the question mark icon will appear only after you have clicked on the selected field.

To report a new use:

- **Step 1.** Click on the <u>+</u> button corresponding to the relevant life cycle stage where you want to add a new use.
- **Step 2.** Provide an intuitive name for the record by clicking on the field on the top of the record, so that you can easily recognise it later as this name is what is shown in the table of content. This name can be the same as the use name or at least consistent with it.
- **Step 3.** Provide a use name which should be representative for the use, and preferably not too long; in case an exposure assessment is performed, the use name becomes the exposure scenario name in the Chemical Safety Report (CSR) and Exposure Scenario (ES). This is to say that the correspondence between the name of each use reported in section 3.5 of the IUCLID dossier and its corresponding Exposure Scenario in the Chemical Safety Report should be easy to recognise.
- **Step 4.** Report further details in the field *Further description of the [use]* to further explain the process(es) covered by the use, or the type of (sub)product(s) used in the case of a consumer use.
- **Step 5.** Select the *Registration/Notification status for the use* from the picklist. This selection will determine the type of fields provided for entering information, it is therefore **very important to fill it as first**. You will still see the non-relevant fields, visually identified as non-editable.

The Registration/Notification status mainly identifies whether the use belongs to a registration for a substance below 10 tonnes/year or not, whether it is registered according to REACH article 17/18. For uses at industrial sites it also enables to differentiate uses as intermediate. Further explanation on the relevant fields for these three types of registration status is provided in the chapters below.

#### Linking use information

There are a number of relationships (links) among fields which can be reported in a IUCLID dataset: i.) between uses and other information in the dossier, namely the composition and manufacture/use site and ii.) between uses of different life cycle stages.

i. Link between uses and composition and sites

When describing a use, you may link it to a certain composition, reported in section 1.2 of IUCLID under  $Related\ composition(s)$ . This may be particularly relevant if the composition supplied to one use has a hazard profile different from the compositions in other uses e.g. most hazardous compositions are not supplied to consumer uses.

You can also link a use to one of the sites listed in the IUCLID section 3.3. (see chapter <u>Sites</u> for more information).

ii. Link between uses of different life cycle stages

There are several situations where links between uses apply:

- The first situation is when an end use leads to the inclusion of the substance in an article, this use should be linked to the relevant subsequent service life. To enable this linking, select yes in the picklist Subsequent service life relevant for this use to flag whether the substance is included into an article during the use. Then set a link to the relevant subsequent use(s) described in the section 3.5.6 Service life once they have been created;
- The second situation is when the Registration/Notification status of a use at industrial site

has been set to use registered according to REACH Article 17/18, it is possible to link this use to use records in earlier life cycle stages that have led to this intermediate use e.g. previous formulation step. To enable such linking you need to select the checkbox Any precursor use(s) and then select the relevant use(s) as shown in the figure below; the precursor use(s) may be entitled to the same exemptions.

• The third situation is when the use is registered under article 10, and has a particular regulatory status that impacts on the required use and exposure information e.g. the chemical safety assessment of cosmetic uses does not need to address human health. The regulatory status of a *Use at industrial site*, *Use by professional workers* and *Consumer uses* may trigger a related particular status of uses in previous life cycle stages that have led to this use e.g. formulation of the cosmetic use. To enable such linking you need to check the box *Any precursor use(s)* and then select the relevant use(s) at earlier Life cycle stages.

Figure 37: Reporting precursor use(s)



# 8.5.4.3. Describe uses of Article 10 substances for 10 t/a and more

For uses in some life cycle stages, you can select, if applicable, a *Regulatory status* from the picklist and provide a justification in the *Explanation for the regulatory status* field. Otherwise, do not select any item in the picklist *Regulatory status*. Such information will support the authorities deciding on the need/no need for further regulatory action for the use under REACH.


In addition, if your substance is subject to authorisation, you should inform that in the *Regulatory status* field. If the use does not correspond to a lead's supply chain use, then you should not select the tick box *Own supply chain*. The authorisation number should also be provided in the relevant field.

Figure 38: information to be specified for each use when a substance is subject to authorisation



For a use at industrial site, if the *Registration/Notification status* for the use is use as intermediate registered according to REACH Article 10; total tonnage manufactured/imported > = 10 tonnes/year, you need to confirm the intermediate status with providing information under the heading *Relevant chemical reactions and reaction products*. Create one block per chemical reaction in which the substance is involved as intermediate. Create then one block per each product or residue resulting from the chemical reaction.

Figure 39: Describing chemical reaction and its reaction products




Additional information such as schemas or structures can be provided as an attachment in the field *Additional information on chemical reaction*.

#### Describe the use in more detail

A use may consist of one or more contributing activities describing processes, tasks or unit operations. Such contributing activities are to be defined from environmental perspective and from the human health perspective. Each use needs to include as a minimum a *Contributing activity / technique for the environment* and a *Contributing activity / technique for workers or consumers* (depending on the life cycle stage to which the use belongs to). Each contributing activity needs to have as a minimum a use descriptor assigned e.g. PROC, ERC.

**Note:** a use is usually characterised by one (more broad) contributing activity for the environment and a set of contributing activities for workers (defined by tasks) or for consumers (defined by specific product types).

Figure 40: Contributing activities / techniques for environment and workers



Start the description of the use by adding (repeatable) blocks of information for each Contributing activity / technique for the environment:

- Provide a *Name of the activity/technique*, to facilitate the understanding on the process, technique, product or article addressed in this contributing activity. Standard names may be available from downstream sector organisations via use maps. In case an exposure assessment is performed this name also becomes the *contributing scenario name*.
- Select a suitable *Environmental release category (ERC)* from the picklist. Only relevant ERCs for the life cycle stage are available.

**Note** that the ERCs carry intrinsic properties of the use (life cycle stage, indoor or outdoor use) but also information on the technical fate of the substance in the use, whether it will be included in an article matrix or not. Consequently, whenever the uses are described with the *ERC 5*, *ERC 8c* and *ERC 8f*, a Service life use record is required in IUCLID section 3.5.6 (even if the substance transforms during the use, see Q&A 1669 on *When is the description of article service life expected and why?* at <a href="https://echa.europa.eu/support/qas">https://echa.europa.eu/support/qas</a>).

When you describe a **worker use**, complete the description of the use by adding (repeatable) blocks of information for *Contributing activity / technique for worker*:

- Provide a Name of the activity/technique, to facilitate the understanding of the task or
  process step carried out by a worker. Standard names may be available from downstream
  sector organisations via use maps. In case an exposure assessment is performed, this name
  becomes also the contributing scenario name;
- Select a suitable *Process category (PROC)* from the picklist;
- Add further contributing activity/technique for worker if relevant. Note: the same PROC
  may be assigned to more than one activity, if needed. In this case, the contributing activity
  name can provide further specificity.

When you describe a **consumer use** complete the description of the use by adding (repeatable) blocks of information for *Contributing activity / technique for consumers*:

- Provide a Name of the activity/technique, to facilitate the understanding on the type of
  product the consumer uses. Standard names may be available from downstream sector
  organisations via use maps. In case an exposure assessment is performed, this name
  becomes also the contributing scenario name;
- Select a suitable *Product category (PC)* [or suitable *Article Category (AC)* for Service life by consumers] from the picklist;
- Add further contributing activity/technique for consumer if relevant. **Note:** the same PC may be assigned to various (sub)product types. In this case, the contributing activity name can provide further specificity.

Alternatively, you can fill in the *Contributing activity / technique for the environment* and a *Contributing activity /technique for workers or consumers* by importing a pre-filled *CSV* file (see more details in the IUCLID user manual) .

For more information on how to describe a use and the concepts of contributing activity and use descriptors refer to *Guidance on use description* (R.12) and *Guidance Part D: Framework for Exposure Assessment* available at <a href="https://echa.europa.eu/guidance-documents/guidance-on-reach">https://echa.europa.eu/guidance-documents/guidance-on-reach</a>.

Once the use and its contributing activities are defined, further details should be added:

- Provide more information on the market where the use takes place by selecting one (or more if needed) relevant use descriptor(s) in the following fields, where applicable: Product category used, Sector of end use. This information may also be available from downstream user organisations via use maps; Please note that the field Product category used is mandatory for uses reported in sections 3.5.3 Uses at industrial sites and 3.5.4 Widespread uses by professional workers. This rule does not apply for uses as intermediates in section 3.5.3, however in that case the Registration status for the use should be set as 'use as intermediate'.
- If the substance has a particular technical function during a use, select one (or more if needed) entry(ies) in the picklist *Technical function of the substance during use*. If the substance has no specific technical function during this particular use, select *No technical function* which is the last entry in the picklist; The technical function reported needs to be specific to the use described.
- Select Substance supplied to this use in form of: as such or in a mixture.
- Provide, when possible, the Concentration of the substance in the product/mixture supplied for this use for Uses at industrial sites, Widespread uses by professional workers and Consumer uses.

**Note**: the fields for characterising the market *Product Category used* (PC), *Sector of end use* (SU), *Article Category* (AC), the technical function of the substance during use, the form of supply and the relevance of subsequent service life are not available for all life cycle stages, as this information is not always relevant for each stage e.g. *Sector of end use* is not relevant for consumer uses as the "sector" is the general public.

#### Add information on the extent of the use

Information on the extent of the use, such as the tonnage or the number of sites where the substance is used, provides (together with other criteria<sup>11</sup>) an indication on the wide-dispersiveness of the use. For example, uses with low tonnage and/or low number of sites may not be of concern for authorities when prioritising substances for further scrutiny or regulatory action. At the same time, tonnage information is also an input to the environmental exposure assessment.

Quantify the *Tonnage of substance for this use (tonnes/year)* and provide some explanation in the two related fields, enabling the interpretation of the tonnage figure. If the tonnage represents the EU tonnage for the substance (and not just the tonnage from your own supply chain), you should select the checkbox *Total EU tonnage for this use*. Details, such as the source of the values reported or the methods used to estimate the volumes, can be indicated in the fields *Details on tonnage reported*.

If the use only takes place in a limited number of sites in the EU, select the checkbox *Limited* number of sites for this use and provide any justification on why this number is limited in the field *Details on limited number of sites*. This option is only available in the life cycle stages *Formulation* and *Uses at industrial sites*.

You can also provide an indication of the *Number of workers using the substance for this use within EU* for the life cycle stages *Manufacture*, *Formulation*, *Uses at industrial sites* and *Widespread uses by professional workers*.

#### Figure 41: Reporting on the extent of the use



#### Add information on related exposure assessment

Indicate in the field *Related assessment* whether an exposure assessment has been carried out for this use. If an exposure assessment has been carried out, select among the available options whether this assessment:

- is part of the CSR submitted by the lead registrant on behalf of all the co-registrants (joint CSR);
- is part of the CSR submitted by the lead registrant on behalf of all the co-registrants (joint CSR) but it corresponds to a use not relevant to the lead registrant's supply chain; This can only be selected by the lead registrant.
- is only part of your own CSR submitted with your registration dossier. `

If no exposure assessment is carried out for any use, you can flag that under section 3.5.0. Otherwise you should specify *Use not assessed* in the *Related assessment* field for each use.

#### Demonstrate that the use takes place under rigorously contained conditions

You may want to demonstrate that the *use takes place under rigorously contained conditions*, and thus that the potential for exposure is negligible. This may be relevant for adapting information requirements or for convincing authorities that the use is not of priority concern for regulatory action. If you want to make such claim, select the relevant checkboxes:

- Rigorously contained system with strict control for manual interventions;
- Rigorously contained system with minimisation of release to the environment.

You can then describe the *non-technical means for strict control* (measures supporting the implementation of the rigorously contained system which are related to non-technical aspects such as management controls, monitoring and procedures).

Describe the *technologies to minimise emissions* and the *technical means for rigorous containment* in each contributing scenario as they may be specific to each activity (see section below).

# Particular information only relevant for uses under life cycle stage Service life

For uses reported under service life (section 3.5.6) the following particularities exist:

• In the field *Article used by* you need to specify whether the use describes the use of articles by workers or by consumers. Depending on this choice the use description fields

- are displayed with different options e.g. if article is used by workers, the relevant use descriptor for the contributing activity is the PROC;
- You also need to flag whether the Substance is intended to be released from articles. "Intended" means that it is not only foreseeable, but also that the release is intended to deliver the technical function of the substance during the use.
- Provide, when possible, the Concentration of the substance once included in the article as well as an Explanation on low concentration when relevant.

# 8.5.4.4. Provide exposure information for Article 10 substances > 10 t/a

#### General structure of exposure information

If the use is subject to **exposure assessment**, information on conditions of use and the related release/exposure estimates can be reported for each contributing activity. This information should correspond to a risk characterisation concluding that the risks resulting from the use are adequately controlled.

#### Notes:

- This manual does not provide support on how to perform a chemical safety assessment, but rather how to report the outcome of it. For more information on CSA, please refer to the guidance: <a href="https://echa.europa.eu/guidance-documents/guidance-on-information-requirements-and-chemical-safety-assessment">https://echa.europa.eu/guidance-documents/guidance-on-information-requirements-and-chemical-safety-assessment</a>
- The risk characterisation itself as documented in the CSR is not reported in IUCLID.

There are two Contributing Scenarios available for each use:

- Contributing scenario for the environment (related to workers [consumers] activities) for reporting the conditions of use driving the release to the environment during a use by workers [consumers];
- Contributing scenario for the workers [consumers] for reporting the conditions of use driving the direct exposure of workers [consumers].

Figure 42: Contributing scenarios for workers





Figure 43: Contributing scenarios for consumers



Create a Contributing scenario for the environment (related to workers [consumer] activities) under the relevant heading by clicking the New item button. Link to the corresponding contributing activity to which this contributing scenario refers to by clicking on the Linked contributing activity field selecting among the previously defined contributing activities for environment.

Create also a *Contributing scenario for the workers* [consumers] under the relevant heading by clicking the *New item* button. Link with the contributing activity to which this contributing scenario refers to by clicking on the *Linked contributing activity* field and selecting among the previously defined contributing activities for workers [consumers]. Repeat the operation to create as many contributing scenarios as needed.


Each of the contributing scenarios consists of different parts such as the conditions of use (operational conditions or risk management measures), the related releases (environment) and the exposure estimates.

A few conditions of use are pre-defined (fixed) e.g. *Percentage* (*w*/*w*) of substance in the *mixture*/article, or *Place of use* so that you can only select among or insert some relevant values. If there are other relevant conditions of use you need to define them by yourself, or report them as documented in sector use maps and/or in the exposure estimation tools you apply.

The conditions of use are grouped under fixed subheadings. For more explanation on these sub headings consult the *Guidance Part D: Framework for Exposure Assessment* available at <a href="https://echa.europa.eu/guidance-documents/guidance-on-reach">https://echa.europa.eu/guidance-documents/guidance-on-reach</a>.

Where the pre-defined conditions are listed under a subheading, usually also a field *Other conditions* is available to allow you to report as many relevant conditions of use as relevant for your assessment. IUCLID provides you with repeatable blocks of information for that.


Figure 44: Example of section to report other conditions of use not suitable to report elsewhere



For all the *conditions of use* a field *Additional details* is available. Here you can enter explanation to assist the recipient of the dossier (e.g. ECHA) in understanding the information provided.

For risk management measures (i.e. conditions of use aiming to limit release/exposure) the effectiveness of the measure (i.e. reduction of release/exposure in %) and the route of release/exposure affected by the measure as well as some explanations can be reported.

Figure 45: Reporting effectiveness of a measure for a particular exposure route



The release to the environment and the corresponding exposure estimates are to be reported per release route and per subsequently exposed compartment. For each estimate the applied method and tool used should be selected.

When a substance consists of various constituents, forms, or transformation products occur during use, the release or exposure estimates may be related to certain constituents or transformation products. If relevant for the assessment, link the release and/or exposure dataset to a certain assessment entity (see chapter <u>Assessment approach (assessment entities)</u> via the field <u>Exposure related to</u>.

For more information on exposure assessment, please refer to Guidance on information requirements and chemical safety assessment part D at <a href="https://echa.europa.eu/guidance-documents/guidance-on-reach">https://echa.europa.eu/guidance-on-reach</a>.

The next sections explain in more detail how to report exposure information such as conditions of use, releases or exposure estimates.

# Conditions of use driving the environmental release

**Note:** The type of conditions driving the environmental release are different between workers and consumers. *Technical and organisational conditions and measures* limiting releases to the environment are usually not available for consumer uses. The same applies for particular *conditions and measures related to Biological Sewage Treatment Plant*. Therefore, the corresponding sub-headlines or pre-defined conditions are not displayed for consumer uses.

Report *Product (article) characteristics* having an impact on environmental releases. Information to be reported here includes concentration of the substance in the product used, package design affecting releases, etc. Create a block by clicking *New item* for each of the *Product (article) characteristics*, provide a short description in the corresponding field and give any additional details in the *Additional details* field.

Report Amounts used (or contained in articles), frequency and duration of use/exposure: The


Daily [annual] use amount at a site is the highest amount of substance used in a day [year] at a generic site (industrial site or standard town with 10,000 inhabitants for widespread uses by workers or consumers). Together with the emission factors, they determine the release rate to the local [regional] environment. You can also indicate the *Number of emission days*. Note that you should always provide an explanation on how the number of emission days is taken into account in the assessment.

Report the *Technical and organisational conditions and measures* limiting or minimising releases to the environment by clicking *New item*. This should include i) any process design and/or organisation that has an impact on environmental releases and ii) any treatment of exhaust air, waste water or waste before release, except for Biological waste water treatment (which is reported in a section on its own).

If you claim the use to take place under strictly controlled conditions (checkbox *Rigorously contained system with minimisation of releases* selected) you need to describe the process design and integrated measures, including containment in the field *Technologies to minimise emissions*. To activate this field click on *New item* under the heading *Technical and organisational conditions and measures*.


The field *Additional information* related to the *Technologies minimising emissions* provides an opportunity for an attachment (e.g. to report process schemes).

Otherwise, add your information in *Other technical and organisational conditions*. In this block any measure to control release except for those related to biological sewage treatment can be reported including its effectiveness on one or more routes.

Figure 47: Reporting other technical and organisational conditions



Report Conditions and measures related to Biological Sewage Treatment Plant. In this set of predefined fields you can report the relevant information from your assessment regarding the biological waste water treatment.

Report Conditions and measures related to external treatment of waste (including article waste): You can provide any particular considerations on the waste treatment operations by selecting among the options in the picklist. If the substance properties and/or the use pattern do not call for a particular assessment of the waste life stage, select *no*, and explain the reasoning in *Details on waste treatment*. Examples for such reasoning can be found in the *Guidance on environmental assessment* R.16 available at <a href="https://echa.europa.eu/guidance-documents/guidance-on-information-requirements-and-chemical-safety-assessment">https://echa.europa.eu/guidance-documents/guidance-on-information-requirements-and-chemical-safety-assessment</a>.

Report any *Other conditions of use affecting environmental exposure* that do not fit under any of the fixed subheadings. This section includes two pre-defined conditions: *Place of use* (indoor or outdoor with implications on potential direct release to soil or water) and the *receiving surface water flow rate* (which may be set to a site-specific value if relevant for the assessment).

#### **Environmental release and exposure**

Report the *Releases to waste and the environment* predicted or measured for the reported conditions of use. Click on *New item* to open a repeatable block. When a substance consists of various constituents or forms transformation products during use, the release may be related to certain constituents or transformation products. If relevant for the assessment, link the release dataset to the previously defined assessment entity to which the releases relate to via the field *Release related to*.

Report the *Release to the environment* for each release route separately by clicking on the *New item* button under the *Release to the environment* heading. Start with selecting a release route in the field *Release from site to* and then enter the relevant information in the pre-defined fields. Alternatively, you can fill in the fields by uploading a CSV file. **Note:** The *Release factor from site after on-site risk management* refers to releases before biological sewage treatment (regardless whether this takes place onsite or in the municipal STP). Repeat the reporting for each relevant release route.

Report the *Release to external waste*. Report the *Release factor to external waste*. This is the percentage of the use amount leaving the site as waste for external treatment (disposal or recovery). This figure is, together with other information, the basis for determining whether a particular assessment for the waste life stage is required.

Report the Exposure of the environment. When a substance consists of various constituents,

forms, or transformation products occur during use, link the exposure dataset to the previously defined assessment entity to which the exposure relates to via the field *Exposure related to* as explained for the release.

Report the *Exposure to the environment* for each compartment separately. Start with clicking on the *New item* button next to the field *Predicted exposure concentration* and then selecting the *Exposed compartment*. Then enter the *predicted exposure concentration*, select the correct *unit* and provide information related to the *exposure estimation method*. This may include attaching documents such as export files of exposure estimation tools<sup>12</sup>. For measured exposure the number of measured points, standard deviation and reliability scores should be provided in the relevant fields. Repeat the reporting for each relevant compartment. Alternatively, you can fill in the fields by uploading a CSV file.

Report Exposure of humans via the environment. When relevant, link the exposure data-set to the previously defined assessment entity to which the exposure relates to via the field Exposure related to as for the exposure to the environment. Enter a value for the daily intake via food consumption and select the right unit. For each estimate, the applied method/tool used should be selected.

#### Conditions of use related to workers activities driving human exposure

Report the relevant *Product (article) characteristics* having an impact on workers' exposure. This includes the *Percentage (w/w) of the substance in the mixture/article*, and the *Physical form of the used product* during the contributing activity. If the used mixture is *solid*, select the relevant level of dustiness from the picklist in the field *Physical form of the used product*. Note: The form of the used product is not necessarily identical with the physical state of the substance as derived from manufacture (e.g. solid substances may be dissolved or dispersed in liquids). Also, forms may change during use, and this may significantly have an impact on the exposure (e.g. milling of granules into powder).

Report Amounts used (or contained in articles) frequency and duration of use/exposure. This includes the duration of each contributing activity (in hours/day) as assumed for the exposure estimate and risk characterisation. If this duration is shorter than 8h, you may provide under Details on duration of activity whether the shorter duration is required to control risks for a worker.

Report the *Technical and organisational conditions and measures* limiting or minimising exposure to workers:

- If you claim the use to take place under strictly controlled conditions (check box Rigorously contained system with strict control for manual intervention selected) you need to describe how the technical equipment ensures rigorous containment. Provide this information in the field Technical means for rigorous containment and strict control for manual intervention. The field Additional details provides an opportunity for supporting information.
- Otherwise, report under the heading *Technical and organisational conditions and measures*, any process design or engineering controls having an impact on workers' exposure e.g. local exhaust ventilation, technical barriers for dermal protection, etc. The organisational measures that support the implementation of these technical measures should be described here as well e.g. maintenance of the equipment.

Report Conditions and measures related to personal protection, hygiene and health evaluation, such as respiratory protective equipment or dermal protective equipment. The organisational measures necessary to achieve the reported effectiveness when using the protective equipment

should be described as well e.g. training.

Report Other conditions affecting workers exposure. This includes two pre-defined conditions The Place of use (indoor, outdoor) and the operating temperature.

# Conditions of use related to consumers activities driving human exposure

Report *Product (article) characteristics* having an impact on consumers' exposure. This includes the *Percentage (w/w) of the substance in the mixture/article*, and the physical form of the used product during the contributing activity. If the used mixture is *solid*, select the relevant level of dustiness from the picklist in the field *Physical form of the used product*. Note: The form of the used product is not necessarily identical with the physical state of the substance as derived from manufacture (e.g. solid substances may be dissolved or dispersed in liquids).

Report Amounts used (or contained in articles) frequency and duration of use/exposure. This may include the amount of product used per event, the duration of exposure event or the frequency of use.

Report *Information and behavioural advice for consumers*, required to ensure safe use. This includes for example instructions on safe use and in very exceptional cases also personal protective measures.

Report *Other conditions affecting consumers exposure*. These can include information on the place of use (indoor/outdoor), or room size assumed in the assessment.

#### **Exposure of workers or consumers**

Report the *Exposure of workers* or *consumers* predicted or measured for the reported conditions of use.

When a substance consists of various constituents, forms, or transformation products occur during use, the exposure may be related to certain of these constituents or transformation products. If relevant for the assessment, link the exposure data-set to the previously defined assessment entity to which the exposure relates to via the field *Exposure related to*.

Report the *Exposure estimation* for each *type of exposure* separately by creating several blocks. To create a block click on *New item*. Start with selecting a *Type of exposure*, enter the *Exposure estimate* and select the correct unit and provide information on the method/tool used to generate the exposure estimation in the field *Exposure estimation method*.

For measured exposure estimates the *number of measured data points, geometric standard deviation* and *reliability scores of measured data set* should be provided in the relevant fields.

# 8.5.4.5. Describe uses for Article 10 substances below 10 t/a

For substances manufactured or imported up to a volume of 10 tonnes per year a few particularities apply regarding the reporting of use and exposure information. Otherwise follow the explanation in section above (Describe uses for Article 10 substances above 10 t/a).

- There is no need to indicate the *related assessment* as no exposure assessment is required in this tonnage band. This should be indicated in section 3.5.0 in the field *Justification for no exposure assessment*.
- You can demonstrate that a use takes place under rigorously contained conditions, by filling in the three text-fields are available in the use description: Description of nontechnical means for strict controls, Technologies to minimise emissions, Technical means

- for rigorous containment and strict control for manual intervention. This may be relevant for convincing authorities that the use is not of priority concern for regulatory action.
- To claim that exposure via one or more routes of release/exposure is insignificant, a set of particular fields is available for this tonnage band: *Insignificant exposure via the following route* and *Insignificant release via the following route*. These fields can be used both when a substance is not used under rigorous containment, but nevertheless you consider the exposure is negligible for other reasons, or to provide quantification of residual releases in case of use in rigorous containment. In this case, select for which route(s) insignificant exposure (or release) is expected for this use. Provide explanations supporting the selection in the subsequent field.

# 8.5.4.6. Describe uses for Article 17/18 intermediates

An intermediate substance under REACH is a substance that is manufactured/imported for and consumed in chemical processing, in order to be transformed into another substance. Intermediates being manufactured and used under strictly controlled conditions can benefit from a particular registration regime as described in REACH Article 17 and 18.


For uses with a **Registration/Notification status** for the use registered according to REACH Article 17/18, information needs to be given to support both the intermediate status (details on chemical reactions and reaction products) as well as to support the strictly controlled conditions. Note that you can only claim the status of intermediates for uses of the registered substance in the life cycles that describe the manufacture (if your registration covers the manufacture of the intermediate substance), the formulation or re-packing of the intermediate (if such activity takes place) and the chemical process where the substance is transformed into another substance. These uses should be reported in IUCLID sections:

- 3.5.1 Manufacture
- 3.5.2 Formulation on re-packaging
- 3.5.3 Uses at industrial sites

In addition, for uses at industrial sites, a checkbox appears to give the possibility to further specify the type of intermediate registration. Select the checkbox if the use is *Use as on-site isolated intermediate registered according to REACH Article 17(3)*. This is important as on-site intermediates are exempted from Evaluation and Authorisation.


- **Step 1.** Confirm the intermediate status by providing information under the heading *Relevant* chemical reactions and reaction products. Create one block per chemical reaction in which the substance is involved as intermediate by clicking on *New item*.
- **Step 2.** Create also one block per product or residue resulting from the chemical reaction. Additional information such as schemas or structures can be provided as an attachment in the field *Additional information on chemical reaction*.

Figure 48: Describing chemical reaction and its reaction products



**Step 3.** For all uses registered under Article 17/18 you may define the *Contributing activities/techniques for workers* to describe which activities take place with the substance. This will be useful to confirm the fact that the use takes place under strictly controlled conditions. Describing the contributing activities includes giving the activity an intuitive name and assigning a suitable process category (PROC).

Figure 49: Defining contributing activities techniques for workers



**Step 4.** You may also specify the sector of industry (*Sector of end use*) in which the intermediate is used.

**Note:** This would be usually a sector where manufacturing of substances takes place. If not, please cross check whether your substance indeed fulfils the criteria for being treated under REACH as an intermediate.

- **Step 5.** Select whether the substance is supplied: as such or in a mixture under Substance supplied to that use in form of.
- **Step 6.** Quantify the *Tonnage of substance for this use* and provide some explanation in the related field enabling the interpretation of the tonnage figure. If the tonnage represents the EU tonnage for the substance (and not just your own individual tonnage), you should select the checkbox *Total EU tonnage for this use*. Details such as the source of the values reported or the methods used to estimate the volumes can be indicated in the field *Details on tonnage reported*.
- **Step 7.** Next, you need to describe the strictly controlled conditions for both the conditions at workplace and the conditions related to environmental release. This information is to be entered under the header *Use takes place under rigorously contained conditions*. For the *Technical means for rigorous containment including strict control for manual intervention* provide such descriptions per process step or task.
- **Step 8.** You may want to provide some additional information supporting the description in the textboxes (e.g. graphical schemes, flow charts). You can attach documents in the field *Additional information on the conditions of strict control*.
- **Step 9.** Finally, you should provide *Contact details of the downstream users*, who have confirmed intermediate use and strictly controlled conditions to you under Article 18.4, unless you have already described their uses and conditions in the following fields:
  - Chemical reactions and reaction products;
  - Use takes place under rigorously contained conditions.

#### 8.5.5. Section 3.6 Uses advised against

According to Annex VI section 3.7 of the REACH Regulation, registrants have to provide information of their uses advised against.

If no uses advised against have been identified then you should not enter any information in this section.


If you have identified use(s) advised against, then you must add a record for each use advised against in the corresponding life cycle stage subsections:

- 3.6.1 Formulation or re-packing advised against;
- 3.6.2 Uses at industrial sites advised against;
- 3.6.3 Widespread uses by professional workers advised against;
- 3.6.4 Consumer uses advised against;
- 3.6.5 Service life advised against.

The fields in this section are similar to the ones described above for other uses, however the number of fields is lower to report uses in this section. Please refer to the explanations above and IUCLID for support.

Registrants should also report the justification why the use(s) are advised against. Provide such justification in the *Remarks* field per use. Additional details can be provided as an attachment by clicking on the paperclip icon displayed on the top right corner of the record.

# 8.5.6. Section 3.7 Environmental assessment from aggregated sources

This section is to report exposures aggregated from the different life cycle stages. The regional exposure consists in the background exposure when taking into account all sources, i.e. all uses in all the life cycle stages. The combined widespread exposure relates to a predicted exposure concentration in a local environment (standard municipal town) when releases from all widespread uses, i.e. consumers uses and uses widespread uses by professionals as well as service life, are taken into account. For more information refer to <u>Guidance R16</u>.

You have to create a record for reporting this information. You may have to create several records if:

- You have created assessment entities for your assessment (see <u>section 8.3.9</u>). In this
  case, make a reference to the relevant assessment entity in the field *Exposure related to*(select an assessment entity if relevant);
- You are the lead and you are submitting two CSRs: one joint CSR covering part of the uses in the joint registration and one CSR for your own uses not covered by the joint CSR. In this case select whether the values are corresponding to your own CSA or the joint CSA in the *field Exposure related to (select a CSA type if relevant)*.

Report the *Total Releases* to water, air and soil. They correspond to the releases from all the uses at the regional scale, before biological sewage treatment is applied, as this corresponds to a standard output of an environmental assessment using the release estimation tool EUSES.

Report then the Predicted Exposure Concentrations *(PEC)* regional for each compartment in the subsequent fields. For each PEC, indicate which method has been used to estimate this value.

At the end, report the PECs for water and soil obtained when combining the local releases from all widespread uses.

# 8.6. Sections 4, 5, 6, 7 and 8 - Endpoint sections

This chapter guides you through the most relevant aspects of filling in sections 4 to 8. You will find here instructions on how to enter information for the scientific studies carried out following Annexes VII to X (and their adaptations according to Annex XI) of the REACH Regulation, into the sections 4 to 8 of IUCLID:

- **Section 4** Physico-chemical properties;
- Section 5 Environmental fate and pathways;
- **Section 6** Ecotoxicological information;
- **Section 7** *Toxicological information;*
- Section 8 Analytical methods.

#### **Further information**

#### **8.6.1. Concepts**

REACH prescribes that the registration dossier must contain, in the form of study summaries or robust study summaries, the physicochemical, ecotoxicological and toxicological information that results from the application of Annexes VII-X, as well as all relevant available information. In IUCLID, (robust) study summaries are reported in electronic formats called endpoint study records, which are based on the harmonised templates developed by the OECD. The following concepts will be used throughout this chapter:

Robust study summary (RSS)13

A robust study summary is a detailed summary of the objectives, methods, results and conclusions of a full study report providing sufficient information to make an independent assessment of the study, minimising the need to consult the full study report.

Study summary 14

A study summary is a summary of the objectives, methods, results and conclusions of a full study report providing sufficient information to make an assessment of the relevance of the study.

Endpoint study record



An endpoint study record is a IUCLID document that stores the information from a robust study summary or study summary, or the proposal or waiving of a test.

Endpoint summary [2]



An endpoint summary is the IUCLID document that summarises the information from endpoint study records to give an appraisal of all data compiled in a given endpoint section.

# 8.6.2. How to complete endpoint study records

The IUCLID endpoint study records provide a structured way to fill in the information for each endpoint. Depending on the approach chosen to fulfil the information requirements under REACH Annexes VII-X, and the available data, different parts of the endpoint study record may be relevant. As a starting point, three types of approaches can be identified:

Study, including alternative methods: The information requirement is fulfilled by one or more study summaries or robust study summaries that either directly or indirectly (through an adaptation) provide information on the endpoint.

Testing proposal: For studies required under REACH Annexes IX and X, a testing proposal must be submitted if a valid test result is not available and no adaptation method applies. Whenever testing proposals on vertebrate animals are submitted, to demonstrate the use of animal testing as a last resort, the considerations for adaptations according to Column 2 of the REACH Annexes on information requirements, and Annex XI must be provided.

Data waiving: For studies that have been waived according to the specific rules for adaptation in Annexes VII-X, columns 1 and 2 or Annex XI, sections 2 and 3 principles. Data waiving usually relates to a property of the substance, or its use and exposure information, that should be demonstrated in the same or a different section of the registration dossier. It is not enough to refer in your data waiving justification to information provided elsewhere in the dossier. The main argument of your justification for data waiving must be reported in the field Justification for data waiving. Additional information can be reported in the field Justification for type of information.

Each information requirement must be fulfilled by one of the above approaches. Table 3 shows the relevant parts of the endpoint study record that need to be filled in for each approach.

Each endpoint study record must correspond to exactly one of the above approaches; it is not possible to combine several approaches in one record.

#### 8.6.2.1. Administrative data

The Administrative data section of the endpoint study record is used to summarise the purpose of the record – whether it contains information from a study, it is a testing proposal or data waiving – and the main contextual information for the chosen approach. Table 4 shows the fields in the Administrative data section and their relevance to the approaches outlined in Table 3.

Conditional formatting of the fields will prevent major inconsistencies; e.g. if the endpoint study record has been indicated as a study, the fields for reporting data waiving become inactive.

#### **Endpoint**

For all endpoint study records created, whether they represent study summaries, data waiving or testing proposals, you must indicate the *Endpoint* that is addressed. Several IUCLID sections cover more than one information requirement under REACH; this field allows you to refer to the specific information requirement in the REACH Annexes.

## Type of information

The field *Type of information* is used to specify what kind of information the (robust) study summary reported in the endpoint study record is based on: experimental data, read-across, weight of evidence justification/conclusion or QSAR, for example. The field is also used to indicate if the endpoint study record refers to a testing proposal, for which you should select *experimental study planned* or *experimental study planned* (based on read-across), as appropriate.

#### Adequacy of study

Use the picklist field *Adequacy of study* to indicate how the (robust) study summary reported in the endpoint study record is used to fulfil the information requirements for the registered substance and the subsequent hazard assessment. To do this, select one of the following:

- key study is a study that has been identified as most suitable to describe an endpoint from the perspective of quality, completeness and representativeness of data. A key study is expected to correspond to a robust study summary that is used in the hazard assessment. When several results are available for a given information requirement there can also be several key studies. For substances with more than one study available, the study/ies giving rise to the highest concern should normally be used as the key study/ies for the assessment of the substance. In case another study is used as key study the reasons should be clearly documented (see selection disregarded due to major methodological deficiencies).
- *supporting study* provides some additional information to support the conclusions from the key study/ies.
- weight of evidence is selected to indicate that an endpoint study record contributes to a weight of evidence approach. A weight of evidence approach relies on the submission of multiple endpoint study records for the same endpoint. Using the weight of evidence implies that no single study of sufficient quality and reliability exists and that information from several independent sources is required to conclude on a particular property of the substance. Short reasoning for why a given record is used in this respect can be provided in the field Justification for type of information. When using a weight of evidence approach you should provide, as a minimum, two separate endpoint study records for an endpoint (REACH Annex XI, 1.2). In addition, one endpoint study record (per weight of evidence approach) with the Type of information set to 'weight of evidence justification/conclusion' must be provided (see section Justification for type of information).

- disregarded due to major methodological deficiencies is a study that demonstrates a
  higher concern than the key study/ies but is not used as key study because of flaws in
  the methodology or documentation. This picklist value should be selected for justifying
  why a potentially critical result has not been used for the hazard assessment. The lines
  of argumentation should be provided in field Rationale for reliability incl. deficiencies,
  accompanied by the appropriate reliability score.
- other information is other available information which does not directly contribute to the conclusions for the endpoint, and which does not fall under the criteria for disregarded due to major methodological deficiencies, e.g. because the disregarded study does not demonstrate a higher concern that the key study/ies.

All endpoint study records in sections corresponding to the REACH Annexes that are indicated as key study or as weight of evidence are subject to a full completeness check. Other types of study summaries should be filled in as much as possible to support the assessment of the endpoint.

#### Reliability and Rationale for reliability incl. deficiencies

Indicate in the field *Reliability* the reliability score for the (robust) study summary reported in the endpoint, and support the selection by providing the rationale for reliability in the field *Rationale for reliability incl. deficiencies*.

#### Data waiving

If you waive the information requirement according to the provisions of REACH Annexes VII-X (columns 1 or 2) or Annex XI (sections 2 or 3), you must indicate this in the field *Data waiving*.

Select the reason for waiving from the picklist, e.g. study technically not feasible when the nature of the substance does not allow it to be tested for that endpoint; or study scientifically not necessary / other information available when information exists that suggest that the study is not needed/relevant.

In the picklist field *Justification for data waiving* provide a detailed justification for why the study was not performed. The picklist contains standard phrases to justify data waiving, which are endpoint-specific and mostly based on the specific rules of column 2 under REACH Annexes VII-X. The availability of standard phrases does not mean that a data waiving justification in the picklist is necessarily applicable to your substance. The phrases are provided to assist you in documenting your decision. It is always up to the registrant to analyse their situation and decide whether waiving is applicable.

If you consider that data waiving is possible for a certain information requirement, but a suitable standard phrase is not available, select the option *other*: from the *Justification for data waiving* picklist. When choosing this option, ensure to clearly document the main basis for waiving in accordance with the REACH regulation in the below free text field named '*Other*'. Additional information can be provided in the *Remark* field. See the picture below.

If you intend to waive based on Annex XI, section 2 (testing is technically not possible), the omission of testing should be thoroughly justified and the technical limitations explained in the field *Justification for data waiving* under the picklist option *other:*. The data waiving justification needs to include the test method that has been attempted and the property of the substance that has impeded the testing. This property must be relevant for the endpoint.

# Justification for type of information

Use the field *Justification for type of information* and the subsequent *Attached justification* field to store documentation specifically relevant for the type of information provided. The field provides free text templates that help the user in addressing the relevant points. In particular, the field is expected to be populated when the *Type of information* of the endpoint study record is the following:

- experimental study planned: in the case of proposing a test on vertebrates, mandatory considerations for adaptation possibilities. Note that this information will always be published.
- experimental study planned (based on read-across): endpoint-specific documentation on the read-across approach.
- (Q)SAR: endpoint-specific documentation on the prediction.
- read-across based on grouping of substances (category approach): endpoint-specific documentation on the read-across approach.
- read-across from supporting substance (structural analogue or surrogate): endpointspecific documentation on the read-across approach.
- weight of evidence justification/conclusion: endpoint-specific documentation on the weight of evidence approach.

In addition, for an endpoint study record where *Adequacy of study* has been set to *weight of evidence*, a short reasoning for why the record is relevant for this can be provided in this field.

# Cross-reference

Use the table *Cross reference* to link the endpoint study record to other records in the same IUCLID section, or to other sections that belong to the same dataset. For example, use the field:

in a data waiving record to refer to the endpoint study record which provides the relevant

information that is used as a basis for the data waiving (Data waiving: *study scientifically not necessary / other information available*). Note that the main argument of a data waiving must be reported in the field *Justification for data waiving* in the IUCLID section that is being waived.

- to link a read-across target record to the source record (Type of information: read-across from supporting substance (structural analogue or surrogate), see chapter <u>How to report read-across in IUCLID</u>).
- in a record marked as weight of evidence justification/conclusion in the field Type of information: to link weight of evidence source records that contribute to the conclusion of the weight of evidence approach.

# The following basic conventions apply when completing endpoint studies provided under the REACH Annexes VII to XI:

- Each requirement indicated in columns 1 of REACH Annexes VII-X must correspond to at least one complete endpoint study record in IUCLID;
- If no data waiving, no testing proposal, no key study and no weight of evidence study are provided for a required endpoint, then the endpoint will be considered as incomplete;
- All data waiving, testing proposals, weight of evidence and key studies must be complete. As a consequence, if there is more than one key study or weight of evidence record per endpoint then all of these records must be complete; this applies even if the endpoint is not required for that Annex;
- It is not possible to combine several approaches in one record. An endpoint study record cannot be at the same time a data waiving, a testing proposal and/or a study summary.

#### 8.6.2.2. Data source

The Data source part of the endpoint study record captures information on the bibliographic reference of the data and on the data access (see also chapter <u>Literature reference</u>).

#### Reference

To insert a Reference, click on the Reference field and then click the button Select.

- i. This action will open a dialogue window, where you can search for existing references in your IUCLID database by entering search criteria, such as Author or Report date, in the open dialogue or by typing at least three characters in the search field. Select the relevant reference in the list of search results.
- ii. Alternatively, you can create a new reference by clicking the *Create* button at the top of the window, entering the information and clicking *Save*.

Ensure to provide sufficient information about the reference to enable it to be verified.

#### Data access

Use the field *Data access* to indicate your right to use the provided study information; e.g. whether you are the data owner, or you have a Letter of Access to the information. If you select data submitter has permission to refer, then you must provide in the *Remark* field below the statement according to instructions you received from ECHA together with the permission to refer.

#### 8.6.2.3. Materials and methods

The information on the materials and methods is relevant for (robust) study summaries and testing proposals.

# Test guideline

Both for endpoint study records that represent (robust) study summaries and testing proposals, the test guideline (to be) used in the study must be indicated in the *Guideline* field under the table *Test guideline*. If no test guideline can be specified (e.g. because the study is a non-guideline study, or (Q)SAR was applied), or if you deviate from the indicated guideline, a description of the principles of the test protocol or the method must be provided in the field *Principles of method if other than guideline*. Templates are available to support entering the information.

# **GLP** compliance

For the endpoint study records that have the *Type of information* indicated as experimental study in sections 5 *Environmental fate and pathways*, 6 *Ecotoxicological information* and 7 *Toxicological information*, it must be indicated whether the study is compliant or not with the principles of Good Laboratory Practice (GLP) provided for in Directive 2004/10/EC. This is done by selecting one of the following options: *yes (incl. QA statement)*, *yes*, *no* or *not specified* from the picklist *GLP compliance*.

Note that according to REACH Article 13(4), ecotoxicological and toxicological tests performed after 1 June 2008 for REACH purposes should be carried out in compliance with GLP.

For each endpoint study record where the study has been indicated as GLP compliant, the contact details of the testing laboratory must be provided. Therefore at least one entry under *Reference* under *Data source* heading must contain information on the name, address and country in the *Testing facility* field.

Type of method, Test type, Type of study, Type of assay, Type of study / information, Application method, (section-dependent)

Report in these fields the specific type of method used, or test performed.

#### 8.6.2.3.1. Test material

The fields below the sub-heading *Test material* are relevant for endpoint study records that represent (robust) study summaries and testing proposals.

The field *Test material information* is a link field where a test material corresponding to the test material that was used in the study is linked (or is planned to be used in a proposed study). (see

chapter Test material).

The information provided in the test material record should cover the test material as it was used in the study as starting material for the test system, prior to any preparatory steps to convert it to the form actually used in the experiment. For the purposes of each experiment, the test material may have been further processed before used or administered to test animals. The details of this further processing are study specific and should therefore be given in the corresponding endpoint study record, in the field *Specific details on test material used for the study* or the relevant fields related to study design.

To link a test material information record:

Click the button Select in the Test material information field.

- i. This action will open a dialogue window, where you can search for existing test material records in your IUCLID database by entering search criteria or by typing at least three characters in the search field. Select the relevant test material information record in the list of search results.
- ii. Alternatively, you can create a new test material information record by clicking the *Create* button at the top of the window, entering the information and clicking *Save*.

The test material record consists of a table in which to report the composition of the test material by using linked reference substances and concentration range fields. It also contains fields to report the test material form, and the details on the test material.

The test material should be reported to the level of detail available and relevant; however as a minimum, at least one constituent must be provided by linking a reference substance containing standard identifiers (EC, CAS and/or IUPAC).

- For an *experimental robust study summary*, it is expected that detailed compositional information on the test material exists and is provided, while for a *study summary based* on handbook information, less details on the test material may be available.
- When reporting the results for a QSAR study, the test material should correspond to the structure for which the prediction was made. QSAR predictions are typically made with discrete molecular structures and hence there is no need to define the concentration range. Instead, the registrant may indicate in the field Composition / purity: other information that the purity concept is not applicable for an in silico study. Moreover, in the case of QSAR studies typically only one reference substance would be expected to be linked to the test material. This reference substance should contain the SMILES notation or InChl with which the prediction was carried out.
- For a read-across target record (see chapter <u>How to report read-across in IUCLID</u>), the test material should refer to the target of the read-across approach (i.e, the registered substance). The experimentally tested material(s) should be identified in the source study summary record (analogue) or in the category member substance records (category).
- For a record corresponding to a testing proposal the test material should be identified to the extent known.

It is important to note that any deviations in the test material from the registered substance should be listed (e.g. different amount of impurities) and all possible effects that such a deviation may have on the obtained test results should be analysed and reported under the *Overall remarks*, attachments heading of the endpoint study record.

Use the field *Specific details on test material used for the study* to report any study-specific information on the test material, such as the batch number and treatment of the test material prior to testing.

Use the field *Specific details on test material used for the study (confidential)* to report any confidential study-specific information on the test material.

Provide all available information on the study design, test animals, test systems and other subheadings of the *Materials and methods* section.

#### 8.6.2.4. Results and discussions

The Results and discussion part must be filled in for all endpoint study records that correspond to a (robust) study summary. The structure of the results part varies depending on the endpoint section; in general it consists of one or more tables where the results are summarised, together with fields that capture other observations related to the particular endpoint.

You must always fill in the results table. The minimum fields required for each section can be seen in *Annex 2. Overview of the completeness check performed by ECHA on the submitted dossiers*, of this manual. Whenever a result was determined in the test, this must be provided, together with the relevant information on the parameters and test conditions, such as pH and temperature. When the test was performed (i.e. the information requirement was not waived), but a result could not be determined, this must be explained in the field *Remarks on result*. The fields can also be filled by importing a CSV file.

Figure 52: Example of filling in results table for flammable solids in section 4.13 – Flammability, when a result was determined in the test





Figure 53: Example of filling in results table for flammable solids in section 4.13 – Flammability, when no result could be determined in the test



Report in the field *Any other information on results incl. tables* any further information on the results, e.g. the individual measurements behind the reported key result, and when relevant, any concentration/dose response relationship.

All results of the study are to be provided under *Results and discussion* heading. The information should not include interpretation of the obtained results, or analysis for the purposes of classification etc.

#### 8.6.2.5. Overall remarks, attachments

Under this heading, provide the interpretation or analysis of the obtained results, e.g. due to deviations in the test guideline, relationship of the substance properties to the applicability boundaries of the test method, or other factors that may have influenced the obtained results or their quality. Include an explanation on the reasoning for which the test results need to be interpreted in a particular way. Additional information may be provided under the table *Attachments*.

#### 8.6.2.6. Applicant's summary and conclusion

Report the main conclusions from the study under *Applicant's summary and conclusion* heading. Use the field *Interpretation of results* (section-dependent), where available, to indicate how any effects observed in the study relate to classification and labelling criteria. Depending on the section, explain how the results impact the distribution of the test material in the environment and body (e.g. surface tension), and their influence on the risk assessment. In the field *Validity criteria fulfilled* (section-dependent), state whether the validity (or quality/repeatability) criteria of the applied testing method were fulfilled as per the OECD and EC test guideline used. Note that the details included in the endpoint study record should support the selection.

# 8.6.3. How to report read-across in IUCLID

The approach of read-across implies that endpoint information from one or several chemicals (the **source**) is used to predict information for another chemical (the **target**) for the same endpoint, when the properties of the chemicals are considered to be similar. Using read-across to fulfil an information requirement requires the reporting of both the experimental information on the source chemical(s), as well as the outcome of the read-across prediction on the target chemical.

In IUCLID, the **source records** are normally endpoint study records with the *Type of information* selection *experimental study*. They must be provided as directly linked to the substance dataset (analogue approach), or as part of category member datasets (category approach). Endpoint study records indicated with the *Type of information* field to be *read-across based on grouping of substances (category approach)* or *read-across from supporting substance (structural analogue or surrogate)* are **target records**. The target records document the outcome of reading across from the source substance(s) (analogue approach) or from the chemical group (category approach).

Both target and source information must be present in a IUCLID dossier containing a read-across approach<sup>15</sup>. Below, instructions are given for the reporting of category and analogue read-across, and for the completion of read-across target records.

Read-across based on grouping of substances (category approach)

- **Target data**: You must indicate each endpoint study record linked to the registered substance, which provides the outcome of reading across information from the category to the registered substance, with the *Type of information* set to *read-across based on grouping of substances (category approach)*. See below for more detailed instructions on how to fill in a target endpoint study record.
- **Source data**: To provide the source information for the read-across, you must include at least one *Category* object in the dossier, and ensure that all reported category objects are complete:
- i. Provide information on the category hypothesis, applicability domain and category justification in the field Category rationale (insert existing templates ) or attached in the table Reports.
- ii. Link the *Category members*, i.e. the substance datasets that form part of the chemical category underlying the read-across, to the category object. The category member substance datasets that are not in scope of the registration should contain as a minimum all the relevant information on substance identification and property/endpoint data to support the category approach.
- iii. In addition, you must select the *Category documents* that are used in the read-across approach.

Read-across from supporting substance (structural analogue or surrogate)

• **Target data**: You must indicate each endpoint study record, which provides the outcome of reading across information from the analogue to the registered substance, with the

<sup>&</sup>lt;sup>15</sup> As reporting of read-across in IUCLID 5 did not strictly follow the analogue or category approach, and as analogue read-across has so far been reported with a mix of source and target information in the same record, existing read-across records are migrated to IUCLID 6 with an indication in the *Type of information* field that the value was migrated from a previous version of IUCLID. In line with this, migrated read-across records will be checked according to general completeness check rules for endpoint study records, and will not require the source-target approach described above. It is however advisable, for the sake of transparency and consistency, to adapt the read-across reporting to the new approach as soon as feasible.

Type of information set to read-across from supporting substance (structural analogue or surrogate). See below for more detailed instructions on how to fill in a target endpoint study record in the IUCLID web user interface.

• **Source data**: For each target record, you must include at least one source record in the same IUCLID section. The source endpoint study record (ESR) must consist of a (robust) study summary of the experimental study done on the source substance. It must be filled in as any other ESR that documents an experimental study and will be subject to full completeness check. Endpoint study records that are used as source documentation for read-across are expected to be reliable (1 or 2) studies and should therefore be reported with the *Adequacy of study* set to *key study* (exceptionally, the adequacy could be set to *weight of evidence*, if justified).

#### Read-across target records

Target endpoint study records are subject to a limited completeness check as it is not meaningful for the target record to contain information related to an experimental study, such as the guideline or reliability. Table 5 shows an example of how to fill in a target record for read-across from a supporting substance. Target records must be filled in as follows:

#### Administrative data:

- Endpoint: Indicate the endpoint as appropriate; generally it is the same as in the source study/ies
- Adequacy of study: Indicate the adequacy as appropriate, according to how you will use
  the target information to fulfil the information requirement in the registration dossier.
  Note that indicating a read-across target endpoint study record with the field Adequacy
  of study flagged as supporting study, other information or disregarded due to major
  methodological deficiencies means that it is not used to fulfil the information requirement
  and only provides additional information to the main body of data.
- Justification for type of information: Provide here the endpoint-specific justification for the read-across.
  - i. For read-across from a supporting substance it is possible to load a text template that can be further adapted and extended, as needed, to report the necessary justification for the particular read-across hypothesis.
  - ii. For read-across based on category this field should contain endpoint specific considerations, it is possible to load a text template. The category justification should be provided in the category object in the field *Category rationale*. For category read-across: if multiple category objects exist in the dossier, it is also useful to mention the category name supporting this read-across outcome.
- Cross-reference: The field is only relevant for analogue read-across; provide here a link to the endpoint study record(s) in the same IUCLID section used as source study/ies for the read-across.

#### Materials and methods:

Test material information: Specify here the material that is the target of the read-across. While the test material information of the read-across target record usually reflects the substance that is in scope of the registration, explicit reporting of the read-across target material is important

#### for the following reasons:

- i. As the registered substance often represents a wider range of concentrations than a particular test material, and as several purity profiles may be covered in the registration, it is essential to indicate the assumed composition of the read-across target material, so that its relevance for the registered substance can be assessed.
- ii. Read-across may also take place from one form of a test material to another. In this case, the form of the read-across target material should be clearly indicated.
- iii. In the case of a multi-constituent or UVCB substances, the target material may also refer to a (group of) constituent of such a substance, depending on what approach the registrant takes in fulfilling the information requirement.
- iv. Read-across may be applied to generate results on another substance than the registered substance (e.g. transformation product), which is relevant for the safety assessment.

#### Results and discussion:

- Each IUCLID section has its own structure to report the results of the study. Click *New Item* to create the results table of the read-across target record and provide all the relevant information on the result as generated through the read-across approach.
- The results in the target record may be identical to the source endpoint study record if read-across is truly one-to-one. However, there may be differences between the source and target chemicals, which influence the numerical result (e.g. molecular weight). In the case of chemical categories, the property to be predicted may not be stable within the chemical group but follows a trend. Therefore, it is important that the result you report in the target endpoint study record corresponds to the value estimated for the read-across target substance after applying any such corrections.
- You should only report results that have been generated by the read-across approach in the target record. The source endpoint study record may also contain results which are not used in the read-across approach; these should not be present in the target endpoint study record.

## Applicant's summary and conclusion (optional but recommended)

- Present under this heading the main conclusions of the approach.
- The information should reflect the target material; provide an indication of how the
  estimated effects relate to classification and labelling criteria for the target material, if
  available in that section, and explain whether the results impact the distribution of the
  target material in the environment and body.
- In the *Executive summary* field, you may briefly summarise the justification for the readacross approach and the applicability of the result (please refer to the example in Table 8).

Table 5 below highlights the relevant parts of the endpoint study record for read-across source and target records. Mandatory chapters and fields are indicated in bold; parentheses refer to information that may be useful to report depending on the case.

# 8.6.4. How to report testing proposals in IUCLID

For studies required under REACH Annexes IX and X, a testing proposal must be submitted if a valid test result is not available. A testing proposal is indicated by setting the field *Type of information*, to *experimental study planned*, or *experimental study planned* (based on readacross), and should be completed as follows:

# Standard testing proposal, where the test is proposed on a test material that corresponds with the registered substance

- Endpoint: Indicate the endpoint to be addressed by the proposed test.
- Type of information: Select the value experimental study planned.
- Justification for type of information: If the proposed test concerns testing on vertebrate animals, load the available text template Experimental study planned / Testing proposal on vertebrate animals and fill in the point-by-point considerations for why the different adaptation possibilities provided by the REACH Regulation cannot be used to address the information requirement, and why animal testing is necessary. This information will always be published on the ECHA website and linked to the third party consultation on the testing proposal.
- Materials and methods: under the Test guideline heading, provide information on the Guideline and the Test material of the proposed test, as described in chapter 8.6.2 How to complete endpoint study records.
- In addition, for testing proposals concerning sections 7.8.1 and 7.8.2, enter information in the fields *Justification for study design* and *Species*, respectively.

# Testing proposal based on read-across, where the test is proposed on a substance different from the registered substance, to be used as a source for read-across to the registered substance

- Endpoint: Indicate the endpoint to be addressed by the proposed test.
- Type of information: Select the value experimental study planned (based on read-across).
- Justification for type of information: load the available text template 'Read-across (analogue)' or 'Read-across (category)' and provide the endpoint-specific justification for the read-across approach (see also chapter <u>How to report read-across in IUCLID</u> for links to further information on the application of read-across to fulfil information requirements).
- Materials and methods: under Test guideline heading, provide information on the Guideline and the Test material of the proposed test, as described in chapter 8.6.2 How to complete endpoint study records.
- In addition, for testing proposals concerning sections 7.8.1 and 7.8.2, enter information in the fields *Justification for study design* and *Species*, respectively.

 If the substance on which testing is proposed is subject to registration under REACH, ensure to include a standard testing proposal in the corresponding registration dossier according to the above instructions.

# 8.6.5. How to report a justification for weight of evidence approach in IUCLID

Standard information requirements under Annexes VII-X can be addressed with an adaptation according to Annex XI Section 1.2 Weight of evidence. A weight of evidence approach implies that information from several independent sources enable through a reasoned justification, a conclusion on the information requirement. A guide on what needs to be considered in a weight of evidence approach can be found in the "Weight of Evidence/uncertainty" template available at: Formats and templates - ECHA (europa.eu)

In IUCLID, the conclusion of the weight of evidence approach is reported in a record with the *Type of information* set to *weight of evidence justification/conclusion*, and must be filled in as follows:

- Endpoint: Indicate the endpoint for which the justification/conclusion is applied.
- Type of information: Select weight of evidence justification/conclusion.
- Justification for type of information: Provide here the endpoint-specific justification for the weight of evidence approach; a rationale for using this evidence instead of standard testing. It is possible to load a text template that can be further adapted and extended, as needed. Further information in support of the weight of evidence approach can be provided in the field Attached justification.
- Cross-reference: In this table, link all the endpoint study record(s) that contribute as sources to the weight of evidence approach. The linked records can be from the same or different IUCLID sections.
- Results and discussion: Summarise in this table the results enabled by the assessment of all the weight of evidence sources. The structure of the table captures the results and other observations and varies depending on the endpoint.

Table 6: Relevant parts of endpoint study record for weight of evidence source and weight of evidence justification/conclusion

# 8.6.6. Examples of completing endpoint study records

In this chapter you can find examples of how to document in IUCLID different approaches to fulfil the information requirements, i.e. which fields are relevant and the type of information to be filled in. For information on what the different approaches entail and how to use them to fulfil the information requirements, please refer to the following documents:

Note that the examples aim at illustrating how to use the IUCLID structure to report certain type of information. They are not exhaustive in content, and do not offer guidance on how to

use the different approaches to fulfil the information requirements in a compliant way. The fields indicated below represent the minimum information expected when entering the information in IUCLID; all available information that is relevant for the interpretation of the results should be provided.

# 8.6.6.1. Key study

To prepare an endpoint study record corresponding to a key study, detailed information on the applied methodology, test materials, the study results and conclusions must be provided in the respective fields of IUCLID. An example is given on how to report a key study for section 4.7 – *Partition coefficient*. Note that the fields indicated below represent the minimum information expected when preparing an endpoint study record corresponding to a key study; all available information that is relevant for the interpretation of the results should be provided.

# 8.6.6.2. Weight of evidence

When using a *weight of evidence* approach you should provide as a minimum two separate endpoint study records for the endpoint (REACH Annex XI, 1.2). You can provide in the field *Justification of type of information* an explanation on how the information in the endpoint study record contributes to the weight of evidence.

In addition, you must create one endpoint study record per weight of evidence approach with the type of information set to 'weight of evidence justification/conclusion'.

Below you can see an example of two different weight of evidence records for section 4.7 – *Partition coefficient and the* 'weight of evidence justification/conclusion' record. The fields indicated below represent the minimum information expected when preparing weight of evidence records; all available information that is relevant for the interpretation of the results should be provided.

# 8.6.6.4. Testing proposal

For studies required under REACH Annexes IX and X, a testing proposal must be submitted if a valid test result is not available. In some cases, the need to submit a testing proposal may be also triggered by results of tests performed at a lower tonnage band.

The fields indicated below represent the minimum information needed to submit a testing proposal; any further information relevant to support the testing proposal should be provided in the relevant fields. For testing proposals in sections 7.8.1 and 7.8.2, additional information in the fields *Justification for study design* and *Species*, respectively, are required (see example below).

# 8.6.7. How to complete endpoint summaries

Endpoint summaries are created by clicking † next to the corresponding IUCLID section. Except for situations where several sets of data are relevant for the assessment of the substance (see chapter <u>Assessment approach - assessment entities</u> or Annex 5 <u>Assessment Entities in IUCLID</u> 6), there should not be more than one endpoint summary per section.

In the context of REACH, the endpoint summaries are important for the IUCLID Report generator for generating the Chemical safety report (CSR). In addition, selected key values are intended to serve as input parameters to feed specific software used for assisting in the risk assessment process, e.g. any exposure estimation tool or the REACH-specific ECHA Chemical Assessment and Reporting Tool (Chesar).

Endpoint summaries are available for all endpoints in IUCLID. There are three types of endpoint summaries:

- **Endpoint summaries at endpoint level** (e.g. section 6.1.1 *Short-term toxicity to fish*), to identify and justify what is(are) the key study(ies) to be used for the further assessment. Hence, an endpoint summary addresses, in a very condensed form, the most relevant and reliable data. The summary may be confined to the highlights of one key study, if only one is available, or give a justification as to why the results of a given study are considered as key data in case several studies are available.
- **Endpoint summaries for main sections**, in which no endpoint data can be entered directly. For instance, Endpoint sections 6.1.1 *Short-term toxicity to fish*, 6.1.2 *Long-term toxicity to fish*, 6.1.3 *Short-term toxicity to aquatic invertebrates*, etc., are grouped in section 6.1 *Aquatic toxicity*. The template for such endpoint summary usually only consists of two rich text fields: *Description of key information* and *Additional information*, which are included at the beginning of CSR sections as a conclusion on an endpoint. In some cases, a field for justifying the classification and labelling is also included (see chapter *Section 2.1 GHS*).
- · Hazard conclusions for the environment and for human health. At the main

heading level of section 6 *Ecotoxicological Information* and section 7 *Toxicological information* specific fields are provided for recording more integrated information on hazard assessment conclusion, e.g. PNECs, DNELs respectively, including relevant input parameters but also more qualitative hazard conclusions. The fields for the hazard conclusion summary are further explained later in this chapter. A DNEL and PNEC calculator has been implemented in IUCLID to support registrants in deriving long term systemic DNELs or PNECs (see chapters on The IUCLID DNEL calculator and on The IUCLID PNEC calculator).

The next paragraphs explain the different endpoint summary types in more detail.

### 8.6.7.1. Endpoint summaries at endpoint level

Endpoint summaries at endpoint level are meant to identify the key information from the endpoint for the assessment. They consist of a set of information:

#### Link to relevant study record(s)

Provide here the link to the most relevant study (or studies) from which the key value for chemical safety assessment is extrapolated. The key information from those studies will be visible on the IUCLID user interface within the link.

#### Description of key information

You may provide here a short summary of the relevant values for the endpoint with some contextual information on the origin of the value. For the physico-chemical properties reported in IUCLID sections 4 the description of key information corresponds to the information reported in the CSR section 1 by the Report generator. However, the characterisation of the endpoint data should be kept as concise as possible.

#### Key value for chemical safety assessment.

The key value(s) reported in this section may subsequently be used in the chemical safety assessment as input parameters for exposure estimation or for deriving (eco)toxicological hazard conclusions, classification and labelling. In order to enable the use of any specific software, only a minimum number of structured fields are provided.

Key values are intended to condense the data summarised in field *Description of key information* to one single numeric value or a concluding remark (e.g. negative / positive) chosen from a picklist. Where a numeric field is provided, it is possible to also report a *less than* or *greater than* qualifier for it. You are advised to only use the qualifier when you lack information enabling you to derive a value, to inform about the uncertainty on the result. Conversion to a predefined unit or temperature may be required, if indicated in the field label (e.g. Koc at 20 °C), although in most cases the unit can be specified in a separate unit field.

Assessment tools such as Chesar depend on the availability of key values entered in IUCLID endpoint summaries (e.g. molecular weight, vapour pressure, water solubility, biodegradability). The rationale for any user-derived values should be described in the rich text field *Additional* 

information for the sake of transparency.

- For physico-chemical and environmental fate properties, the key value is usually a value which may be used for the estimation of a deterministic exposure value. Therefore select the value leading to a realistic worst case exposure estimate. As an example of a user-derived parameter, if for water solubility the substance is completely miscible: enter an appropriate concentration value (e.g. 1 g/L) which falls in the highest solubility category used in the relevant assessment tool;
- For environmental hazard endpoints, the key value usually is usually a dose descriptor (e.g. LC50 or NOEC) which may be used for the derivation of a PNEC. Therefore, select the lowest relevant value.
   As an example of user-derived parameter, if for aquatic long-term toxicity to fish a LOEC of 1 mg/L is available (corresponding to >10% and <20% effect): calculate NOEC as</li>
- For human health endpoints, the key value is further differentiated into a set of structured data which may be used for the derivation of a DNEL (therefore select the lowest relevant value) or a qualitative conclusion (e.g. irritant). The structure may vary depending on the endpoint. The following information can be reported as it is useful to identify the appropriate assessment factors for the derivation of a DNEL when relevant:

Justification for classification or non-classification Available for some endpoints (see chapter <u>Section 2.1 GHS</u>).

LOEC/2 and enter 0.5 mg/L in the field for NOEC;

#### Additional information

In this rich text field, describe the interpretation of the key information you have made for the given endpoint. This includes for example:

- Discussion on the potential data gaps.
- Relevance of the results for the risk assessment. For example for human health, the
  extent to which the results from an animal study are relevant.
- The rationale for the choice of the key study(ies) and the choice of the key value that, according to your judgment, characterises the endpoint. This includes a discussion of the most relevant information identified and in some instances of studies which are considered to be unreliable, but give critical results. A discussion as to why they were discarded in favour of other studies should then be included. Vice versa, a weight of evidence analysis based on less reliable data or use of published data, the reliability of which cannot be judged because of limited reporting, should be justified.
- If several studies were identified to be relevant for the assessment, discuss possible reasons for differing results if any, e.g. differences in purity / impurities of the test substance used, differences in the methods and test conditions, etc.
   Such discussion may not be needed for simple endpoints in standard situation, for example water solubility.

In addition, for a few endpoints for human health (7.5 Repeated dose toxicity, 7.6 Genetic toxicity, 7.7 Carcinogenicity, 7.8 Toxicity to reproduction, 7.9.1 Neurotoxicity, 7.9.2 Immunotoxicity) you may report an analysis of the mode of action of your registered substance in the field Mode of action analysis / Human relevance framework. In order to properly complete this field, it is advised to refer to the templates based on the WHO/IPCS Mode of Action Framework published at <a href="https://echa.europa.eu/web/guest/support/guidance-on-reach-and-clp-implementation/formats">https://echa.europa.eu/web/guest/support/guidance-on-reach-and-clp-implementation/formats</a>. It is recommended to make use of the HTML formats of these

templates which is already suitable for inclusion in the related IUCLID toxicological endpoint summaries.

#### 8.6.7.2. Hazard assessment conclusions<sup>16</sup>

For dossiers with a tonnage above 10 tonnes, a CSR must be provided (Annex I of REACH). This CSR should contain a hazard assessment where PNECs and DNELs should be derived when possible. In case the substance meets the classification criteria for at least one hazard, or is assessed as being PBT or vPvB, an exposure assessment is to be carried out. In this case the scope of exposure assessment under REACH and the type or risk characterisation to be carried out can be deducted from the hazard assessment conclusion for each protection target for the environment and each route and type of effect for human health:

- If the conclusion is that there is no hazard identified, then there is no need to carry out an exposure assessment;
- If a PNEC or a DNEL has been derived, a quantitative risk characterisation has to be carried out;
- If a DMEL or another toxicological threshold has been derived, a semi quantitative assessment has to be carried out;
- In all the other cases a qualitative risk characterisation is to be carried out.

For more information refer to Guidance Part D: Framework for Exposure Assessment available at <a href="https://echa.europa.eu/guidance-documents/guidance-on-reach">https://echa.europa.eu/guidance-documents/guidance-on-reach</a>.

#### 8.6.7.3. Hazard conclusion for the environment (including PNECs)

In the endpoint summary of section 6 *Ecotoxicological information*, for each protection target (e.g. *Freshwater*, *Marine water*, *STP*, *Sediment (freshwater)*, *Sediment (marine water)*, *Air*, *Soil*, *Secondary poisoning*), a selection must be made in the picklist *Hazard assessment conclusion*.

Based on the outcome of the hazard assessment, either a PNEC must be selected providing a numerical value and a unit, or a reason why no PNEC is available must be chosen from the list. If a PNEC was derived, provide additional information on the PNEC derivation in the fields Assessment factor and Extrapolation method.

When no PNEC is derived an explanation should be provided in the field *Explanation for hazard conclusion*.

# 8.6.7.4. Hazard conclusion for human health (including DN(M)ELs)

In the endpoint summary of section 7 *Toxicological information*, for each hazard under *Workers* and *General population*, a selection must be made in the picklist *Hazard assessment conclusion*. The conclusions include:

- Derivation of DNELs or DMELs from the dose descriptors giving rise to the highest concern (usually the lowest NOAEL/LOAEL) per route of exposure and type of effect;
- Derivation of a qualitative description of the level and type of hazard (low, medium or high hazard) for threshold effects like irritation or sensitisation if no dose descriptor is available. This also applies for non-threshold effects for which no DMEL can be derived

(e.g. mutagenicity);

- The statement *no hazard identified* for a route of exposure and type of effect, if no adverse effects have been observed at the limit dose in the reported studies;
- Statements related to the conclusion that the available information does not support a
  conclusion on the hazards of the substance for a certain route of exposure or type of
  effect. This may include two assessment cases:
  - i. Hazard unknown but no further hazard information necessary as no exposure expected: this is to be selected when the generation of hazard information is waived on the basis that no exposure is expected. In such case the exposure assessment should describe the use conditions under which exposure is prevented;
  - ii. Insufficient hazard data available (further information necessary): to report that testing is proposed.

If a DNEL was derived, provide additional information on the DNEL derivation under *DNEL related* information.

When a deviation from a standard assessment factor is made your justification should specify how the following factors in REACH Annex I, Section 1.4.1. have been taken into account:

- the uncertainty arising, among other factors, from the variability in the experimental information and from intra- and inter-species variation;
- the nature and severity of the effect;
- the sensitivity of the human (sub-)population to which the quantitative and/or qualitative information on exposure applies;
- and that the DNELs reflect the likely route(s), duration and frequency of exposure.

Read the field-specific help text in IUCLID for more information.

#### 8.6.7.5. The IUCLID DNEL calculator

IUCLID 6 includes a *DNEL calculator* functionality. The aim of the IUCLID DNEL calculator is to support the derivation of Workers and General Population Derived No-Effect Levels for long-term systemic effects for oral, dermal and inhalation routes based on the *ECHA Guidance on Information Requirements and Chemical Safety Assessment, Chapter R.8.* 

The current version of the *DNEL* calculator only supports the derivation of DNELs for long-term systemic effect based on dose-dependent effects on repeated dose toxicity or reproductive toxicity. It does not support the calculation of DNELs for acute toxicity or local effects, nor the use of human data and the derivation of DNEL for threshold carcinogens. Finally, the *DNEL* calculator does not support the calculation of Derived Minimal Effect Levels (DMELs) for non-threshold hazards.

The *DNEL calculator* is available by clicking on the *Calculate DNEL* button in the endpoint summary under section '7 Toxicological information' in a substance data set or template. The *DNEL calculator* will calculate default DNEL values based on the selection of the data provided in the dataset related to the endpoint summaries of section 7.1, 7.5 and 7.8. The registrant should always check that all needed information is added to the DNEL calculator window, so that the calculator can then perform the algorithm to select the starting dose descriptor(s) for the specific

route. The registrant can modify some parameters of the default calculations if needed, providing a justification. The outcome is automatically reported in the endpoint summary of section 7. The hazard conclusions for local effects and for acute effects have to be manually reported by the registrant directly in the endpoint summary of section 7.

For more information on the IUCLID DNEL calculator, refer to the help system of IUCLID.

#### 8.6.7.6. The IUCLID PNEC calculator

IUCLID 6 includes a *PNEC calculator* functionality. The aim of the IUCLID PNEC calculator is to support the derivation of Predicted No-Effect Concentration for the aquatic, sediment and terrestrial environmental protection targets based on the <u>ECHA Guidance on Information Requirements and Chemical Safety Assessment, Chapter R.10.</u>

The current version of the *PNEC calculator* does not support the calculation of PNECs for microorganisms in sewage treatment plants and the PNEC oral used for the assessment of secondary poisoning.

The *PNEC calculator* is available by clicking on the PNEC button in the endpoint summary under section '6 Ecotoxicological information' in a substance data set or template. The *PNEC calculator* will calculate default PNEC values based on the selection of the data provided in the dataset related to the endpoint summaries of section 5.4.1 (*Adsorption / desorption*), 6.1.1 to 6.1.6 (*Aquatic toxicity*), 6.2 (*Sediment toxicity*) and 6.3.1 to 6.3.4 (*Terrestrial toxicity*). The registrant should always check that all needed information is added to the DNEL calculator window, so that the calculator can then perform the algorithm to select the starting dose descriptor(s) for the specific protection targets. The registrant can modify some parameters of the default calculations if needed, providing a justification. The outcome is automatically reported in the endpoint summary of section 6. The hazard conclusions for microorganisms in sewage treatment plants and for the secondary poisoning have to be manually reported by the registrant directly in the endpoint summary of section 6.

For more information on the IUCLID *PNEC calculator*, refer to the help system of IUCLID.

#### 8.7. Section 11 Guidance on safe use

According to section 5 of Annex VI of REACH Regulation you need to provide a guidance on safe use with the following information:

- First aid measures;
- Fire-fighting measures;
- Accidental release measures;
- Handling and storage;
- Transport information.

In cases where CSR is not required, you need to report the additional information, such as:

- Exposure controls / personal protection;
- Stability and reactivity;
- Disposal considerations.

For joint submissions, the guidance on safe use can be provided jointly by the Lead registrant on behalf of all members, or separately by each member individually.

The reported information must be consistent with that in the safety data sheet (SDS), where an SDS is required.

## 8.8. Section 13 Assessment reports

This is the section where the chemical safety report is attached, if needed. Article 14 of the REACH Regulation requires a chemical safety assessment (CSA) and its documentation in a chemical safety report (CSR). This applies to the substances manufactured or imported at 10 tonnes or more per year per registrant with some exemptions listed in Article 14.2.

## 8.8.1. Section 13.1 Chemical Safety Report (CSR)

To attach a CSR:

- **Step 1.** Create a record in section 13.1 by clicking on ±.
- **Step 2.** Select the *Type of CSR*: if you are a lead registrant, select whether it is a *Joint CSR* (*joint uses*) that you submit on behalf of all members, or if it is an *Own CSR* (*own uses*). You can also indicate if your own CSR is based on a jointly prepared CSR *Own CSR initially prepared jointly within the consortium*.
- **Step 3.** Select the content of the attached CSR in the picklist *CSR contains* i.e. whether the CSR contains part A, or part B section 1 to 8 with hazard assessment, or part B section 9 and 10 with exposure assessment, or a combination of them.
- **Step 4.** Indicate the type of tool used for performing the CSA and generating the CSR in the field *Chemical safety assessment/report tool used* (e.g. if you have used Chesar).
- **Step 5.** Attach the CSR in the field *Chemical safety report (CSR)*.
- **Step 6.** If you used a tool for performing your assessment and generating the report, you can also attach the export file from this tool in the field *Export file* (safety assessment / exposure estimation tool).
- **Step 7.** In the subsequent fields you can provide additional details on the attached files (for example if you attach an assessment tool export file, you may want to indicate the version used) or other explanations.

#### Joint chemical safety report

In case of a joint submission, the members can agree that the lead registrant submits a joint CSR on behalf of some or all of the members of the joint registration. The hazard assessment should always be done collectively within the joint submission. Submitting a joint CSR is also advised in case the exposure assessment is expected for the substance to be registered. The lead registrant dossier should include in section 3.5 all the uses covered by the joint CSR, and document for each use, in the section 3.5.X field *Related assessment*, whether:

- i. it is assessed in the joint CSR, or
- ii. it is assessed in the joint CSR but is not a lead's own supply chain use

The member registrants include their uses in section 3.5, and indicate in section 3.5.X field *Related assessment*, that the uses are assessed in the joint CSR. The joint CSR should be

submitted by the lead only. It is advisable that the lead provides a documentation to the members detailing how the uses covered in the joint CSR have been described in IUCLID section 3.5. The document could be provided as an export file from IUCLID.

In addition, the lead and member registrants may report and assess particular uses relevant only to themselves. In this case, they can submit a partial CSR Part B, containing only chapter 1, 2, 9 and 10, and add the corresponding uses in section 3.5. In the *Related assessment* field it should be flagged that the use are assessed in an own CSR.

It is essential that each registrant reports for each use in section 3.5.X whether it is assessed in a joint CSR or an own CSR, or is exempted from assessment.

If a CSR including exposure assessment is provided by the lead on behalf of the members, each member registrant should still provide part A of the CSR, where the member certifies that he applies the identified risk management measures at his own site, and has also communicated the required risk management measures relevant to his customers.

#### Waiving the chemical safety report

Article 14(2) of REACH specifies certain conditions under which a chemical safety assessment does not need to be conducted. If your substance fulfils the conditions under Article 14(2), in order for the dossier to be considered complete, you must create a record in section 13.1 and justify the absence of a CSR by including an explanation in the field *Discussion*. In the justification, you must clearly document how the substance fulfils the conditions in Article 14(2), i.e. that the substance is imported in a mixture or material where it is present at a value below the cut-off value relevant for that substance. The justification must be specific to the registered substance; a generic reference to Article 14(2) is not sufficient to omit the CSR.

#### IUCLID Report generator

If you provide information under CSR Part A in section 13.1 *Chemical Safety Report (CSR),* the IUCLID *Report generator* will use this information to complete part A of your CSR. This part includes the following three text fields:

- A summary of risk management measures: there is no need to repeat the description of the risk management measures included in the part B. A reference to the relevant exposure scenarios in Part B should be sufficient.
- The declaration that these measures have been implemented: this refers to the registrant's manufacture and own uses.
- The declaration that these measures have been communicated to customers via the extended safety data sheets.

Once the CSR has been generated with the IUCLID *Report generator*, it must be attached to section 13.1, as explained above. For information on how to access the *Report generator* see chapter <u>The Dataset page</u>.

# 8.8.2. Section 13.2 Other assessment reports

This section allows the attachment of different reports, other than the chemical safety report. For example, reports in response to dossier evaluation or measured exposure data reports can be attached here.

To attach a report:

- **Step 1.** Create a record in section 13.2.
- **Step 2.** Select the *Type of report*.
- **Step 3.** Attach the report in the field *Document/report*.
- **Step 4.** Provide additional information on the report in the *Further information on the attachment / remarks* field, as relevant.

# 8.9. Section 14 Information requirements

#### 8.9.1. Section 14 Annex III criteria

The standard information requirements for the 1-10 tonnes/year registrations under REACH are defined in REACH Annex VII, which is divided into two types of information:

- Information on physicochemical properties required for all 1-10 tonnes/year substances;
   and
- Information on toxicological and eco-toxicological properties for all substances that do not meet the criteria of a phase-in substance, and those phase-in substances that fulfil the Annex III criteria of REACH.

If you are registering a substance at 1-10 tonnes/year which meets the criteria of a phase-in substance according to REACH Article 3(20), and which does not have any properties of concern as described in REACH Annex III, you can benefit from the reduced information requirements and submit your registration dossier with physicochemical information only (see also the Annex *Overview of endpoints and information requirements*). In this scenario, you will need to fill in *Annex III criteria under Section 14 Information requirements* in IUCLID to justify your approach. This is applicable for individual, lead and member dossiers relying only on physicochemical information:

- **Step 1.** In the navigation panel, click on the + button next to *Annex III criteria*.
- **Step 2.** A new record with a set of questions is created.

The questions/points appearing in the record will guide you, in a step by step mode, to the different possibilities for a substance falling under REACH Annex III, in order for you to demonstrate the non-applicability of its criteria to your substance. You will need to reply to all of the questions choosing *Yes* or *No* from the respective picklists. You will be able to justify your conclusion by a free text explanation and by attaching supporting documents, if necessary.

ECHA has developed support material outlining an effective step by step procedure for companies to consider REACH Annex III in the context of their registration. For more information please visit the Annex III dedicated webpage at <a href="https://echa.europa.eu/support/registration/what-information-you-need/reduced-information-requirements">https://echa.europa.eu/support/registration/what-information-you-need/reduced-information-requirements</a>.

# 8.9.2. Section 14 Opt-out information for REACH registration

In this section, you indicate that you submit all or part of the registration dossier data separately, i.e., opt out from the commonly agreed data of the joint submission in line with at least one of the reasons listed in REACH Article 11(3) or 19(2). Whether you opt out for part or all of the jointly submitted data, you must be part of the same joint submission.

There are two ways to gain access to the joint submission:

- The lead registrant provides you with a token to access the joint submission in REACH-IT. In this case, you can opt out for part of the data (a 'partial opt-out') or all of the jointly submitted data (a 'full opt-out').
- You can request an ECHA full opt-out token through your REACH-IT account to access the joint submission. This allows you to submit only a full opt-out dossier.

As a member registrant with a partial opt-out, you can decide what data to opt out for, e.g., only a specific study or several studies.

As a member with a full opt-out, you must submit all the information specified in Article 10(a)(iv), (vi), (vii) and (ix) of REACH; your dossier must contain all the information required at your registered tonnage band. You cannot rely on the data submitted jointly.

As a lead registrant with an opt-out, you must provide all the information required to be submitted jointly as specified in Article 10(a) of REACH. This is because the dossier submitted by the lead registrant will be relied upon by the other registrants for fulfilling their data requirements under REACH. You can decide what additional data to opt out for. For example, when the joint submission covers a lower tonnage than the lead's own tonnage band, the lead may opt out with the data required for this higher tonnage.

All the data provided, whether jointly or opted out, must be complete.


### In order to prepare your dataset for opt-out:

- **Step 1.** Go to section 14 Information requirements in the navigation panel and click on the button next to *Opt-out information for REACH registration*.
- **Step 2.** Select *New item* next to the *Data selected for opt-out* heading.
- **Step 3.** Click in the *Documents* field and then click *Select*. You can then choose whether you are adding an existing endpoint study record or GHS record, or creating a new record.

Note that when using a joint submission member working context, new endpoint study records or GHS records can be created exclusively through section 14 (see picture below) and not from the Table of Content (TOC). Existing endpoint study records or GHS records (if created using a different working context) can be referenced by ticking their corresponding box.

All the records linked in section 14 will be automatically included in the dossier. However, the endpoint summaries (e.g., for sections 6 and 7) can only be included in your dossier during the dossier creation step through the *Advanced settings* functionality. For advice on how to include such data please see section 9.2 of this manual.

**Step 4.** Opt-out must be justified. For this, select at least one of the five reasons available in the field *Justification* in section 14 *Opt-out information for REACH registration*, and answer all the questions associated with the chosen opt-out reason.

Different blocks should be created if the opt-out data is justifiable based on different provisions in REACH Article 11(3) or 19(2). To add additional data blocks, click on *New item* again and repeat the abovementioned steps.

For example, if you are opting out to provide available existing information on physicochemical, human health or environmental properties of an intermediate (Article 17(2)(d) or 18(2)(d) of REACH) or other information that is not required by any registrant in the joint submission you should use the reason 'disagreement on the selection of the Annex VII-X information'.

If you are opting out to provide your own classification and labelling data, you should use the reason 'disagreement on the jointly submitted classification and labelling information'.

If you have received an ECHA decision granting the 'permission to refer' related to a data sharing dispute, select the reason 'data sharing dispute' and provide the data sharing dispute number DSH-XX-X-XXXX-XXXX in the connected field. The 'X' characters in the reference DSH-XX-X-XXXX-XXXX must be replaced with the actual number of the dispute. If you received the token

to access the joint submission from ECHA you must also select the checkbox *Data sharing issues* in the dossier header (see <u>section 9.1.4</u>). Any data submitted separately for which you have not received the 'permission to refer', must be provided under a separate block with a separate justification.

More information on the opting out possibilities and mechanisms can be found in the *Guidance on data sharing* available at <a href="https://echa.europa.eu/quidance-documents/quidance-on-reach">https://echa.europa.eu/quidance-documents/quidance-on-reach</a>.

The opt-out reasons with the associated questions (as available in the justification picklist in section 14), see <a href="#">Annex 7</a> of this manual.

### 9. How to create a Dossier

Once you have included all relevant information in your substance dataset, the next step is to create a dossier.

Before creating a dossier you are advised to check the completeness of your substance dataset by running the *Validation assistant*. For more information on how to run the *Validation assistant* refer to the help system of IUCLID.

- **Step 1.** To create a dossier open the list of available datasets by clicking on the button entitled *Substances* in the IUCLID Dashboard.
- **Step 2.** All available substances will be displayed in the *Substances* list page. If a substance does not appear in the list you can search for it using the search field.
- **Step 3.** Click on the substance for which you want to create a dossier.
- **Step 4.** Before creating a *Dossier* a *Working context* (submission type) must be selected. Click on the *Working context* field and select the right submission type from the picklist. Choosing the correct dossier template by selecting the *Working context* is essential for a successful submission. Before exporting your dossier you have to make sure that the selected template corresponds with the intended submission.
- **Step 5.** Click on *Create Dossier* in the top right-hand corner of the screen.


The selection of the *Working context* allows the IUCLID interface to present to the user at the start of Dossier creation, either a pre-filled or blank *Dossier header* of the correct type.

For instructions on how to fill the administrative information in the Dossier header, please see the following subchapters.

Information contained in the dossier header is crucial for business rules checking when you submit your dossier. Missing or incorrect information can result in that your submission cannot be accepted for further processing and will be automatically removed from the system. In this case you need to create a new dossier with corrected information and submit it again. For more information refer to the Annex: <u>Overview of the business rules checks performed by ECHA on the submitted dossiers</u>.

**Step 6.** From the *Dossier header* page you can either use default settings and create your dossier by clicking on *Create dossier* at the foot of the page, or access the *Advanced settings* for dossier creation by clicking on the *Advanced settings* button.

- **Step 7.** From the *Advanced settings* window you can define the confidentiality level by selecting the data protection flags. If you have included any confidentiality or regulatory programme flags in your substance dataset, please make sure that the relevant information is included in your dossier by selecting the appropriate flags in this step. If you are unsure, it is recommended to select the defaults option. ECHA will assess the confidentiality of the information and the justifications provided. You can find more information on the publication of part of the dossier on the ECHA website at <a href="http://echa.europa.eu/manuals">http://echa.europa.eu/manuals</a>.
- **Step 8.** From the *Advanced settings* window you can select whether the annotations should be included in the dossier.
- **Step 9.** By ticking the checkbox *Select documents to be included* and clicking *Next* you can verify and select which documents and entities will be included in your dossier. Certain documents, such as section 1.1, will always be included in a dossier, and cannot be excluded in this step. Likewise, depending on the submission type, some documents will not appear in the list and cannot be included as they are not relevant for the selected submission type. If you are unsure of the information to be included, you can rely on the default settings for that submission type.
- **Step 10.** To finalise the creation of your dossier click on *Create dossier* at the bottom of the *Advanced settings* window.

#### 9.1. Administrative information

Dossier name: Choose a name for your dossier which enables you to easily identify it in your database. You are advised not to use confidential information in the dossier name; it will be seen by anyone you share the dossier with.

Dossier submission remark: This field is optional and can be used for additional remarks on the submission reasons, e.g. in the case of an update, what motivated it.

# 9.1.1. Type of submission

**Individual registrant:** The checkbox *Joint submission* should not be selected if you are not part of a joint submission with your substance.

**Lead registrant:** The checkbox *Joint submission* should be selected only if your dossier will be submitted as the lead dossier of a joint submission. Select the relevant checkboxes if you are providing information on behalf of the members, such as *Chemical safety report*, *Guidance on safe use* and/or *Review by an assessor*.

**Member registrant:** If you are a member of a joint submission, make sure you have selected one of the two following *Working contexts* (Submission types):

Member of a joint submission - general case;

Member of a joint submission - intermediates.

As a member of a joint submission you can indicate in the dossier header if information is provided by the lead on your behalf. This applies to the *Chemical safety report, Guidance on safe use* and *Review by an assessor.* 

#### 9.1.2. Tonnage band

In the field *Tonnage band(s)* of the registrant select your own tonnage band. The tonnage band of the joint submission is established by the type of dossier template that you have selected. If the dossier is a combined submission for non-intermediate and intermediate use, then indicate also the intermediate tonnage bands.

# 9.1.3. Specific submissions

Identify whether the dossier should be submitted as an initial submission or as an update of a previous submission.

An update can be submitted only in the following cases:

- Spontaneous update, when you have successfully registered this particular substance and you wish to update your dossier with new information;
- Requested update, following a failure of the technical completeness check (TCC) in your previous submission, or a request or decision by the Agency.

They are further explained in the next chapters.

#### 9.1.3.1. Spontaneous update

Submit a spontaneous update if you wish to update your dossier on your own initiative in order to keep your dossier up to date as per REACH Article 22, or in response to an informal communication from the Agency such as a screening campaign. Indicate in the dossier header that *The submission is an update* and enter the submission number of the last successful

submission in the corresponding field. Select the checkbox *Spontaneous update*. Select an appropriate reason for updating from the picklist in the *Justification* field. If you select *other*, then the free text field needs to be filled with an appropriate reason for updating. If you wish to indicate more than one reason for updating the dossier, you should create an additional repeatable block for each reason. Please note that a *Justification* has to be provided in all the blocks.

### 9.1.3.2. Update following a completeness check failure

**Submit a requested update if you are updating your dossier due to a completeness check failure(s) in your previous submission.** Indicate that *The submission is an update* and enter the submission number of the submission that failed the completeness check in the corresponding field. Select the checkbox *Further to a request/decision from regulatory body* and enter the communication number in the field *Number*. The communication number can be found in the completeness check failure letter under the Key documents tab of the Submission page in REACH-IT.

### 9.1.3.3. Update following other request by the Agency

Submit a requested update if it was so requested by the Agency e.g., resulting from a compliance check or confidentiality claim assessment outcome in a letter sent to your REACH-IT account. Indicate in the dossier header that *The submission is an update* and enter the submission number of your last successful submission in the corresponding field. Select the checkbox *Further to a request/decision from a regulatory body* and enter the communication number linked to the request by the Agency that motivated the update in the field *Number*.

# 9.1.4. Dossier specific information

**Reviewed by an assessor:** The checkbox *Reviewed by an assessor* is not compulsory, but in accordance to REACH Article 10 (a) (viii) if the dossier, or parts of it, have been reviewed by an assessor it must be indicated here.

**Confidentiality claims:** Confidentiality claim on registration number and Confidentiality claim on tonnage band should be selected if you want to claim the relevant data confidential. The claim needs to be followed by a justification. Also, these claims may trigger an invoice.

The confidentiality claim flag in the dossier header needs to be re-introduced every time the dossier is resubmitted. Once you have received the registration number, you can also put the confidentiality flag on the registration number in IUCLID section 1.3. The flag will remain there in the subsequent updates.

The checkbox for the *confidentiality claim on the tonnage band* is the only location in the dossier where you can request confidentiality on your registered tonnage band. The confidentiality flag in IUCLID section 3.2 relates to the actual tonnage manufactured/imported, which is always treated as confidential information.

**Data sharing issues:** When joining a joint submission using a token provided by the Agency, it is mandatory to select the checkbox *Data sharing issues* in the dossier header while creating the dossier. Provide an explanation in the *Justification* field, or your Data sharing dispute number (DSH-XX-X-XXXX-XXXX) in case you have received the 'permission to refer' following a Data sharing dispute. The 'X' characters in the reference DSH-XX-X-XXXX must be replaced with the actual number of the dispute.

When the checkbox *Data Sharing Issues* in the dossier header is selected, the submission cannot rely on the jointly submitted documents.

Fee waiving (1-10 tonnes, not fulfilling Annex III criteria and voluntarily providing full Annex VII): You can claim a fee waiver in the dossier for 1-10 tonnage band (including intermediates) only if you, or the joint submission lead, voluntarily provide the full information indicated in Annex VII of REACH and your substance is phase-in and considered of low risk (i.e. does not meet the Annex III criteria of REACH).

Please see also Chapter <u>Section 14 Annex III criteria</u> of this document for background information.

Note that in order to refer to the full Annex VII data of the lead dossier you need to have a prior agreement with the lead registrant during the data sharing negotiations. If the lead submission does not cover the full Annex VII (e.g. lead dossier with reduced information requirements/physicochemical information only), as a member you can provide the information as an opt-out.

When submitting a registration using the template REACH Registration 1 - 10 tonnes, physicochemical requirements the registrant is not entitled to waive the fee.

#### 9.1.4.1. Compulsory information for isolated intermediates

If your dossier covers a registration for intermediates then one or both of the checkboxes referring to the conditions of the use in accordance with REACH Article 17 and 18 need to be selected as appropriate.


# 9.2. How to include endpoint summaries in an opt-out dossier

All the records linked in section 14 will be automatically included in the dossier (see chapter 8.9.2). However, the endpoint summaries, including section 6 'Ecotoxicological information' and section 7 'Toxicological information', can only be included in your dossier during the dossier creation step through the Advanced settings functionality.

In order to include all relevant information proceed as follows:


- **Step 1.** Click *Create dossier*. Fill in all the administrative information as instructed in previous chapter.
- **Step 2.** Click on the *Advanced settings* button (in the bottom right).
- **Step 3.** Select the tick box *Select documents to be included* (in the bottom of the pop-up window) and then click *Next*.

**Step 4.** Add the endpoint summary records and click *Create dossier*.

**Step 5.** Make sure that the additional documents you selected are present in the final dossier by verifying manually the table of content.

# 10. How to export a Dossier

To start the export process, first search for the *Dossier* by clicking on *Substances* on the IUCLID Dashboard. In the *Substances* page, click the *Dossiers* button in the top right-hand corner of the screen and then select the relevant dossier among those displayed in the list by clicking on it. A *Dossier* is indicated by a lock icon at the lower right of the entry in the list.

Once your *Dossier* screen is open click on the icon with three dots displayed in the top righthand corner of the screen. To export your dossier click *Export to i6z*.

#### 11. Submit Dossier

To submit your dossier to ECHA you must sign-up in REACH-IT with the legal entity details of the submitting entity, and follow the instructions provided there for your specific type of submission.

# 12. Update Dossier

If you need to update your dossier, you do not need to re-type again all your substance data. Instead you can update the information in the *Substance dataset*. To edit the *Substance dataset*, select it from the *Substances list* page and fill in or update the relevant data. When the dataset is ready you can create a dossier (see chapter *How to create a Dossier*).

Once a registration dossier has been submitted to ECHA and accepted for processing, any resubmission of the dossier has to be identified as an update for technical reasons and it is the responsibility of registrant. If the information is the part of the joint submission, the lead registrant have to update the registration on behalf of the members.

There are two types of updates for registration dossier: *requested* and *spontaneous update*. When updating a dossier refer to the <u>chapter 9</u> of this manual.

# Annex 1. Overview of the business rules checks performed by ECHA on the submitted dossiers

Business rules are a set of dossier format and administrative pre-requisites that must be fulfilled before ECHA can establish that the dossier can be handled properly and that the required regulatory processes can be successfully carried out. Business rules do not assess the completeness or compliance of the data provided. If the dossier submission fails at the business rule level, the dossier will be automatically removed from the system, and a new submission is required before any regulatory processes can be initiated. You can see the outcome of the business rules check in the submission report in REACH-IT.

This document will guide you through the basic requirements of creating the substance dataset and the IUCLID dossier header. In addition, it is recommended to use the IUCLID Validation Assistant on the substance dataset and also on the final dossier before exporting it from IUCLID and submitting it to REACH-IT. Click on your substance dataset or on the dossier in the IUCLID navigation panel and select *Validate*. The *Validation Assistant* will check most of the business rules. However, some of the business rules depend on the information that is stored within the REACH-IT database, and therefore the plugin cannot simulate all the business rules checked by the Agency.

# Annex 2. Overview of the completeness check performed by ECHA on the submitted dossiers

This Annex compiles the minimum elements to be reported in a registration or PPORD dossier. The checks described below do not provide an indication of the quality or compliance of the dossier.

Also note that the completeness check performed by ECHA may include additional checks than the ones listed below, to ascertain that all the required elements have been provided. These additional checks include manual verification by ECHA staff of certain elements in the dossier that cannot be automatically determined. They could potentially lead to different conclusions from those indicated by this Annex. For more information on the areas of manual verification refer to the document <u>'Information on manual verification at completeness check'</u>: https://echa.europa.eu/manuals

The below checks are included in the IUCLID Validation assistant. The Validation assistant includes some more detailed logic on when certain rules are verified. This is not reflected in the list below as it would increase its complexity. It is strongly recommended to use the Validation assistant when preparing the Substance dataset, and also on the final dossier, before submitting it to ECHA.

The following conventions apply and are not separately stated for each of the checks below:

- Whenever the value *other:* is selected in any picklist field, the below text field displaying the word '*Other'* must be provided;
- Wherever a check applies to a repeatable field structure such as a repeatable block or table: each created entry must be complete;
- Whenever a field is associated with a unit, this must be filled in.

# Annex 4. Minimum information required for updating a registration under previous Directive 67/548/EEC

When updating a registration that was previously a notification under Directive 67/548/EEC (NONS) the following three scenarios have to be taken into account:

- Tonnage band update
- Update to become the lead or a member of a joint submission
- Other updates

Please see the detailed description and the requirements set to these update types below.

#### Tonnage band update

According to Article 24(2) of the REACH Regulation, the registration dossier for the previously notified substance must be updated when the manufactured/imported quantity reaches the next tonnage threshold (10, 100 or 1000 tonnes). Moreover, an update is required for notified substances produced in quantities below 1 tonne when reaching the 1 tonne threshold.

The update should contain the information required by REACH that corresponds to that higher tonnage threshold and any information that corresponds to all the lower tonnage thresholds. All the information requirements included in column 1 of REACH Annexes VII-X must be met depending on the tonnage. In this case, the dossier has to be fully in line with REACH requirements in the IUCLID format specified by ECHA. In particular, all of the completeness check requirements referred to in this document must be met without any possibility of making derogations due to the substance being previously notified under Directive 67/548/EEC.

If your update involves a registration at or above the 10 tonnes threshold, a Chemical Safety Report (CSR) should be included in section 13 of your IUCLID dossier, unless not required due to the reasons given in Article 14(2) REACH in which case a justification should be provided in section 13.

Annex 2 of this manual provides more information on the completeness check performed by ECHA on the submitted dossiers.

#### Update to become the lead or a member of a joint submission

According to Article 11 and 19 of REACH, the joint submission obligation also applies to the previously notified substances. Therefore, when another registrant wants to register the same substance, a joint submission must be established and data must be shared.

In such cases, the previous notifier will need to take one of the following courses of action:

• The previous notifier becomes the lead registrant of the joint submission. Based on Article 11(1) of REACH, the lead registrant must submit all the information required to be submitted jointly, which is specified in Article 10(a). Accordingly, the previous notifier, as the lead registrant, will need to create the joint submission in REACH-IT and submit the joint information with the agreement of the other registrant(s), who will then register as member(s) of the joint submission.

In this situation, similar to the tonnage band update described above, the lead dossier has to be fully in line with REACH requirements in the IUCLID format specified by ECHA. In particular, all of the completeness check requirements outlined in this manual must be met without any possibility of making derogations due to the substance being previously notified under Directive 67/548/EEC.

• The previous notifier becomes a member of the joint submission. When a new registrant creates a joint submission and becomes the lead of it, the previous notifier will eventually need to join this joint submission as a member registrant. At the latest, this will happen when the previous notifier needs to update the dossier.

As long as the manufactured/imported quantity of the substance does not reach the next tonnage threshold, the previous notifier as a member registrant can make derogations due to the substance being previously notified under Directive 67/548/EEC and exempt from some data requirements (see next paragraph). As soon as the quantity of the substance reaches the next tonnage threshold, the dossier must be fully in line with REACH requirements (see the previous paragraph).

#### Other updates

Article 22 of the REACH Regulation lists the cases when the registrant has to update the registration dossier. This also includes updates to include the classification and labelling according to Article 40 of Regulation (EC) No 1272/2008 on classification, labelling and packaging of substances and mixtures (CLP Regulation).

When updating the registration dossier of a NONS (excluding a change of tonnage band and becoming the lead registrant), certain information in your dossier is not required. However, to be considered complete and for REACH-IT to be able to process the dossier, your dossier must include as a minimum the following information<sup>17</sup>:

New and updated information submitted

The new and the updated information submitted as a consequence of the update has to meet all of the completeness check requirements referred to in the present manual, with no special exceptions due to the status as a previously notified substance, e.g. if you are updating your dossier to include the classification and labelling according to the CLP Regulation, IUCLID section 2.1 has to be complete.

Robust study summaries must be provided for any new study and for the studies requested by a Competent Authority under Directive 67/548/EEC and now regarded as Agency decisions according to Article 135 of the REACH Regulation.

Certain types of updates under Article 22 require that the relevant sections of your IUCLID dossier are updated; e.g., to update the consumer uses, the IUCLID section 3.5.5 needs to be updated.

Section 1 - General Information

**Section 1.1 Identification and 1.2 Composition**. These sections must meet all of the completeness check requirements. However, structural formulas are optional as they have

already been submitted on paper under Directive 67/548/EEC.

**Section 1.3 Identifiers**. At least the notification number under Directive 67/548/EEC (NCD number) and your registration number under the REACH Regulation (that you received when claiming your registration number via REACH-IT) must be included.

Section 2 – Classification & Labelling and PBT assessment

**Section 2.1 GHS. Classification and labelling** according to the CLP Regulation (GHS) is compulsory in section 2.1 of your IUCLID dossier. If you have previously submitted a dossier without section 2.1, you should provide this information in a registration update without undue delay.

**Section 2.3 PBT assessment**. It consists of an endpoint summary and endpoint study records. If the updated notification is above 10 tonnes per year, you need to create an endpoint summary in section 2.3 PBT assessment and make sure that a choice has been made in the picklist *PBT status*. If *PBT assessment does not apply* is selected, a *Justification* should be provided in the free text field.

• Section 3 - Manufacture, use and exposure

In case you indicated in IUCLID section 1.1 that your *Role in the supply chain* is (also) *Manufacturer* then the following subsection has to be complete:

**Section 3.3 Sites**. If you indicated in section 1.1 that your *Role in the supply chain* is *Manufacturer*, then you must provide at least one production site in this section. To this end, you must create a record in section 3.3; link a *Site* to it; and link it using the field *Related manufacture/own use* to at least one manufacture record in section 3.5.1. For manufacturing sites, the country of the site is normally expected to be the same as the country of the submitting Legal entity.

**Section 3.5.1 Manufacture**. If the checkbox *Manufacturer* is selected in section 1.1 *Identification*, then at least one record must exist with a manufacture use in section 3.5.1.

• Section 13 - Chemical Safety Report

When the update does not involve a change in tonnage band, the notifier does not normally need to submit a CSR. However, a CSR has to be provided if the updated notification is above 10 tonnes per year and covers new identified uses, or new knowledge arises with regard to the risks of the substance to human health and/or the environment which would lead to changes in the safety data sheet, or there is a change in the classification and labelling of the substance.

If you do not need to submit a CSR, you should select *REACH Chemical safety report (CSR)* from the picklist *Type of report* in IUCLID section 13 and write the justification for not providing the CSR either in the field *Further information on the attached file* or in the field *Discussion*. Please use the following justification:

"A CSR is not submitted because it is a previously notified substance which did not reach the next tonnage threshold and which does not fall within the scope of Articles 22(1)(d), 22(1)(e) and 22(1)(f) of the REACH Regulation."

• Dossier header - Derogation statement

The following derogation statement in your Dossier header has to be written in the *Dossier* submission remark field:

"This dossier is a registration update of a previously notified substance which did not reach the next tonnage threshold under the REACH regulation. It contains new and updated information."

### **Annex 5. Assessment entities in IUCLID 6**

#### Assessment entity definition

If you conclude that several sets of substance properties are needed for carrying out your assessment (see also considerations in the Guidance on Chemical Safety Assessment part D, chapter D.2), you should create assessment entities in IUCLID in order to transparently report those sets of properties.

An assessment entity (AE) is a wrapper [container] for a set of substance property data (physchem/fate/hazard) used for assessment purposes. It enables the assessor to define datasets of properties that are relevant for specific compositions/forms (placed on the market or generated upon use). These datasets are then used to assess the substance over its life cycle, reflecting its behaviour (e.g. in terms of fugacity, water solubility, absorption, degradation or transformation) in the different foreseen uses and potential changes in the hazard profile.

There are several types of AEs defined by their relation to the registered substance dataset. The possible types are:

- 1. Registered substance as such: it may be useful to create an AE for the registered substance as such when the substance as such and certain constituents or transformation products play a role in the assessment. For example, if your substance transforms, you may need the properties of both your substance before it transforms and the transformation product to carry out your assessment. Also, for multi-constituent substances, it may be that some properties depend on the constituents and impurities, but for others it is possible to consider the substance as such. It is a frequent practice to carry out human health assessment for the full substance (if vapour pressure is similar for the different constituents) but to differentiate the environmental assessment according to groups of constituents (having different physicochemical properties). If the registration covers several compositions with different hazard profiles, then the AE for "specific composition/form of the registered substance" should be defined (see below). The AE type "registered substance as such" should not be created if there is no need to group the substance as such property data.
- 2. **Specific composition/form of the registered substance**: if the registration covers compositions with different phys-chem/fate/hazard profiles, then different AEs may be created to group the relevant properties according to those compositions.
- 3. (group of) constituent in the registered substance: when the fate properties of various constituents/impurities lead to potential exposure of man and/or the environment to a composition different than the composition being used, then one or more sets of properties for (group of) constituents may be relevant for the assessment. For example, if an activity takes place at elevated temperature and the substance is composed of various constituents of various volatilities, the exposure may be to the most volatile constituents. This may also apply if the hazard of, e.g. an impurity would drive the assessment. The selection and potential grouping of constituents/impurities must be well documented.
- 4. **Transformation product of the registered substance**: the registered substance may transform in the environment or when used. Such transformation may be due to:
- i. dissociation
- ii. biotic or abiotic degradation, hydrolysis, photolysis. Ultimate degradation usually

- considers that transformation products do not need to be taken into account;
- iii. reaction during the use because of the technical function of the substance. When the substance reacts in the manufacturing of another substance which will then be registered on its own (unless exempted), the reaction products do not need to be assessed. When this is not the case, the transformation products must be assessed as part of the registration of the original substance (including for service life when only transformation products remain in the articles).

#### Assessment entity data structure

You should define your assessment approach (AE) by:

- An assessment entity name: note that this name will not be displayed in the navigation panel. You may re-name the AE by clicking on the bar at the top of the record page.
- An assessment entity composition (similar to the way compositions are defined in section 1.2 of IUCLID).
  - The composition of the AE is meant to support the understanding of what the AE consists of.

Relationship of the AE to the registered substance	Assessment entity composition
Registered substance as such	Same composition as the substance available in section 1.2
Specific composition/form of the registered substance	One or more composition can be selected from the compositions available in section 1.2
(group of) constituent in the registered substance	One or more constituent/additive/impurity which have been reported in any composition(s) - section 1.2 - can be selected
Transformation product of the registered substance	One or more reference substance can be selected

- A link to the composition(s) reported in section 1.2 (reported in the *Related composition* field). Such link is useful in case several compositions exist, used in different uses, to trace back which AE is relevant for which composition.
- Some *additional information*, when it may be needed to provide more explanation on the AE, for example in case the AE is defined for a group of constituents, the assessor may explain how the grouping had been made.

As the AE is a wrapper for sets of substance properties reported in endpoint study records and endpoint summaries in IUCLID, you must set up links to those elements (see sections below).

## Relationship between assessment entity, endpoint study records and endpoint summaries

In order to enable transparency and sorting of the information in the IUCLID data set, and to reflect this in the CSR generated by the *Report generator*, it is essential to indicate for each AE, which endpoint studies records (ESR) and related conclusions (endpoint summary) are available.

The following links are enabled in IUCLID6:

- Each endpoint study record makes reference to one test material information (TMI);
- All study records considered when assessing a specific endpoint can be linked to the related endpoint summary(EPS);
- Endpoint summaries can be linked to one or more AE. A field exists to explain the link between the endpoint summary(ies) and the AE. In this way it is possible to trace back which study records are relevant for which AE.

Figure 58: Relations between assessment entity, endpoint summary and endpoint study records





Figure 59: More detailed illustration



It is possible that the dossier contains study records which are not linked to an endpoint summary. This is the case for i) studies reported under the obligation to provide any relevant available information on the substance properties, but not (directly) used in the assessment (e.g. old study where composition is now different), and ii) ESR used to report waiving of information.

#### Link between endpoint summaries and assessment entities

You can link endpoint summaries from an AE reported in section 1.10 of IUCLID. You can select several endpoint summaries in one go and link them to the AE. In this case, an explanation valid for all summaries can be added in the note field.

An AE should be linked to only one summary per specific endpoint (for example, one AE should be linked to one boiling point summary only).

The list of summaries linked to the AE is then displayed in the AE itself.

#### Link between endpoint study records and endpoint summaries

In each endpoint summary it is possible to link all relevant studies (endpoint study records) that contribute to the summary itself. This is particularly needed when AEs exist and that several endpoint summaries are created, to ensure transparency on the information basis for the summary.

### **Annex 6. Overview of the tonnage fields in IUCLID**

This Annex provides an overview of the different fields in IUCLID dealing with tonnage information. It describes the field including which kind of tonnage is expected to be reported (individual registrant's tonnage vs EU tonnage) and what is the intended use of the information.

### **Annex 7. Opt-out justification**

To facilitate the drafting of your opt-out justification, five reasons are listed in IUCLID section 14 each with dedicated questions. At least one of the reasons must be selected; all associated questions must be answered. This information should not be provided as an attachment.

The five reasons and the associated questions are the following:

#### Reason 1: Disproportionately costly to submit this information jointly

Article 11(3) and article 19(2) of REACH requires that you submit an explanation as to why the costs would be disproportionate.

- 1. Cost of access to the jointly submitted data (amount, currency)
- 2. Cost of your opt-out (amount/currency)
- 3. Explain why the cost of submitting the relevant information jointly is disproportionate.
- 4. Describe the measures taken to agree on the cost of submitting the relevant information jointly.

# Reason 2: Disclosure of commercially sensitive information is likely to cause you substantial commercial detriment to submit jointly

Article 11(3) and Article 19(2) of REACH requires that you submit, along with the dossier, an explanation as to why disclosure of information was likely to lead to a substantial commercial detriment.

1. Commercially sensitive information that would be disclosed if submitted jointly. Consider that after registration, information from your registration dossier will be made publicly available on ECHA's website in accordance with Article 119 of REACH.

Examples of commercially sensitive information:

- Degree of purity and/or the identity of dangerous impurities or additives
- Tonnage band
- Robust study summary and study summaries
- Uses
- Trade name
- Patent-related issues
- Indication of manufacturing process
- 2. Substantial commercial detriment likely caused

#### Reason 3: Disagreement on the selection of the Annex VII-X information

Article 11(3) and Article 19(2) of REACH requires that you submit, along with the dossier, an explanation of the nature of the disagreement.

- 1. Disagreement with the lead registrant on the selection of the Annex VII-X information. For example:
- Quality (reliability, adequacy) of data
- Type of data (e.g. bibliographic data or (Q)SARs)
- Relevance of the data selected by the Lead
- Substance with specific compositions / impurity profiles
- Different data is available to fulfil same endpoint
- Disagreement on testing strategy (use of animal testing, alternative testing methods or selection of representative test substance)
  - 2. Actions taken to include your data in the Lead dossier.
  - 3. Reasons why it was not possible to include this data

# Reason 4: Disagreement on the jointly submitted classification and labelling information

Article 11(3) and Article 19(2) of REACH requires that you submit, along with the dossier, anexplanation on the nature of the disagreement.

- 1. Disagreement with the lead registrant on the jointly submitted classification and labelling information. For example, use the following as a basis for your argumentation:
- Quality (reliability, adequacy) of data used in deriving the classification
- Difference in interpretation of data for classification
- Difference in concentrations of constituents / impurities / additives influencing classification
- Difference in (nano)forms of the substance influencing classification
  - Disagreement with the lead registrant on the jointly submitted classification and labelling information. For each different classification, provide a reference to the data underlying the classification. This reference may be to information submitted in your own dossier as a (robust) study summary, or alternatively, references to publicly available literature may be provided.
  - 3. Actions taken to include your classification and labelling in the lead dossier.

#### Reason 5: Data sharing dispute

If you have received a positive decision in a data sharing dispute, please provide the data sharing dispute number. The number is in the format DSH-XX-X-XXXX-XXXX.
