We agree that the reported malformations of head, skull and brain in mice and rat, and particularly the reported exencephalies in mice, warrant classification for Repr. 1B; H360D. The data is supported by similar pattern of developmental findings reported for 2-ethylhexanoic acid, a likely hydrolysis product of the substance.
