I. Summary record of the proceedings

Item 1 - Welcome and introduction

1.1 Opening by the Vice-Chair of the Forum

The Vice-Chair welcomed all the participants. He announced apologies and stated the proxies appointed. The Vice-Chair informed that the quorum requirement was met.

1.2 Adoption of the agenda

The Vice-Chair indicated the changes in the agenda (Content IV, $\frac{\text{Annex 1}}{\text{1}}$). The agenda was adopted.

1.3 Declarations of conflicts of interest with regard to agenda items

The Vice-Chair requested all participants to declare any potential conflicts of interest for any of the agenda items, according to Article 9(2) of the Rules of Procedure. No conflicts of interest were declared in the meeting.

1.4 State of play with action points from Forum-25

The ECHA Forum Secretariat informed the plenary on the status of action points from Forum-25 and highlighted the open actions.

1.5 Practicalities and brief recapitulation of results of the written procedures between Forum-25 and Forum-26

The Vice-Chair referred to the document with the results of the written procedures between Forum-25 and Forum-26.

Item 2 - Election of the Chair and Vice-Chairs of the Forum

The Forum elected, from among the members, the new Chair and Vice-Chairs of the Forum. Before the election, all the candidates explained their motivations to the plenary.

Katja vom Hofe (DE) was elected as the Chair starting from 1 March 2017. Sinead McMickan (IE) was elected as the Vice-Chair starting from 1 March 2017 and Szilvia Deim (HU) was elected as the Vice-Chair starting from 15 May 2017.

The elected Chair of the Forum took over the chairing of the meeting.

Item 3 – Address by ECHA's Director of Risk management

The Director welcome the new Chairs and participants of Forum-26. He highlighted the preliminary results of the second Forum pilot project on Authorisation, focusing on substances that had sunset dates in 2015 and encouraged some reflection on the usefulness of the succinct summary of the risk management measures and operational conditions. The Director supported the initiative to identify frequently occurring SDS compliance problems and to start a discussion with stakeholder organisations on how they can address them. The Director welcomed the discussion on the improvement in cooperating with ASOs and stated that other ECHA Committees had positive experiences. Lastly, the Director reflected on the synergies between the Forum and the new BPR Subgroup and encouraged a close cooperation between the two.

Item 4 - Enforcement projects in Member States

4.1 Austrian experience in enforcing REACH authorisation decisions

The Forum member presented the experiences gathered after the second pilot project on Authorisation, focusing on the enforcement of authorisations decisions relevant for the DUs covered by the supply chain of the authorisation holder.

4.2 Danish national project on aerosol dispensers

The expert informed the meeting about the national enforcement project. It focused on products used in garages and auto industry since the aerosol dispensers posed a risk to human health for the workers. The inspectors assessed the worker's safety based on the information provided by the suppliers in the SDS and label. It also assessed the obligation to register all products for occupational use based on the national legislation.

The expert summarised the project's methodology and the results found. Forum members and COM welcomed the project.

Item 5 – Cooperation with other networks

5.1 Update from SLIC-CHEMEX

The chair of the CHEMEX WG informed the Forum on the ongoing activities of this network.

5.2 Information on the PARCS network

A Finnish customs enforcement representative presented on the PARCS network, its activities, objectives and deliverables.

The Forum appreciated the work of the network and encouraged future collaboration.

Item 6 – Forum's enforcement activities - Ongoing projects 6.1 Prioritisation of REF projects

6.1.2 WG progress report

The WG chair presented the progress report, which focused on the second version of the REF project methodology and the second version of the working procedure for the prioritisation of REF projects. The Forum members and COM were invited to submit new project proposals by 30 April 2017.

6.1.2 Adoption of the revised REF methodology

The WG chair highlighted the changes introduced in the new version of the document. The Forum adopted the REF project methodology and the working procedure for the prioritisation of REF projects submitted for the meeting.

The prioritisation and selection of the REF-7 project will be done according to the new version of the methodology.

As a reply to COM, the WG chair would discuss with the WG and the Forum the possibility to publish the legal duties covered by the REF projects. ECHA Forum $\frac{1}{2}$

Secretariat suggested to consider publishing a summary of the procedure for prioritising REF proposals.

6.1.3 Mandate amendment

A new chair was appointed for this WG. The Forum adopted the updated mandate (Annex 2a).

6.2 REACH-EN-FORCE-4 on Restrictions

6.2.1 WG progress report

The WG chair informed about the status of the project, presently collecting the data from the Member States. The WG discussed on elaborating a best practice document on the enforcement of restrictions to implement the Forum MAWP 2014-2018, at least for the restrictions covered within the scope of the REF-4 project.

COM suggested for the WG to reflect on the experiences gained in the project on the enforceability of restrictions and whether there could be some best practices drawn out of that. The WG chair would expect feedback from the inspectors if some severe problems were detected and should be reflected in the report.

6.2.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2b).

6.3 Enforceability of restrictions

6.3.1 WG progress report - Advice on restrictions

The Forum Chair informed about the work of the WG, which recently received two new proposals for restrictions that have passed conformity to be examined by the Forum with the view to provide an advice on enforceability. Forum members have been invited to comment on both dossiers.

The WG chair informed that the outcome of technical workshop of COM's WG on the restriction of CMRs in textile articles and clothing for consumer use was available in COM's website.

6.3.2 Update of the Compendium

A WG member informed there was no significant input from stakeholders on methods to be included in the Compendium after one year of publication and after the different requests in open sessions with the stakeholders. Therefore, it was suggested to postpone the exercise for 2018. If done next year, the WG could also take into consideration the results from the REF-4 project (e.g. information on valid used methods not included in the Compendium) as well as the new Annex XVII restrictions which were not covered in the first version of the Compendium. The Forum agreed to revise the Compendium in 2018.

The WG proposed to support the WG Substances in articles by providing advice on different analytical methods for measuring candidate list substances in articles.

6.3.3 Mandate amendment

The Forum adopted the updated mandate (Annex 2c).

6.4 Pilot project Substances in Articles

6.4.1 WG progress report

The Chair informed that the preparation of the project was ongoing and that REACH Article 33(2) was added to the scope of the project as an optional module.

6.4.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2d).

6.5 Characterisation of risks

6.5.1 TF progress report

The Chair summarised the work of the Task Force mentioning that the project would not focus on developing risk for non-compliance but on suggesting an alternative way to deal with this matter via the exchange of best practices in the Forum meetings. This possibly could be tackled when updating best practice documents. The Task Force will further elaborate a thought starter document to be presented at the Forum-27 meeting.

The project should elaborate guidelines for the use of ICSMS and elaborate on the "serious risk" as there was a need for a common understanding at EU level. It was deemed important to involve the Forum in the PROSAFE project regarding the "assessment of Risk from Chemicals in Consumer Products". The Forum nominated a Swedish expert as a Forum representative to liaise with PROSAFE.

6.5.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2e).

6.6 Implementation of PD-NEA

6.6.1 WG progress report

The Chair informed that the WG has commented on the PD-NEA User Manual and it has been sent for translation and publication. The sub-WG on the BPR elements has been analysing the requirements for biocides, together with the ECHA experts and a contractor. Moreover, after the establishment of the BPRS, it was proposed for the sub-WG to form a WG under the umbrella of BPRS at the BPRS-1 meeting. The Forum agreed to detach this sub-WG from the WG PD-NEA and move it to BPRS.

6.6.2 PD-NEA project progress report

The ECHA Forum Secretariat informed that there has been the release of PD-NEA version 2.2.1, which included improvements and fixing of bugs. There will be two more releases in 2017, mainly focusing on performance improvements.

For countries who started using RIPE in 2011 and made their first security audit in the same year, a new security audit was due during 2017 – six years after the first audit¹. The user's administrators and PD-NEA administrators would be contacted regarding this task.

6.6.3 Mandate amendment

The Forum adopted the updated mandate (Annex 2f).

6.7 REACH-EN-FORCE-6 on classification and labelling of mixtures 6.7.1 WG progress report

The Chair summarised the status of the ongoing work of this WG.

6.7.2 Mandate amendment

The Forum adopted the updated mandate (<u>Annex 2g</u>). The mandate was revisited after the discussion in agenda point 10.

6.8 Training for enforcement trainers 2017

6.8.1 WG progress report

The WG chair highlighted the work done so far by the WG in preparing the next training event, that will take place on 4 and 5 October 2017 in ECHA. The training will be on an intermediate level for topic on CLP of the mixtures and on basic level for the topic on the authorisation, meaning that the nominated trainees should have at least basic knowledge on the CLP of the mixtures. Since the content of the training would be relevant for REF-6 project, the training for REF-6's National Coordinators would take place back to back. Therefore, the Forum members were invited to appoint the REF-6 National Coordinator as one of the trainees.

6.8.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2h).

6.9 Pilot project on Control of internet sales of hazardous chemicals

6.9.1 Task Force progress report

The Chair informed that the operational phase of the project was ongoing. As a reply to a Forum member, a member of the Task Force clarified there was no specific methodology in the manual on how to use the search engine for identifying the hazardous mixtures for inspection so that Member States could approach the project according to their own priorities.

6.9.2 Operational phase: DE experiences

An expert shared some experiences gathered during the operational phase of this project as well as other national initiatives in enforcing CLP Article 48.

6.9.3 Mandate amendment

A Forum member volunteered as a chair for this Task Force, changing the status to a working group. The Forum adopted the updated mandate (Annex 2i).

6.10 Second project on Authorisation

6.10.1 WG progress report

The WG chair presented the preliminary results of the project summarising the draft report that was under consultation with the Forum.

6.10.2 Mandate amendment

The Forum agreed to close the mandate of the WG once the report was adopted. The Forum adopted the updated mandate (Annex 2j).

6.11 REACH-EN-FORCE-5 on Extended SDS, exposure scenarios, risk management measures and operational conditions

6.11.1 WG progress report

The Chair informed that the operational phase was ongoing and the WG was on hold to support the NCs during this phase. An ECHA support team was set in place to help inspections of Cluster 1 (First level suppliers) by extracting information from the CSRs into a concise and easy to understand format.

6.11.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2k).

6.12 Revision of the best practice documents

6.12.1 TF progress report

The ECHA Forum Secretariat presented the result of the first consultation within TF. The Forum discussed the open issues presented and voted to partially merge the two documents, keeping the minimum criteria elements visible as an annex to strategies for enforcement documents. The Forum also agreed with the recommendation of the Task Force to include BPR in the scope of the documents and for the BPR experts in the Task Force to prepare the BPR essential requirements in consultation with the BPR Subgroup.

The Task Force would remain in the remit of the Forum and BPR Subgroup would provide its experts to work on BPR-related revisions and be debriefed in their meetings on the progress of this work.

6.12.2 Mandate amendment

The Forum adopted the updated mandate (Annex 21).

6.13 Cooperation with Customs 2

6.13.1 TF progress report

The Chair informed that the Task Force prepared a survey to collect information on the involvement of customs with the enforcement of REACH. The information would be used to take stock of current practices in Europe and make new proposal for a workshop with DG TAXUD at the end of the year. COM representative added that the meeting would take place in November 2017 in Brussels, with the view to encourage the Customs authorities to collaborate at European level.

Forum members were invited to fill in the questionnaire after it will be launched.

6.13.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2m).

6.14 Information and Communication System for Market Surveillance (ICSMS)

6.14.1 WG progress report

The Chair informed that the REACH Directive related product information (DRPI) was not yet available and no further timelines were known. The Manual for using ICSMS was adopted by the Forum.

A Forum member stated that the use of ICSMS was still unclear, since his country has their own national system. With ICSMS, the inspectors would need to additionally log the inspections in that tool due to the impossibility to import information from other systems to ICSMS. Therefore, some clarification was still needed on what should be logged in ICSMS. The WG chair replied that some countries logged information of only the non-compliant products found whilst others logged also the compliant ones. The WG would discuss further and try proposing a common approach.

The Forum agreed on compiling a list of ICSMS National Contact Points for REACH and CLP (ref. section 4.1 of the Manual on using ICSMS) to be made available to the Forum via PD-NEA.

6.14.2 Mandate amendment

The Forum adopted the updated mandate (Annex 2n).

Item 8 - Debriefing of the meeting with ECHA Directors

The Chair summarised the discussions held with ECHA's directors.

Item 9 - Update on relevant developments by the Commission

9.1 General updates by the European Commission

The COM representative (DG GROW) gave the Forum an update of the COM's activities that were relevant for the work of the Forum.

The Forum member that attended the last ADCO Chairs meeting stressed that the lack of resources was one common challenge shared by the Forum and the other ADCOs. He also highlighted the amount of work done under the Market Surveillance regulation (MSR), which contain elements of REACH, CLP, PIC and BPR. He recommended the Forum to make the exercise of analysing the synergies between all the regulations, perhaps during the recast of the MSR.

A Forum member requested a list of the ADCO members in order to liaise with them at national level. COM to liaise with the appropriate DG.

The ECHA Forum Secretariat confirmed the possibility to have the Forum-31 meeting back to back with COM's second REACH and CLP enforcement conference. However, discussions were still being held at the management level on the resources available.

By request of an invited expert, the COM representative informed that once set, the dates for the workshop on OSH and employment will be shared with the Forum members.

9.2 REACH review and the results from the public consultation

The COM representative of DG ENV gave an overview of the status of the REACH REFIT evaluation results of the public consultation. A report will be available in July 2017.

COM representative from DG GROW provided a general information on the content of the feedback received from the consultation. The information was still being assessed for the report, which will contain a section on enforcement.

A Forum member asked whether there was work being done for the next Member State reporting exercise, in particular in the clarification of the terms used in the questionnaire. COM responded that it continues working on that.

Item 10 - Coordination between Forum and BPR Subgroup 10.1 Update on the coordination of the BPR enforcement

The ECHA Forum Secretariat summarised the agenda and main issues planned for discussion at the BPRS-1 meeting that were relevant for the Forum (see Agenda and Minutes of the BPRS-1 meeting)

Item 11 - Presentation of the Helpex tool for Forum

ECHA Forum Secretariat summarised the new fast track procedure for the practical issues procedure using the HelpEx tool. The Forum topic in the HelpEx platform and its functionalities were presented.

The members would be able to customise their notifications of the tool. It was foreseen that a new user identification would be needed to use the Forum topic in

HelpEx for those that were already HelpEx users. Hence, only the users of the Forum topic would be able to access the issues in that topic. The Forum members could also nominate other people to be given access to the platform/topic. The use of this tool for the BPRS' practical issues was not yet discussed.

Item 12 - Serbia's enforcement activities

12.1 Capacities and practices in enforcing Serbian law on chemicals

The Serbian representative presented the country's legislation related to chemicals and how they relate with the European ones as a well as an overview of the organisation of inspectors. The inspections were done at national level. Inspectors were located in three different locations but they worked under the remit of the same national institution. She informed on the national campaigns done and planned for and some general figures of chemicals investigated. Lastly, she presented the reasons Serbia would like to become an observer of the Forum.

The Chair thanked the representative for the presentation. A Forum member congratulated the presenter for the efforts to implement the enforcement of the regulations in Serbia as he had participated in joint inspections with Serbian inspectors.

The presenter added that the Serbian chemical agency provided expert assistance to enforcers in the more technically challenging cases and gave trainings. It had synergies with other ministries and academia to increase the pool of experts of different areas. There was good cooperation between the different enforcement bodies of other legislations via regular meetings.

As a reply to COM representative's on the authorisation system, the presenter informed that the authorisation process was being set in place based on the national registry.

Serbia would be willing to participate in the Forum's REF projects. There was no experiences yet regarding substance evaluation but preparations for that process were ongoing.

Serbian law provided a legal framework to classify and prevent the sale of dangerous substances to the general public.

12.2 Forum discussion on Serbia's observer status

The Chair moderated the discussion on the potential observer status of Serbia taking into consideration, amongst other criteria, the country's legislation and its proximity to the Community chemicals legislation and the readiness of their enforcement system. The Forum agreed that future observer status' requests should be considered case by case.

Item 13 - Updates from the ECHA Forum Secretariat

13.1 Status of the revision of the Forum's Multi Annual Work Programme

The ECHA Forum Secretariat presented the work done on the document MAWP, which was consulted with the Chairs and then with the Forum and BEG. The next step will be to draft the BPR-related sections, with the BPRS. Once the BPR-related sections are included, the MAWP will return to the Forum for consultation and adoption.

The Forum discussed about disclosing the Manual of Conclusions to other networks and highlighted the issue of confidentiality present in the different networks. The Forum agreed to provide a particular practical issue upon request from other networks with similar levels of confidentiality as for the Forum. Each such request

would need to be discussed and agreed with the Forum before being shared with the network.

The Forum agreed to publish the Forum level indicators after being consulted with the Forum and revise it annually. COM representative informed that COM would publish a document containing the EU level indicators.

In order to be involved in the review of ECHA's strategic perspective during the summer of 2017, the Forum would need to set up a WG in June 2017. The Forum would re-discuss the issue at Forum-27, when the extent and timing of input needed from the Forum would be clarified.

13.2 Outcome of the consultation of the non-conformities from automatic screenings

The ECHA Forum Secretariat presented the summary of the input received from the Forum members on the screening exercise presented at Forum-25 on potential cases of non-compliances that ECHA found concerns. The interested members would receive more information, as well as the number, of the cases from ECHA in order to plan and allocate resources. The Members States following the investigations were invited to report to the Forum their findings in the upcoming meetings.

13.3 Improvement of the SDS' quality - proposed actions

The ECHA Forum Secretariat presented some actions to be set in place that would help increase the quality of the SDS. The proposals were created based on the conclusions from various Forum projects that found high number of deficient SDS and the feedback provided by the Forum members. The WG Prioritisation raised several ideas of what could be done instead of setting up a project dedicated to the SDS.

The Forum mandated the TF Revision of Best practices document to consider highlighting in the strategic documents the importance of the control of SDS, by including SDS control as an integral part of each inspection (or percentage of it).

The Forum welcomed the proposal to collect information from volunteering Member States on the experiences when checking SDS, concretising on the deficiencies found and the follow-up actions, via an Excel questionnaire.

This information would then be assessed and conclusions drawn. The results could be shared with interested accredited stakeholders (ASO) and potentially join forces with Industry to tackle the issue. ASOs would be invited to – for example – disseminate the information among their members and potentially organise trainings on how to avoid the common problems with the SDSs. The Forum could take the opportunity of an open session to engage the ASOs on actions to improve the quality of the SDS amongst their members. The ECHA Forum Secretariat would contact the ASOs inquiring whether they would be interested in that exercise prior to collecting information from Member States. The proposal would need to be further concretised after discussion in the Forum-27.

Replying to an expert's concern, ECHA Forum Secretariat would investigate how to reach the suppliers of SDS that were not part of any organisation.

13.4 Template letter for contacting ORs in other Member States

The ECHA Forum Secretariat presented the draft template (model) letter and the proposed communication strategy. A Forum member expressed the need to have the information on the letter that the NEA of the Member State where the OR is located, was made aware of that communication.

The Forum agreed to make the template letter available in all EU languages and give the choice to the inspectors whether to send only the English version or additionally in the language of the Member State where the OR is located. The Forum agreed for the PD-NEA focal point(s) to be informed about the communication. The PD-NEA would also be the depository for the template letter. The template would be then transferred to the NEA's own identity header/footer.

13.5 Improvement of the cooperation with ASOs

The ECHA Forum Secretariat re-opened the discussion on the cooperation with the ASOs with the view to increase satisfaction of both Forum and ASOs and improve transparency. The Forum acknowledged the low turnout, relatively low activity of ASOs and low satisfaction of Forum and ASOs with the current cooperation model.

The Forum agreed to consult the ASOs on the Forum meeting's draft agendas and request input. On the same line, the Forum members could also signal the agenda items for which input from ASOs would be sought.

The ECHA Forum Secretariat took the initiative to include a Forum item in the agenda of the 2017 ECHA ASO workshop taking place in Brussels during autumn. In that meeting, the Forum representatives would try to find the ASO's needs regarding the Forum.

13.6 IT tool for the calculation of classification of mixtures

The ECHA Forum Secretariat informed that there was no plan for ECHA to develop an IT tool for the calculation of classification of mixtures, as this was not requested and supported at a policy level. Alternatively, the Forum could consider including this aspect in the REF-6 project as an optional action.

The REF-6 WG chair agreed to discuss it with the WG. He questioned the need to collect information during the operational phase of REF-6 on the commercial tools for the classification of mixtures. The Chair added that it could be interesting to find the inadequate IT tools that could be the target of additional investigation by the Member States.

Item 15 - Practical issues for enforcement of REACH and CLP

Issue 26.1 – Delivery of SDS via direct link

The invited expert who raised the issue presented it and the Forum discussed the proposed conclusion.

A draft conclusion was proposed and was revised at the meeting. The Forum agreed with the revised conclusion. Editorial changes could still be made during the consultation with the Forum on the inclusion of this issue in the Manual of Conclusions.

Issue 26.2 - Recovery of UVCB Substances

The Forum member who raised the issue presented it followed by a discussion with the Forum.

The issue and a conclusion would be sent for a written consultation after the meeting, as the draft conclusion was made available in a room document.

Issue 26.3 - Restricting sale of products for professionals to general public

The Forum member who raised the issue presented it and the Forum discussed the proposed draft conclusion.

The Forum agreed with the conclusion as drafted.

Issue 26.4 - Can inspectors accept test of multiconstituent substances to override CLH?

This issue was postponed until the next Forum meeting.

The ECHA Forum Secretariat reminded that issue 25.1 was still open but would be concluded and adopted via written procedure after the meeting.

The CHAIR reminded the Forum that new practical issues could be submitted by 21 April.

Item 16- Updates from the ECHA Secretariat

16.1 Enhanced completeness check

ECHA Secretariat presented a summary of the completeness check procedure and the reasons ECHA was performing enhanced completeness checks and manual verifications. The presenter clarified that checking the CSR were not in the scope of the manual verification but will be tackled in the future.

16.2 Taking action on existing registrations

ECHA Secretariat gave a presentation on the ongoing activities in ECHA's registration unit and substance ID and data sharing unit to address shortcomings that have taken place during registration. These include reinforcing the *one substance, one registration* (OSOR) principle, actions on lead registrants acting without the agreement of the joint submission and a retrospective examination of existing registrations against the revised completeness check.

A Forum member expressed appreciation for the work done that would facilitate the work of the enforcers.

16.3 ECHA's work with the Poison centres

ECHA Secretariat informed the Forum on the work undertaken in ECHA concerning the new harmonised format for poison centre notifications.

A Forum member appreciated that ECHA would be the recipient of the information since it would be practical for the NEAs to search the information that could be otherwise scattered. Forum agreed to discuss in the future plenary meetings the role of the NEAs related to the obligations to notify information to poison centres using the new harmonised format.

16.4 ECHA Interact - update and implementation plan 2017

ECHA Forum Secretariat informed on the INTERACT initiative, project update and implementation plan for 2017. The initiative aims at standardising and simplifying the interactions between Authorities and Committees (RAC/SEAC/MSC and Forum) with ECHA processes, through a single and easy-to-use portal, providing access to all relevant case and substance information. The Forum was invited to appoint a contact person for this initiative on behalf of their country/organisation. It was not necessary for all Member States to be involved at that point of the project.

16.5 Follow-up of ECHA Decisions: updates from ECHA

The Chair informed that a document was submitted with the summary of the cases sent to the Focal points by 6 March 2017.

16.6 Update on ECHA guidance activities

The Forum took note of the updates from ECHA Guidance.

16.7 Understanding downstream user information needs in the context of workplace risk assessment

ECHA Secretariat informed that ECHA was preparing a survey to better understand downstream (end) user's information needs from extended safety data sheets to help them with workplace risk assessment to be conducted in two Member States. The aim would be to better understand the needs and opportunities associated with information on safe use of substances and mixtures generated under the REACH Regulation. The Forum would be kept informed.

Item 17 - A.O.B.

17.1 Dates of the Forum meetings in 2018

The Forum took note of the dates for the Forum plenary meetings in 2018:

 Prepare proposals for the discussion with the European Commission DG TAXUD and the Customs Authorities on the possible involvement of Customs in control of REACH and CLP (and possibly aspects of PIC)

Mandate:

- Collect and list the experience of countries where Customs was involved in checking of REACH and CLP and on that basis prepara a list of specific REACH and CLP checks that could potentially be done customs authorities.
- 2. Examine the outputs of Forum WG "Cooperation with Customs" and examine if the proposals made therein are still actual.
- 3. Once it becomes available in 2017, examine the COM position on the exact extent of the role of Customs on the application of REACH, and see whether any of the proposals identified in tasks 1 and 2 fall within the scope of Customs responsibilities identified by the COM.
- 4. Prepare the Forum position for the discussion with DG TAXUD and the Customs Authorities at the workshop planned by the COM in 2017.
- 5. Propose to test in practice the proposal developped in Task 1 and if agreed with Customs and Forum, prepre, oversee and report from it.
- 6. Prepare a presentation about the Forum for the plenary meeting for the PARCS network in June or November 2017, in advance of the workshop identified in Task 4.
