I. Summary record of the proceedings

Item 1 - Welcome and introduction

1.1 Welcome and opening by the Forum Chair

The Forum Chair welcomed all the participants and opened the meeting. She announced that the Forum members from the 27 EU Member States with voting rights and the three EEA countries were attending, physically and remotely. The Chair informed that the quorum requirement was met.

1.2 Adoption of the agenda

The Chair indicated the changes in the agenda. The agenda was adopted (Content IV, Annex 1).

1.3 Declarations of conflicts of interest with regard to agenda items

No conflicts of interest were declared at the meeting according to Article 9(2) of the Rules of Procedure.

The Chair mentioned that the annual collection of declarations of interest of members of all ECHA bodies has changed and it will now be done using an IT tool. All members have received an automated email including a personal link to an ECHA portal and members were encouraged to submit their declarations by the deadline.

1.4 State of play with action points from Forum-40

The Harmonised Enforcement team (HET) informed the plenary on the status of the action points from Forum-40. A document with the latest status was provided at the meeting.

1.5 Results of the written procedures and other issues between Forum-40 and Forum-41

The Chair referred to the document with the results of the written procedures between Forum-40 and Forum-41.

Item 2 - Forum's enforcement activities - Ongoing projects

2.1 Prioritisation of REF projects

2.1.1 WG progress report

The WG chair presented the outcome of the prioritisation of the proposals for Forum projects received by the WG.

The Forum agreed with the WG to revise the projects proposals' template by the next plenary meeting.

2.1.2 Discussion of the scope of the next REF project

The WG concluded on the shortlist of two project proposals for REF-12. The Forum members discussed the options presented and agreed that the topic for REF-12 will be decided and adopted during Forum-42.

2.1.3 Mandate amendment

The Forum adopted the updated WG mandate (Annex 2a).

2.2 Enforceability of Restrictions

2.2.1 WG progress report

The WG chair presented the work done by the experts in the WG and the advice developed. He highlighted the need for the appointment of a rapporteur for one of the new restriction proposals.

The Forum raised concern about the time a rapporteur would need. To help the nomination, HET would provide an estimate of the workload and tasks of a rapporteur for this WG.

These time estimations would be provided by HET and previous rapporteurs would be inquired about their experiences.

The WG was working on the revision of the Forum process for advising on the enforceability of the restriction proposals and would present its findings in the Forum's next plenary meeting.

2.2.2 Transparency of the Forum advice on the enforceability of restrictions

The WG chair summarised the WG discussions on the implications of the (partial) publication of Forum advices through its integration in the public opinions issued by RAC and SEAC, and the receipt of "access to document" (ATD) requests for Forum advices, which needed to be assessed against the ATD Regulation.

The Forum discussed the advantages and disadvantages of the issues presented and took note of the input of ECHA legal affairs unit.

The Forum Chair debriefed the Forum on the exchange of views between the Forum and BPRS chairs with ECHA Directors. The issue of transparency was addressed, and it was proposed to organise a remote workshop for the WG Restrictions and interested Forum members.

2.2.3 Mandate amendment

The Forum adopted the updated mandate (Annex 2b).

2.3 Pilot project on classification of mixtures focusing on detergents and cleaning products

2.3.1 WG progress report

The WG chair summarised the activities of the WG and the collaboration with the ECHA Secretariat.

2.3.2 Mandate amendment

As this project, for the time being, would be a collection and analysis of practical cases, the WG mandated was modified accordingly. The Forum adopted the updated mandate (Annex 2c).

2.4 Member State reporting

2.4.1 WG progress report

The WG developped a questionnaire to survey the volunteering Member States on their reporting practices, which the Forum members will be invited to fill in.

Additionally, the WG discussed the Forum's recommendation on the use of ICSMS for cases where non-compliance was found and there was a need to coordinate on

the case with other NEAs. The COM in the EUPCN and some authorities working on the Market Surveillance Regulation had considered broader reporting to ICSMS related to the duty of Article 34 of Market Surveillance Regulation. Considering that the matter was raised at the EUPCN and its potential usefulness for the COM analysis of ICSMS data, the WG was mandated to examine if the existing Forum recommendation on the scope of use of ICSMS should be reviewed.

2.4.2 Mandate amendment

The mandate of the WG was expanded to consider whether the existing Forum recommendation on the use of ICSMS should be reviewed. The Forum adopted the mandate of the WG (Annex 2d).

2.5 REF-10 on Integrated control of products

2.5.1 WG progress report

The Forum took note that the operational phase of the project was running since January 2022 and the WG was supporting the national coordinators with any queries.

2.5.2 Mandate amendment

The Forum adopted the updated WG mandate (Annex 2e).

2.6 REF-11 on SDS

2.6.1 WG progress report

The WG chair summarised the activities of the WG in preparing this project, which aims at assessing whether duty holders have updated and provided the SDS according to the new requirements of Annex II of REACH Regulation amended by Regulation (EU) 2020/878. The project focuses on the substances and mixtures placed on the market in EU/EEA, primarily on SDS sections that have been changed by Regulation (EU) 2020/878.

The Forum endorsed the scope proposed by the WG and Forum members were invited to appoint national coordinators.

2.6.2 Mandate amendment

The Forum adopted the updated WG mandate (Annex 2f).

2.7 Train the enforcement trainers 2022

2.7.1 WG progress report

The WG chair reported that the preparations for the training were ongoing. Forum members were invited to send examples of SDS in the new format and to appoint the trainees. The training event will take place on 24-25 November 2022.

2.7.2 Mandate amendment

The Forum adopted the mandate (Annex 2g).

2.8 REF-9 on Authorisation

2.8.1 WG progress report

The WG chair informed that the WG was drafting the project report and presented the preliminary project results.

2.8.2 Project's preliminary results

The Forum took note of the results the WG had analysed so far, with the caveat that the data was still being assessed and potentially there could be changes in the results.

2.8.3 Mandate amendment

The Forum adopted the updated mandate (Annex 2h).

2.9 Pilot project on recovered substances

2.9.1 WG progress report

The WG chair informed that the WG was drafting the project report and presented the preliminary project results. The workshop with ASOs would be organised closer to the Forum's open session but it was not possible to say if it could be included in the open session.

2.9.2 Project's preliminary results

The Forum took note of the results the WG had analysed so far, with the caveat that the data was still being assessed and potentially there could be changes in the results.

Some Forum members identified some deficiencies in REACH related to the waste issues as it was difficult for REACH inspectors to know when the product ceases to be waste and whether it was in the remit of the chemical legislations. COM was encouraged to investigate and clarify those issues in the upcoming REACH review.

2.9.3 Mandate amendment

The WG requested an extension for the completion of the project report. The Forum adopted the updated WG mandate with the timeline proposed by the WG to extend the finalisation of the project report by Forum-42 (Annex 2i).

Item 4 – Forum's enforcement activities - Projects under finalisation

4.1 REF-8 on Online sales

4.1.1 WG progress report

The Forum was informed on the last activities of the WG's mandate: the finalisation of the Enforcement Guide for inspectors and the workshop with the Stakeholders to present and discuss the project's report, which took place remotely on 17 May 2022.

The WG chair summarised the discussions held in the workshop and requested the Forum to agree on the publication of the proceedings of this workshop. The Forum agreed and the proceedings were published in the Forum's website.¹

4.1.2 Mandate closure

The Forum adopted the updated WG mandate and closed the mandate (Annex 2j).

Item 5 - Cooperation with other networks

5.1 Forum's contribution to the Product Compliance Network (EUPCN) and the ADCO Chairs' meetings

The Forum took note of the information from the EUPCN and ADCO meetings attended by the Chairs and referred to in the meeting document.

5.2 Updates from SLIC-CHEMEX

The chair and co-chair of the WG CHEMEX of the Senior labour inspectors committee (SLIC) informed the Forum about the body and the work developed by this WG.

The Forum Chair welcomed to continue the cooperation between the Forum and this committee as there were many interfaces between REACH and OSH that field inspectors face during their routine work.

WG CHEMEX was also discussing the enforceability of the diisocyanates restriction, and the Forum agreed to consult the current practical issue on the same topic with the WG CHEMEX.

Item 6 - Enforcement in the Member States

6.1 French national enforcement projects 2022

The Forum took note of the organisation of the French enforcement authorities as well as on the national projects run in 2022.

Replying to the participants, the presenter clarified that the project on nano-forms was to better understand the market in France. Although F-gases were not in Forum's remit, the presenter encouraged the Forum to be open to discuss this issue. The presenter would consider sharing with the Forum their artificial intelligence tools to help better target the suspicious products.

6.2 Enforcement in Spain: structure and national organisation

The Forum took note of the structure of the Spanish enforcement authorities, their competencies, the work method used when setting up a Forum-driven project and the communication tools used to communicate the cases of non-compliance of chemical products.

Item 7 – Plenary meetings: shaping the future

7.1 Introduction

The Chair presented the topics to be discussed in the groups, which stemmed from the yearly survey to gather feedback from the Forum members. In many areas, the members were satisfied but some issues could potentially be improved, for example, the plenary meetings (frequency, agenda) and the practical issues.

7.2 Break-out-group discussion

The participants were distributed into four groups (three in person and one with all the remote attendees).

7.3 Wrap-up session

The rapporteurs from the break-out-groups summarised their discussions.

The Chair welcomed the ideas and will assess the feasibility and present some proposal for improvement in the next plenary meeting.

Item 8 - Update on relevant developments by the Commission

8.1 Enforcement issues on the Chemicals Strategy for Sustainability (CSS)

COM representative informed the Forum on the developments of the REACH and CLP revisions. The particular topic of online sales was being addressed under both regulations. The aim was to create a person responsible within the EU for imports that are directly sold to consumers.

COM was considering whether Forum could have an advisory role in the authorisation process in addition to the current restrictions process. COM was also discussing the idea of the Forum to have an equal stand as RAC and SEAC, but on the other hand it would lengthen the decision-making process which was one of the criticisms of REACH.

COM was launching a call for evidence on the possible ways to introduce changes into the Basic regulation.

Replying to a Forum member, the presenter clarified that it was planned to have an impact assessment on all solutions proposed, including those meant to strengthen enforcement. It was likely to be decided by the Impact Assessment Board in September/October 2022. It was noted that the outcome of the public call for evidence on the funding regulation would also be considered in this impact assessment.

The initiative to involve the European anti-fraud office (OLAF) to combat the illicit traffic of chemicals was still under discussion. The objective would be for OLAF to coordinate nationally with NEAs and customs via exchange of data to prevent shipments of illicit products to reach the EU citizens. For that, the REACH provisions in Title XIV would need to be revised accordingly. The Forum Chair welcomed for the Forum to be invited to participate in the discussions with OLAF and COM so that only potentially feasible proposals are assessed.

8.2 High level round table

COM representative updated the Forum on the second breakout session with the sherpas on the recommendations for enforcement which took place on 2 June 2022. The minutes were being drafted and would be shared with the participants and the Forum.

There was a presentation on the Digital Services Act, which its final adoption was expected after the summer, and it would take 15 months for its implementation. The General Products Safety Directive would be strengthened to improve the enforceability of the provisions for marketplaces and that, in certain circumstances, online marketplaces could be considered as economic operators. A pilot project on "web crawler" was initiated by following the products identified as illicit in Safety Gate/RAPEX.

The presenter clarified that the ultimate objective was to have in REACH and CLP the same obligations as in the Market Surveillance Regulation.

The changes in the Customs' legislation were also presented at the breakout session on enforcement. Discussions are taking place on different aspects: one was on how the different data systems could be compatible (information of customs' codes *versus* IUCLID date base). The authorised substances could be a good candidate to initiate the exercise. The outcome of these discussion would then be reflected in REACH, by adding or revising existing provisions.

COM representative would share with the Forum the relevant presentations and background documents.

8.3 Revocation of registration numbers

The COM representative highlighted that COM was considering adding a legal basis in REACH to facilitate ECHA to withdraw registration numbers in certain circumstances.

8.4 Future of Authorisations/Restrictions

A detailed discussion on the different proposals will be tabled for the CARACAL meeting in July. Some of the issues discussed will be the role of the candidate list and the potential coordination with OSH during the prioritisation of the SVHCs for the candidate list. The Forum welcome COM to share the final document for discussion at CARACAL.

It was not expected major changes of the current text of REACH provisions concerning restrictions. However, it would be explored the possibility to group substances but that could potentially lead to some challenges in enforcement and would increase the workload of the Forum. In the generic risk management approach (REACH Article 68(2)) are expected some changes, namely, to broaden the scope of the hazard classes and to extend to the professional uses.

On the authorisation process, the discussions were expected to go on the direction that the criteria for granting the authorisation would be the same as the exemptions for restrictions (essential use criteria).

8.5 CLP revision

The COM representative informed the Forum of the timeline of the revision of CLP (and REACH).

8.6 EU Audit Capacity

This item was not addressed since the Forum had previously discussed the issue of EAC with COM in a dedicated workshop on 9 June 2022.

8.7 Green Deal: future uniform Digital Product Passport

The digital product passport was being discussed in COM with the aim that all products should have one unique identifier in order to be marketed in the EU. Once accessed digitally, it would display all relevant information to consumers, waste operators and any other actor. Information such as the name and concentration of the substance of concern and the location of it within the product would be displayed.

A Forum member raised the concern that the information in the passport might not be truthful to the actual content of the product and hence enforcers would need to take samples and run tests. In case there is discrepancies, the responsible person should be prosecuted. However, there was no legal provisions to avoid this abuse.

An invited expert reminded of the existence of the SCIP database and its similar aim as the proposed registry of products for the digital product passport.

8.8 Environmental Crime Directive

The presenter summarised the novelties of the adopted proposal on the new Environmental Crime Directive, that would cover restrictions and authorisations and all CLP provisions. He explained how it would work when environmental offences were identified and gave some practical examples.

Some Forum members shared their prosecution practices in their Member State. Replying to a Forum member, the presenter clarified that the Directive would need to be transposed to the national law and therefore there could be appeals in national criminal courts.

Item 10 - Updates from BPR Subgroup

The BPRS Chair briefed the Forum on the issues discussed at the BPRS-16 plenary meeting². In particular, the speaker updated the members on the state-of-play for the BEF-2 project: the project was running its operational phase and a workshop for all national coordinators was organised back-to-back with BPRS-16.

A dedicated WG was organising the BPRS training event, which will be delivered remotely on 18 November 2022. The training will be focused on CLP for biocides, *in situ* generating systems, and BPR borderline issues.

The BPRS also followed-up on the issue presented in the last open session by the European Ozone Trade Association regarding the non-compliance of *in-situ* devices and was gathering experiences from national enforcement.

Item 11 - Debriefing of the meeting with ECHA Directors

The Chairs informed the Forum about the discussions that took place during the meeting with the ECHA Directors on 12 June 2022. The topics addressed were the 1) Transparency of the Forum's advice of the enforceability of restrictions and 2) European Audit Capacity.

Item 12 – Practical issues for enforcement of REACH, CLP, PIC and POPs

The Chair informed that there were two issues re-opened in the HelpEx tool due to absence of feedback. The Forum members were invited to revisit such issues.

Forum discussed the practical issues relevant to enforcement. Members were invited to submit new practical issues by 19 September 2022.

Issue 41.1 – Training requirements under the training under the diisocynataes restriction

The submitters summarised the issue and HET presented the draft conclusion.

COM representative informed that this point would be addressed in the REACH committee meeting, but it was COM's idea to refer the discussion to the Forum as it was the most appropriate body for this discussion. She added that ISOPA was requesting payment for its trainings.

The submitter found the draft conclusion was not concrete enough in order to be useful for inspectors and welcomed another written consultation. The Forum members were invited to liaise with the national OSH authorities and provide their feedback to this issue. HET would inform SLIC-CHEMEX that consultation on this practical issue was taking place nationally.

Issue 41.2 – What is the definition of the term 'industrial site' used in the context of Annex VIII to CLP?

The submitter summarised the issue that consisted of the fact that in section 2.4, paragraph (3) of Part A of Annex VIII to CLP, the term 'industrial site' is used in the definition of the term 'mixture for industrial use'. The importers and downstream users who are placing on the market mixtures for industrial use are not required to comply with Annex VIII until 1 January 2024, and can use the national systems of submission that were already in place. Therefore, a clarification of the term 'industrial site' is required so that both dutyholders and enforcement authorities have the same understanding.

The Forum members discussed the issue and comments will be collected in a written consultation after the meeting in order to draft a conclusion.

Issue 41.3 – Responsibility of agents in making available products on the market

The submitter summarised the issue of a company that acts as an intermediate between a producer/importer of an article and the retailers. This company acted as single contact point (promotes the product, places orders, etc.) and were not involved in the transactions. It was not clear what kind of responsibilities such company have when the article in question has found non-compliant with REACH Article 67 and Annex XVII. The national enforcement authorities took some actions such as withdrawal of the non-compliant article from the market.

The Forum members discussed the issue and comments will be collected in a written consultation after the meeting in order to draft a conclusion.

Item 13 – Updates from the ECHA Secretariat

13.1 Practical consequences of the new approach of tonnage downgrade after draft dossier evaluation decision

The Forum took note on the approach towards the provision of new information in dossier evaluation following the Board of Appeal (BoA)decision of the cases A-006/007-2020 in respect to tonnage downgrade and the potential abuse of the process. In the past, tonnage downgrade received after the draft decision was not considered by ECHA. After the BoA decision, tonnage band updates received after the draft decision (but before final decision) will be considered as substantial new information which ECHA is required to take into account during the compliance check process.

The requirement to take into account substantial new information which comes to light after the expiry of the deadline to provide comments on the <u>draft</u> decision, may also mean that the Agency is required to re-start, or repeat certain steps of the decision-making procedure set out in REACH Articles 50 to 52. ECHA needed to define what was considered as substantial new information, how ECHA should be informed about it and what information must be provided to demonstrate tonnage downgrade or when new experimental studies become available.

Forum requested that ECHA investigates how many dossier evaluation decisions have been sent to NEAs for enforcement, where the tonnage downgrade was requested after the draft decision.

Replying to a Forum member, the presenter agreed that the cases dealing with ORs were complex and the change in the ECHA process would not solve the issue. The Board of Appeal decision would not have an impact on the Substance Evaluation process. In case a company decided to upgrade the tonnage after a downgrade,

ECHA did not have a process in place yet and could consider to re-issue the decision, depending on the case.

13.2 ECHA's work on groups of substances and cases of (potential) noncompliance

The Forum took note of the work being developed by ECHA on the prioritisation and grouping of substances, generating assessments of regulatory needs (ARNs) of group of substances. During such work, it could be identified some cases of potential non-compliance which the Forum was invited to consider whether to pursue them. As an initial proposal, ECHA identified 10 cases that could be used as pilot cases to set-up a procedure and instruct ECHA experts working with the ARNs. The Forum members were invited to consider taking part of the pilot and to use the process in place for the Interlinks. Some Forum members expressed interest in follow-up on the cases identified by ECHA and requested ECHA to send all the relevant information to facilitate the enforcement. ECHA would identify the number of cases and contact the respective Member States if they were willing to participate in the proposed pilot.

Replying to a Forum member, the presenter clarified that the reports of the ARNs of the groups did not yet include any information on enforceability, but the process was still developing.

Item 14 – Updates from the ECHA Harmonised Enforcement team 14.1 Follow-up of ECHA Decisions

The Forum took note on the statistics about the cases sent to the Member States Focal points until 30 May 2022.

14.2 Update on the enforcement implications of UK withdrawal

The Forum took note of the summary of the discussions between CY, ES, IE and NL Forum members about the impact of UK withdrawal. It generated few challenging enforcement situations, especially on the issue of reimport: many importers from UK claim they benefit from reimportation. The Forum's practical issue on this would need to be revised to reflect the UK withdrawal situation.

14.3 Update on the engagement and improvement actions

The Forum was informed on status of the actions for HET derived from the discussions on the Forum's engagement during 2021.

HET prepared an induction document for Forum and WG members explaining the rights and responsibilities of chairs and members, mode of work and expected workload. Forum members were consulted, and the revised version of the document was submitted for the meeting. In case of any additional comments, Forum members were invited to send feedback by the end of June and after that, the document will be finalized.

21 Forum members and alternates expressed their interest in participating in the remote training in chairing meetings. HET will contact the interested participants to check their availability to book the training.

In order to emphasize the importance of the Forum's work, the Executive Director invited the Management Board and CA members to highlight the importance of harmonised enforcement and appropriate resourcing of Forum work and allow for more robust resourcing of the Forum and the Committees. As discussed at Forum-40, such letter will be sent to all countries and co-signed by ECHA Executive

Director and Forum Chair. Some Members have been indicating the best addressee of such letter in their country. Not all have responded and could so by beginning of July, otherwise the letter would be sent to the Management Board member. HET planned to send the letters in the late summer.

14.4 Dates of Forum meeting in 2023

Chair informed on the dates of the plenary meeting in 2023:

14.5 Revision of the guide on enforcement on registration

HET highlighted the proposal for the change in the Practical Guide on enforcement of registration duties (REF-7) to improve the formulation of the question regarding the tonnage band in the registration dossier. During discussions in ECHA about the Implementing Regulation on updates, it was observed some discrepancies on the way inspectors reported that question which led to the conclusion that the question was being misinterpreted.

Therefore, the Forum members were questioned on the proposed changes in the wording of the Q 2.6. to remove any ambiguity. The Forum agreed with the changes and to refer to the Implementing Regulation. Consequently, HET will update the document and inform the Forum members of these changes.

Item 15 - A.O.B.

15.1 ECHA screening of registrations to verify update duties – new campaign

The Forum took note of the information regarding the new and last screened campaign on dossier updates. ECHA has done a preliminary check on registrations for substances with harmonised classification and labelling and have concluded that around 200 registrations would be in scope for the exercise. This campaign was planned to be launched during summer 2022, leaving the registrants until autumn 2022 to update their registrations.

ECHA welcomed the NEAs support for those cases, where registration remains incompliant even after the campaign. It was expected a not very high number of such cases and thus not causing much workload on NEAs.

15.2 Update on ECHA's Follow-up of Dossier Evaluation decisions team

Forum took note of the new contact point for Follow-up on ECHA's decision.

15.3 Topics for Training for Enforcement Trainers event 2023

The Forum members were invited to submit proposals for three topics as subject for the 2023 Training event and rank them by priority. The proposals received would be discussed with the Forum Chairs and be brought for Forum-42 for decision.
