

Austria presented a proposal in accordance with Article 59(3) and Annex XV of the REACH Regulation (26 June 2008, submission number AJ017046-57) on identification of bis(2-ethylhexyl)phthalate as a substance of very high concern because of its properties as toxic for reproduction.

The Annex XV dossier was circulated to Member States on 30 June 2008 and the Annex XV report was made available to Interested Parties on the ECHA website on the same date according to Articles 59(3) and 59(4).

Comments were received from both Member States and Interested Parties on the proposal.

The dossier was referred to the Member State Committee on 15 September and agreed in the written procedure of the Member State Committee with closing date of 1 October 2008.

**Agreement of the Member State Committee in accordance with Article 59(8):**

Bis(2-ethylhexyl)phthalate is identified as a substance of very high concern because it fulfils the criteria of Article 57 paragraph (c) of Regulation (EC) 1907/2006 (REACH).

**UNDERLYING ARGUMENTATION  
FOR IDENTIFICATION OF SUBSTANCE OF VERY HIGH CONCERN**

According to Annex I to Directive 67/548/EEC, bis(2-ethylhexyl)phthalate is classified as substance toxic to reproduction Repr. Cat. 2; R60-61 (May impair fertility; May cause harm to the unborn child).
