On an authorisation of biocidal product family Korasit NG Biocidal Product Family through mutual recognition in Latvia

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by Kurt Obermeier GmbH on 9th June 2023 concerning an authorisation of the biocidal product family **Korasit NG Biocidal Product Family** through mutual recognition in sequence.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for the biocidal product family **Korasit NG Biocidal Product Family** developed by the reference Member State – Netherlands.

Therefore, in accordance with Article 33 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products* (regulation 528/2012) LEGMC authorises the biocidal product family **Korasit NG Biocidal Product Family** on the basis of mutual recognition process.

The biocidal product family **Korasit NG Biocidal Product Family** contains the following active substances:

- permethrin (CAS No.: 52645-53-1; EC No.: 258-067-9), concentration 0.269 – 2.69 %,
- tebuconazole (CAS No.: 107534-96-3; EC No.: 403-640-2), concentration 0.156 – 1.56 %,
- propiconazole (CAS No.: 60207-90-1; EC No.: 262-104-4), concentration 0.15 – 1.5 %.

LEGMC assigns the authorisation number LV/2023/MR/012 for the biocidal product family Korasit NG Biocidal Product Family.

The authorisation is valid until 2nd October 2025.

In accordance with Article 22(2)(d) of the Regulation (EU) 528/2012 authorisation numbers with the following suffix for biocidal products within family are indicated in the following table:

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of biocidal product family **Korasit NG Biocidal Product Family** through mutual recognition is granted on the following terms:

- Product type: 8 – Wood preservatives;
- Target organism: wood rotting fungi (*Basidiomycetes*), house longhorn beetle (*Hylotrupes bajulus L.*) and termites (*genus Reticulitermes*);
- Users: non-professional (general public), professionals, trained professionals and industrial;
- Product description: soluble concentrate (meta-SPC 1 and meta-SPC 2), ready-to-use liquid (meta-SPC 3);
- Product stability: 24 months.

The authorisation through mutual recognition applies only to the biocidal product family **Korasit NG Biocidal Product Family** in the composition, form and packing material for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the biocidal product family **Korasit NG Biocidal Product Family** should be as it is indicated in the first authorisation of above mentioned biocidal product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of *regulation 528/2012*,
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006*,
- all other relevant legislation shall be applied.

Kurt Obermeier GmbH as the authorisation holder shall inform LEGMC about any changes in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18th April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.*

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of biocidal product family **Korasit NG Biocidal Product Family** through mutual recognition may be re-opened for review before the 2nd October 2025.

Additionally, LEGMC would like to inform that Kurt Obermeier GmbH is fully responsible of the content of the biocidal product family **Korasit NG Biocidal Product Family** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Kurt Obermeier GmbH to notify the above mentioned information down to supply chain.
