CONCLUSION

The biocidal product MURIBROM PRO BROMADIOLONE (additional tradenames: QM PRO BROMADIOLONE, BR PRO BROMADIOLONE, DIPTRON PRO BROMADIOLONE) to be authorised in Poland is the same biocidal product as AGRORAT BD-5 PASTA PRO (Case Number in R4BP: BC-LS014250-38, Asset Number in R4BP: ES-0005692-0000, Authorisation number: ES/APP(NA)-2018-14-00153) authorised in Spain. The Polish CA agrees with the Product Assessment Report for the renewal of the authorisation of the biocidal product AGRORAT BD-5 PASTA PRO conducted by the Spanish CA and renews the authorisation of the product MURIBROM PRO BROMADIOLONE (additional tradenames: QM PRO BROMADIOLONE, BR PRO BROMADIOLONE, DIPTRON PRO BROMADIOLONE) in Poland.

Specific conditions applying to the active substance bromadiolone laid down in the Commission Implementing Regulation (EU) No. 2017/1380 were considered for the re-assessment of the biocidal product AGRORAT BD-5 PASTA PRO.

The assessment presented in the Product Assessment Report has shown that the ready-to-use product, AGRORAT BD-5 PASTA PRO with the active substance bromadiolone, at a level of 0.005% w/w, may be authorised for use as a rodenticide (product-type 14) since the conclusions of initial evaluation remain valid.

MURIBROM PRO BROMADIOLONE (additional tradenames: QM PRO BROMADIOLONE, BR PRO BROMADIOLONE, DIPTRON PRO BROMADIOLONE) is granted in Poland as a rodenticide product against house mice (*Mus musculus*) and brown rats (*Rattus norvegicus*). It is to be used: (1) indoors and outdoors around buildings by professional, (2) outdoor open areas and waste dumps by trained professional. It is a ready to use pasta bait to be used in tamper-resistant bait stations. The Polish CA renews the first authorization of the product MURIBROM PRO BROMADIOLONE (additional tradenames: QM PRO BROMADIOLONE, BR PRO BROMADIOLONE, DIPTRON PRO BROMADIOLONE) based on the Product Assessment Report for the renewal of the authorisation of the biocidal product AGRORAT BD-5 PASTA PRO.

Anticoagulant rodenticides are considered essential to ensure appropriate rodent control by efficient pest management and as a consequence, to prevent or control any serious danger to human and animal health which rodents may cause.

Non-renewal of anticoagulant rodenticides could lead to insufficient rodent control. It could not only cause significant negative impact on human or animal health, or the environment, but could also affect the public's perception of its safety with regard to exposure to rodents or the security of a number of economic activities that could be vulnerable to rodents, resulting in economic and social consequences.

Conditions for the renewal of the biocidal product MURIBROM PRO BROMADIOLONE (additional tradenames: QM PRO BROMADIOLONE, BR PRO BROMADIOLONE, DIPTRON PRO BROMADIOLONE) in Poland.

The biocidal product will be authorised according to Article 19 (5) of Regulation (EU) No. 528/2012 (BPR) in conjunction with Article 23 (6) of the BPR. According to Article 23 (6) of the BPR, the authorisation of the product will be renewed for 5 years.
