Amendment to the Norwegian authorisation of the Union Authorised biocidal product family – INSECTICIDES FOR HOME USE - EU-0021035-0000

We refer to your amendment of the implemented decision in EEA countries and Switzerland (EE-AAT) to the authorisation of the biocidal product family INSECTICIDES FOR HOME USE - EU-0021035-0000, R4BP 3 Case number BC-FK075174-39. The Norwegian Environment Agency hereby amends the Norwegian authorisation.

Background

Regulation (EU) No. 528/2012 concerning the making available on the market and use of biocidal products (the Biocidal Product Regulation, BPR) and Commission Implementing Regulation (EU) No 354/2013 concerning changes of biocidal product authorised in accordance with BPR are implemented in Norwegian law through the Norwegian Biocide Regulation of 18 April 2017 No. 480.

According to Article 50(2) of the BPR, the authorisation holder of a Union Authorisation seeking to change any of the information submitted in relation to the initial application of the authorisation, shall apply the Agency. The Agency shall examine, and the Commission decide whether the conditions of Article 19 or, where relevant, Article 25, are still met and whether the terms and conditions of the authorisations need to be amended.

The amendment of the implemented decision concerns addition of trade names for the Norwegian market to Meta SPC 1 in the biocidal product family as referred to in Section 1 of Title 1 of the Annex in Commission Implementing Regulation (EU) No 354/2013. The following trade names have been added:

- BEAPHAR OMGEVINGSSPRAY BINNEN INSECTICID
- BEAPHAR UMGEBUNGSSPRAY INNEN INSECTICIDE
