### **On an authorisation of the same biocidal product FERCE-CMT-10**

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **Ferbi S.r.l.** on 26<sup>th</sup> May 2020 concerning an authorisation of **FERCE-CMT-10** according to *Commission Implementing Regulation (EU) No 414/2013 of 6 May 2013 specifying a procedure for the authorisation of same biocidal products in accordance with Regulation (EU) No 528/2012 of the European Parliament and the Council (Regulation (EU) No 414/2013)*.

The reference product is **Free Land 10EC** (authorisation number - **LV/2023/MR/002**) authorised through mutual recognition in Latvia 28<sup>th</sup> February, 2023. Authorisation holder is **Activa S.r.l.**, Via Feltre 32, 20132 Milano, Italy.

**Ferbi S.r.l.** submitted application for authorisation of a same biocidal product **FERCE-CMT-10** according to Article 2 of the Regulation (EU) No 414/2013.

LEGMC accepted and agreed with proposed differences between **FERCE-CMT-10** and **Free Land 10EC** that is the subject on an administrative change in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council (Regulation (EU) No 354/2013)*.

Therefore, in accordance with Article 5 of Regulation (EU) No 414/2013 LEGMC grants the authorisation of the same biocidal product the **FERCE-CMT-10**.

Additional trade names for **FERCE-CMT-10** in Latvia are:

- *SPECTRUM EC*;
- *POWER EC*;
- *WACIP 1000*.

**FERCE-CMT-10** contains **10.53 % (w/w)** of (RS)- $\alpha$ -cyano-3phenoxybenzyl-(1RS)-cis, trans-3-(2,2-dichlorovinyl)-2,2-dimethylcyclopropanecarboxylate (Cypermethrin) (CAS No. 52315-07-8; EC No. 257-842-9) as active substance.

**LEGMC assigns the authorisation number for same biocidal product FERCE-CMT-10:**

**LV/2023/SB/002**

**The authorisation of FERCE-CMT-10 is valid until 16<sup>th</sup> February 2033.**

The authorisation number of **FERCE-CMT-10** shall be indicated on the label of the biocidal product.

The authorisation of **FERCE-CMT-10** is granted on the following terms:

- Product type: 18 – Insecticides, acaricides and products to control other arthropods;
- Target organism – German cockroach (*Blattella germanica*), Oriental cockroach (*Blatta orientalis*), Garden ant (*Lasius niger*) and Tiger mosquito (*Aedes albopictus*);
- Users: trained professionals, professionals and general public;
- Product description: Emulsifiable concentrate;
- Product stability: shelf life – 2 years;

The authorisation applies only to the same product **FERCE-CMT-10** in the form and composition, form and packing according to the reference product **Free Land 10EC** for which the first authorisation is granted by reference Member State – Greece.

The information on the label (and if applicable an enclosed instruction of use) of the **FERCE-CMT-10** should be as it is indicated in the first authorisation for **Free Land 10EC**, taking into account Product Assessment Report, summary of Product Characteristics and proposed differences for same product.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of *Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products*,
- *Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006*,
- all other relevant legislation shall be applied.

**Ferbi S.r.l.** as the authorisation holder shall inform LEGMC about any changes in accordance with *Regulation (EU) No 354/2013*.

Additionally, LEGMC would like to inform that **Ferbi S.r.l.** is fully responsible of the content of the biocidal product **FERCE-CMT-10** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask **Ferbi S.r.l.** to notify the above mentioned information down to supply chain.
