Whereas

- (1) Pursuant to Article 59 of Regulation (EC) No 1907/2006 of the European Parliament and of the Council of 18 December 2006 concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH) the European Chemicals Agency received from Member States 11 Annex XV dossiers for substances which in their opinion meet the criteria of substances of very high concern set out in Article 57 of REACH.
- (2) The Agency invited all interested parties and Member States to submit comments on the Annex XV dossiers.
- (3) The commenting period ended on 14 October 2010.
- (4) The Agency received comments on the identification as a substance of very high concern for 1,2,3-Trichlorobenzene, 1,2,4-Triclorobenzene, 1,3,5-trichlorobenzene, 2-Ethoxyethanol, 2-Methoxyethanol, Cobalt(II) sulphate, Cobalt(II) dinitrate, Cobalt(II) diacetate, Cobalt(II) carbonate, Chromium trioxide and Acids generated from Chromium trioxide and their oligomers.
- (5) Pursuant to Article 59(7) of REACH these substances were referred to the Member State Committee.
- (6) The Member State Committee unanimously agreed via written procedure, which closed on 25 November 2010, and at its 15th meeting (1-3 December 2010) that 2-Ethoxyethanol, 2-Methoxyethanol, Cobalt(II) sulphate, Cobalt(II) diacetate, Cobalt(II) carbonate, Chromium trioxide and Acids generated from chromium trioxide and their oligomers should be identified as substances of very high concern.
- (7) The Member State Committee unanimously agreed at its 15th meeting that, based on the information available, it is not possible to conclude on the identification of 1,2,3-Trichlorobenzene, 1,2,4-Trichlorobenzene and 1,3,5-trichlorobenzene as substances of very high concern in accordance with Article 57(f) of REACH.
- (8) Pursuant to Article 59(8) of REACH the Agency should now include the substances identified as substances of very high concern in the candidate list for eventual inclusion in Annex XIV.
