On an authorisation of the same biocidal product FERPASTA BRODI 25

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **FERBI S.r.l.** on 30th July 2018 concerning an authorisation of **FERPASTA BRODI 25** according to Commission Implementing Regulation (EU) No 414/2013 of 6 May 2013 specifying a procedure for the authorisation of same biocidal products in accordance with Regulation (EU) No 528/2012 of the European Parliament and the Council (Regulation (EU) No 414/2013).

The reference product is *ACTIPASTA-BROD* (authorisation number - LV/2018/MR/021) authorised through mutual recognition in Latvia 16th October, 2018. Authorisation holder is **Activa s.r.l.**, Via Feltre, 32, 20132 Milano, Italy.

FERBI S.r.l. submitted application for authorisation of a same biocidal product FERPASTA BRODI 25 according to Article 2 of the Regulation (EU) No 414/2013.

LEGMC accepted and agreed with proposed differences between FERPASTA BRODI 25 and ACTIPASTA-BROD that is the subject on an administrative changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council (Regulation (EU) No 354/2013).

Therefore, in accordance with Article 5 of Regulation (EU) No 414/2013 LEGMC grants the authorisation of the same biocidal product the FERPASTA BRODI 25.

FERPASTA BRODI 25 contains **0.0025** % (w/w) of brodifacum (CAS No. 56073-10-0; EC No. 259-980-5) as active substance.

The authorisation of FERPASTA BRODI 25 is valid until 31st December 2022.

The authorisation number of FERPASTA BRODI 25 shall be indicated on the label of the biocidal product.

The authorisation of **FERPASTA BRODI 25** is granted on the following terms:

- Product type: 14 Rodenticides.
- Target organism House mice (Mus musculus) and brown rat (Rattus norvegicus);
- Users: professional and general public;
- Product description: Paste bait ready-to-use;
- Product stability: shelf life 2 years:
- Use area: indoor, outdoor around buildings:

The authorisation applies only to the same product FERPASTA BRODI 25 in the form and composition, form and packing according to the reference product ACTIPASTA-BROD for which the first authorisation is granted by reference Member State – Italy.

The information on the label (and if applicable an enclosed instruction of use) of the FERPASTA BRODI 25 should be as it is indicated in the first authorisation for ACTIPASTA-BROD, taking into account Product Assessment Report, summary of Product Characteristics and proposed differences for dame product.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products,
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.

FERBI S.r.l. as the authorisation holder shall inform LEGMC about any changes in accordance with Regulation (EU) No 354/2013.

Additionally LEGMC would like to inform that FERBI S.r.l. is fully responsible of the content of the biocidal product FERPASTA BRODI 25 as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask FERBI S.r.l. to notify the above mentioned information down to supply chain.
