The trap is to be used to attract and a trap fruit flies, it can be used in house (in kitchens, pantries, as well as in front of windows, sinks, garbage cans, composts, etc.).

The trap is place in an adhesive panel folded into a triangle.

- Exchange sticky trap in case it should be covered with fruit flies

- IF ON SKIN: Wash skin with water. If symptoms occur call a POISON CENTRE or a doctor.
- IF IN EYES: If symptoms occur rinse with water. Remove contact lenses, if present and easy to do. Call a POISON CENTRE or a doctor.
- IF SWALLOWED: If symptoms occur call a POISON CENTRE or a doctor.
- IF INHALED: not applicable.
