## On an authorisation of the biocidal product TWP 097i.

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **TROY CHEMICAL COMPANY BV** on 22 May 2019 concerning an authorisation of **TWP 097i.** through mutual recognition in sequence.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for **TWP 097i.** developed by the reference Member State – Denmark.

Therefore, in accordance with Article 33 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (Regulation (EU) No 528/2012), LEGMC authorises the **TWP 097i.** on the basis of mutual recognition process.

The authorisation holder for TWP 097i. in Latvia is:

#### TROY CHEMICAL COMPANY BV.

The biocidal product TWP 097i. contains following active substances:

- *3-iodo-2-propynylbutylcarbamate (IPBC)* (CAS No 55406-53-6, EC No 259-627-5), concentration 0.75%;
- (3-phenoxyphenyl)methyl 3-(2,2-dichloroethenyl)-2,2-dimethylcyclopropane-1-carboxylate (Permethrin) (CAS No 52645-53-1, EC No 258-067-9), concentration 0.25%;
- 1-[[2-(2,4-dichlorophenyl)-4-propyl-1,3-dioxolan-2-yl]methyl]-1H-1,2,4-triazole (Propiconazole) (CAS No 60207-90-1, EC No 262-104-4), concentration 0.24%

## LEGMC assigns the authorisation number for biocidal product TWP 097i.:

# The authorisation is valid until 20 January 2028.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of TWP 097i. through mutual recognition is granted on the following terms:

- Product type: 8 Wood preservative;
- Target organism: wood rotting fungi (Gloeophyllum trabeum; Poria placenta; Coniophora puteana); blue stain (Sydowia pithyophilia; Aureobasidium pullulans spp.); insects (Hylotrupes bajulus (larvae)); termites (Reticulitermes sp. (workers, soldiers and nymphs));
- Users: professionals and amateurs (non-professionals);

- Product description: wood preservative for amateur and professional applications by brushing and rolling at an application rate of 200 mL/m<sup>2</sup> in use class 2 and 3;
- Field of use outdoors. For use on softwood only;
- Product stability: up to 2 years;
- Pack sizes and packaging material: as indicated in Summary of Product Characteristics.

The authorisation through mutual recognition applies only to the product **TWP 097i.** in the composition, form and packing for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the **TWP 097i.** should be as it is indicated in the first authorisation of above mentioned product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 Regulation (EU) No 528/2012;
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006;
- all other relevant legislation shall be applied.

TROY CHEMICAL COMPANY BV shall inform LEGMC about any changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18<sup>th</sup> April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of **TWP 097i.** through mutual recognition may be re-opened for review before 20 January 2028.

Application on renewal of an authorisation shall be submitted according to Commission Delegated Regulation (EU) No 492/2014 of 7 March 2014 supplementing Regulation (EU) No 528/2012 of the European Parliament and of the Council as regards the rules for the renewal of authorisations of biocidal products subject to mutual recognition.

Additionally LEGMC would like to inform that TROY CHEMICAL COMPANY BV is fully responsible of the content of the biocidal product **TWP 097i.** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask TROY CHEMICAL COMPANY BV to notify the above mentioned information down to supply chain.
