## On an authorisation of biocidal product family Primer TIP through mutual recognition in Latvia

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by Lanxess Deutschland GmbH on 29<sup>th</sup> April 2016 concerning an authorisation of the biocidal product family **Primer TIP** through mutual recognition in parallel.

LEGMC has agreed with Product Assessment Report and Summary of Product Characteristics for the biocidal product family **Primer TIP** developed by the reference Member State – Germany.

Therefore, in accordance with Article 34 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products (regulation 528/2012) LEGMC authorises the biocidal product family **Primer TIP** on the basis of mutual recognition process.

The biocidal product family **Primer TIP** contains the following active substances:

- tebuconazole (CAS No.: 107534-96-3; EC No.: 403-640-2), concentration 0.2 %,
- 3-iodo-2-propynyl butylcarbamate (CAS No.: 55406-53-6; EC No.: 259-627-5), concentration 0.5 %
- permethrin (CAS No.: 52645-53-1; EC No.: 258-067-9), concentration 0.06 %.

## LEGMC assigns the authorisation number LV/2022/MR/011 for the biocidal product family Primer TIP.

## The authorisation is valid until 10<sup>th</sup> August 2027.

In accordance with Article 22(2)(d) of the Regulation (EU) 528/2012 authorisation numbers with the following suffix for biocidal products within family are indicated in the following table:

The authorisation number shall be indicated on the label of the biocidal product.



The authorisation of biocidal product family **Primer TIP** through mutual recognition is granted on the following terms:

- Product type: 8 Wood preservatives;
- Target organism wood destroying fungi (brown and white rot fungi), wood discolouring fungi and wood boring insects (shown by *Hylotrupes bajulus*);
- Users: non-professional (general public), professionals and industrial;
- Product description: Ready-to-use liquid;
- Product stability: shelf life 24 months in coated tin containers and 12 months in HDPE containers.

The authorisation through mutual recognition applies only to the biocidal product family **Primer TIP** in the composition, form and packing material for which the first authorisation is granted by reference Member State.

The information on the label (and if applicable an enclosed instruction of use) of the biocidal product family **Primer TIP** should be as it is indicated in the first authorisation of above mentioned biocidal product, taking into account also the information which is stated in the Product Assessment Report and Summary of Product Characteristics issued by reference Member State.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of regulation 528/2012,
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.

Lanxess Deutschland GmbH as the authorisation holder shall inform LEGMC about any changes in accordance with Commission Implementing Regulation (EU) No 354/2013 of 18<sup>th</sup> April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council.

If the first authorisation issued by reference Member State is amended or revoked, the authorisation of biocidal product family **Primer TIP** through mutual recognition may be re-opened for review before the  $10^{th}$  August 2027.

Additionally, LEGMC would like to inform that Lanxess Deutschland GmbH is fully responsible of the content of the biocidal product family **Primer TIP** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask Lanxess Deutschland GmbH to notify the above mentioned information down to supply chain.
