On an authorisation of the same biocidal product Pullex Primer

Latvian Environment, Geology and Meteorology Centre (LEGMC) has evaluated an application submitted by **ADLER-Werk Lackfabrik Johann Berghofer GmbH & Co KG** on 31st October 2023 concerning an authorisation of **Pullex Primer** according to *Commission Implementing Regulation (EU) No 414/2013 of 6 May 2013 specifying a procedure for the authorisation of same biocidal products in accordance with Regulation (EU) No 528/2012 of the European Parliament and the Council (Regulation (EU) No 414/2013).*

The reference product is *Primer TIP A* (authorisation number - *LV/2022/MR/011/02/001*) authorised through mutual recognition in Latvia on 17th October, 2022. Authorisation holder is **Lanxess Deutschland GmbH**, Kennedyplatz 1, 50569 Köln, Germany.

ADLER-Werk Lackfabrik Johann Berghofer GmbH & Co KG submitted application for authorisation of a same biocidal product **Pullex Primer** according to Article 2 and 3(1) of the Regulation (EU) No 414/2013.

LEGMC accepted and agreed with proposed differences between **Pullex Primer** and **Primer TIP A** that are the subject on an administrative change in accordance with *Commission Implementing Regulation (EU) No 354/2013 of 18 April 2013 on changes of biocidal products authorised in accordance with Regulation (EU) No 528/2012 of the European Parliament and of the Council (Regulation (EU) No 354/2013).*

Therefore, in accordance with Article 5 of Regulation (EU) No 414/2013 LEGMC grants the authorisation of the same biocidal product **Pullex Primer**.

Additional trade names for **Pullex Primer** in Latvia are align with summary of product characteristics (SPC).

The biocidal product **Pullex Primer** contains the following active substances:

- tebuconazole (CAS No.: 107534-96-3; EC No.: 403-640-2), concentration 0.2 %,
- 3-iodo-2-propynyl butylcarbamate (CAS No.: 55406-53-6; EC No.: 259-627-5), concentration 0.5 %,
- permethrin (CAS No.: 52645-53-1; EC No.: 258-067-9), concentration 0.06 %.

LEGMC assigns the authorisation number LV/2024/SB/001 for the biocidal product Pullex Primer.

The authorisation is valid until 10th August 2027.

The authorisation number shall be indicated on the label of the biocidal product.

The authorisation of **Pullex Primer** is granted on the following terms:

- Product type: 8 Wood preservatives;
- Target organism wood destroying fungi (brown and white rot fungi), wood discolouring fungi and wood boring insects (shown by *Hylotrupes bajulus*);
- Users: non-professional (general public), professionals and industrial;
- Product description: Ready-to-use liquid;
- Product stability: shelf life 24 months in coated tin containers and 12 months in HDPE containers.

The authorisation applies only to the same product **Pullex Primer** in the form, composition and packing according to the reference product **Primer TIP A** for which the first authorisation is granted by reference Member State – Germany.

The information on the label (and if applicable an enclosed instruction of use) of the **Pullex Primer** should be as it is indicated in the first authorisation for **Primer TIP A**, taking into account Product Assessment Report, summary of Product Characteristics and proposed differences for same product.

The information on the label shall be in Latvian.

Notwithstanding content of the label specified above, requirements stated in:

- Article 69 of Regulation (EU) No 528/2012 of the European Parliament and of the Council of 22 May 2012 concerning the making available on the market and use of biocidal products,
- Regulation (EC) No. 1272/2008 of the European Parliament and of the Council of 16 December 2008 on classification, labelling and packaging of the substances and mixtures, amending and repealing Directives 67/548/EEC and 1999/45/EC, and amending Regulation (EC) No 1907/2006,
- all other relevant legislation shall be applied.

ADLER-Werk Lackfabrik Johann Berghofer GmbH & Co KG as the authorisation holder shall inform LEGMC about any changes in accordance with *Regulation (EU) No 354/2013*.

Additionally, LEGMC would like to inform that **ADLER-Werk Lackfabrik Johann Berghofer GmbH & Co KG** is fully responsible of the content of the biocidal product **Pullex Primer** as well as its classification, labelling, instruction of use and safety data sheet.

LEGMC would like to ask **ADLER-Werk Lackfabrik Johann Berghofer GmbH & Co KG** to notify the above mentioned information down to supply chain.


